Project Summary:

The proposed project includes a full street reconstruction of Gammon Road with construction of a new segment of the West Towne Path. The proposed street layout will be an urban boulevard section with three through lanes and left

left turn lanes at intersections, similar to the existing layout. Construction of the West Towne Path segment will connect to the existing path at Grand Canyon Drive and extend it to the west side of Gammon Road. Construction of the path includes the construction of a 20-foot wide underpass of Gammon Road just north of the West Beltline Hwy. A multi-use side path is also proposed on the west side of Gammon Rd between Mineral Point Road and the Beltline. Connecting paths will also be constructed to connect the West Towne Path to the side path along Gammon Road.

Storm sewer will also be added with the project. Reinforced concrete pipe will be added as necessary to serve the new street layout and is designed to accomodate a 100 year storm event. The existing water main and sanitary sewer will remain in place with some adjustments to those facilities as necessary.

The existing right of way width varies from 132 to 315 feet wide. The proposed street width for Gammon Road is a boulevard section 37 feet wide face to face in each direction.

The proposed project will be let through the WisDOT and the project is funded with with combination of federal and local funding .

be allowed. Metro transit service and temporary bus stops will be maintained during construction.

Real Estate Requirements: A Transportation Project Plat has been completed for the project. PLE is required for traffic signal maintenance on

one parcel and PLE for bike path is required at one parcel. TLE for grading purposes will be required at 5 parcels.

City Engineering has identified 44 trees to be removed with the project, including: Tree Information:

1. (22) terrace trees on the west side of Gammon Road between the Beltline Hwy and West Towne Mall Entrance.

2. (6) terrace trees on the east side of Gammon Road between the Beltline Hwy and Odana Rd.

3. (11) terrace trees on the west side of Gammon Road between Odana Road and Gammon Pl.

4. (5) terrace trees on the west side of Gammon Road between Gammon Pl and Mineral Point Rd.
