Dear Ms. Stouder and Planning Commission members:

Edgewood High School and its neighbors negotiated in good faith through a long and arduous process to balance the school's needs with the needs of surrounding neighborhoods. The result was a planning process that, since 1992, has served that purpose well. Edgewood's schools have benefited greatly with building additions for all three schools, a new dormitory, a new arts center, and at least 12 other improvement projects. The neighbors have generously supported these improvements in several ways and have benefited from the presence of a fine and steadily improving institution. The planning process has worked.

Now Edgewood High School wants to build a lighted, amplified-sound stadium to host many competitive events per season in a variety of different sports, including events for non-Edgewood teams. All of that is outside of the Master Plan, and there is a reason. The substantially higher level of noise, traffic, street parking and other aspects of athletic events in such a stadium would impact the neighborhood negatively. Neighbors have already accepted the increased noise, traffic, street parking, and other changes resulting from the campus improvements in recent years. The stadium proposal takes such changes to a level that is beyond acceptable for the large majority of Edgewood's neighbors.

Edgewood wants to abandon its Master Plan, which would mean abandoning a long, well-honed relationship with its neighbors along with a carefully developed process through which all parties' needs were balanced. The rancor that we've all experienced over this move by Edgewood to circumvent a plan that we all agreed upon will only grow worse if Edgewood succeeds in abandoning the Master Plan process.

Ms. Stouder, Mr. Parks -

This letter is for the Planning Department and for the Planning Commission. Please pass it on to all members of the Planning Commission. It relates to a topic to be heard at the Planning Commission Hearing on 8/26.

I am writing to express my support for:

"2nd SUBSTITUTE Amending Sections 28.097(2) and (3) of the Madison General Ordinances to require conditional use approval in the Campus-Institutional District for the establishment, improvement, or modification exceeding 4,000 square feet in area on a zoning lot of any primary use and to require conditional use approval for the establishment, improvement, or modification of identified secondary uses." (File #56981)

This change would address a number of issues with the Campus/Institutional Zoning Ordinance.

First, this change makes the operating principles of the CI District Zoning consistent with the rest of the city's zoning. In MGO 28.004 "Interpretation":

This ordinance applies to all land and land development within the jurisdictional limits of the City of Madison, Wisconsin.

(1) This ordinance should be interpreted as a permissive zoning ordinance, which means that the ordinance permits only those principal and accessory uses and structures that are specifically enumerated in the ordinance. In the absence of a variance or special exception, any uses or structures not specifically permitted by the ordinance are prohibited.

Almost every district in the city defines a list of "Permitted Uses", "Accessory Uses" and/or "Conditional Uses". This includes the Special Districts, with the only exception being the Campus/Institutional District, which has a list of "Primary Uses" and "Secondary Uses", but no definition as to how they are allowed. While many have assumed that the Primary Uses were "Permitted" and the Secondary Uses were "Conditional", this is not stated anywhere, and it is essential that this be clarified in the ordinance.

The problem is exacerbated by inadequate language in 28.097(2)(c) that allows such districts without a Master Plan to engage in any sort of development, construction, or changes in use, as long as they did not involve a building with more than 4,000 square feet of floor area.

The proposed amendment fixes this, clarifying that, for districts without a Master Plan, any development related to uses in the "Secondary Uses" list require a Conditional Use approval, consistent with what is required in other districts for uses other than the primary, intended, use of a parcel, as defined by its zoning.

It is also modifies the language for developments that are related to the Primary Use, clarifying that large developments that do not include enclosed buildings still requires the Conditional Use process if a district lacks a Master Plan.

It is clear that these changes are consistent with the original intent of the ordinance, as the city wrote the ordinance with the intent of encouraging Campus/Institutional entities to have a Master Plan and would not have intentionally allowed greater priviliges for intitutions that lack them than institutions that have them. This is clear for a number of reasons:

1. In the "Statement of Purpose Section", the ordinance states that "The CI District is established to recognize the City's major educational and medical institutions as important activity centers and traffic generators, accommodate the growth and development needs of these institutions, and coordinate the master plans of these institutions with the City's plans, policies and zoning standards. The district is also intended to:

...

(c) Encourage the preparation of Campus Master Plans that enable adjacent neighborhoods and the broader community to understand the levels of development being proposed, their likely impacts, and appropriate mitigation measures."

2. All newly-formed CI Districts created after the formation of the ordinance were \*required\* to have a Master Plan, to be "approved as part of the map amendment."

While I strongly support this ordinance, I also would like to state that I oppose allowing Edgewood to be released from the agreements in its Master Plan.

The Master Plan encompasses much more than these questions of use and this ordinance is nowhere near adequate to eliminate the harm associated with allowing an institution to abrogate its Master Plan. I have written at length on this topic in a separate letter.

Finally, as long as I am writing, I would like to suggest an additional technical correction in an ordinance that relates to this:

28.091 SPECIAL DISTRICT USES.

(1)

"Table 28G-1 lists all permitted and conditional uses in the Special Districts, except that uses allowed within the Campus Institutional District are listed separately in Sec. 28.096."

This should read "listed separately in Sec. \*\*\*28.097.\*\*\*"

I'd be grateful if you could forward the following letter to the members of the Plan Commission for consideration before Monday's hearing.

Dear Plan Commission members,

I was deeply concerned to hear that the City is proposing to allow Edgewood to unilaterally exit its Master Plan, five years before it expires. Edgewood entered the Master Plan voluntarily, and made a contractual arrangement with the City to abide by it for ten years. While the Dudgeon-Monroe and Vilas neighborhood associations were not signatories to the agreement, they were equal partners in the lengthy and arduous negotiations for the Master Plan, and remain major stakeholders. The Master Plan represents a significant investment of neighborhood representatives' time. The negotiations took four years, and resulted in an agreement that all parties were happy with. It provided security for neighbors in guaranteeing the types of mutually-agreed development that would take place over a ten-year period. Edgewood has reaped considerable benefit, and constructed several major projects as a result. At the same time, the interests of the adjacent residential neighborhoods and the precious environmental resource of Lake Wingra were protected.

Now that Edgewood is proposing a major expansion to competitive use of its athletic field – which is not included in the Master Plan – the appropriate course of action would be for them to request an amendment from the Plan Commission. To allow Edgewood to exit its agreement after having reaped the benefits is a subversion of the public process. It sets a precedent that undermines the public planning concept of the Master Plan and the City's long-standing commitment to community engagement.

West High School, which is similarly located in a dense residential neighborhood very close to its athletic field, does not have its own stadium, and its students are bussed to Mansfield Stadium at Memorial High School and other locations for competitive events. The exact same arrangements that Edgewood High School claims as intolerable hardships on its students are the norm for the local public high school, which is four times as large.

I fear that if Edgewood is allowed to exit its Master Plan, the adjacent neighborhoods and Lake Wingra will have no defense from future disruptive and harmful development on the Edgewood campus.

I urge you to oppose this resolution at the Plan Commission hearing on August 26.

My name is Shawn Doherty and I have lived at 2121 Adams Street for 17 years. I am writing to urge you and the VNA to join your colleagues on the DMNA and Greenbush neighborhood associations in taking a stand and opposing Edgewood's latest move to wiggle out of its Master Plan.

I covered city hall for the Capital Times for four years and before then reported on politics for Newsweek and the LA Times, so I can imagine how difficult it must be to navigate all of the competing interests, pressures, and emotions that play a role in a zoning battle like this one. But irregardless of where you and other VNA officers personally stand on the stadium issue, I hope that the VNA makes it clear in a public statement that the integrity and independence of the city's zoning and planning processes must be paramount. I believe such a statement is especially necessary because of the misleading information that has been put out there.

Edgewood claims that the city "invited" it to exit the plan. That is misleading. Invitations are extended to tea parties, not lawsuits. As you must know, the city suggested this option only after Edgewood lawyers threatened to sue it. <a href="https://isthmus.com/news/news/edgewood-takes-another-route-to-host-stadium-games/">https://isthmus.com/news/news/edgewood-takes-another-route-to-host-stadium-games/</a> RLUIPA is a federal law passed in 2000 that was intended to be used as a shield to protect churches and other religious institutions against discrimination. Instead it is being increasingly used as a hammer by organizations like Edgewood High School with a religious affiliation to shatter and circumvent local zoning regulations. Madison's city planners have a well-deserved national reputation for using the planning process to achieve that delicate balance between private interests and the public good. The result might frustrate developers at times but it is also one of the reasons our city is often chosen as one of the most livable in the nation. No matter how you and other officers at the VNA may feel about the stadium, not sticking up for the independence and value of this planning process and not denouncing this kind of bullying would set an alarming precedent.

It would also create an unbelievable headache. Many of us in the Vilas neighborhood worked for years on the current Master Plan, which builds on previous plans and addresses numerous concerns and issues from both the campus and nearby residents. These issues include stormwater protections, setbacks, parking, lights, and the construction of new buildings. My 98-year-old neighbor Betty McDonald tells me she's been dealing with Edgewood and some of this stuff for over 50 years! I can't imagine having to start over from scratch, especially after so many of us for so long negotiated in good faith and have had to tolerate the compromises reached, for better and for worse. After the dormitory went up across the street I've had to call Edgewood security and the police about property damage, theft, and noise. I deal. Even the young athletes Edgewood talks so much about know you win some and you lose some but you always play by the rules. You don't just quit. Such a move would poison relations and trust between the neighborhoods and campus and city for years to come. The VNA needs to point out that a far better path would be for Edgewood to resume its discussions with the collaborative working group and to continue to seek a compromise.

It is unfortunate that the August VNA meeting was canceled, because that would have been a great time to get feedback from the folks you represent. Perhaps it would be helpful if I shared with you what I learned last weekend, when I went around our side of the neighborhood to collect signatures for a Protest Petition against the zoning change that would allow Edgewood to exit its Master Plan. I contacted 12 households whose proximity to the Edgewood property makes them eligible to sign. Ten of the 12 households did so, which means they cared enough to go the trouble of attending a signing event with a notary public the next day. (Actually, make that 10 1/2. There was a split household.) Some of these people had ties to Edgewood. They were open to the idea of a stadium but "embarrassed" by how the campus has been treating neighbors. Every single person I spoke to except for a couple that had just moved into the neighborhood and didn't know

what was going on was upset, outraged even, that the high school is using the threat of a religious discrimination lawsuit to try to get its way. So, contrary to what Edgewood claims, opposition is not contained to a "small, vocal group" on just one one side of the campus. It runs deep in our neighborhood too. Tag Ever's impressive majority last fall in Ward 66 is another indication of how our Vilas neighborhood feels, and so are the VNA's own Minutes from last fall, which show that most people who turned up for a discussion about the stadium were opposed to it.

A few days ago I looked up the VNA's Charter, which states that the Association's purpose is "the enhancement of the neighborhood's residential character and attributes and the promotion of camaraderie among the Neighborhood's residents." Both goals are in peril and both are worth fighting for. Thank you for having the courage, the patience, and the empathy to listen to and represent the views of residents like myself, even if they differ from your own or upset powerful stakeholders. Thank you for keeping your decision-making process open and transparent. And thank you for the hours I know you put into our neighborhood.

A neighborhood dispute like this can bring out the best or the worst in all of us. May it bring out the best!

Edgewood is a private non-profit tuition-based school campus that resides in the Dungeon Monroe neighborhood (<u>www.dmna.org</u>). I attended multiple meetings for the proposed Edgewood Stadium with my neighbors and Edgewood. Edgewood wants to have a permanent stadium playing field immediately adjacent to its neighbors on Woodrow and Monroe Streets in Madison. You must see the "practice field" location to truly appreciate what they are proposing to visualize the effect a permanent stadium will have on the Dudgeon Monroe neighborhood.

Personally, I believe you should be able to do whatever you want to do on your own property as long as it is not to the detriment of your neighbors. For example, I may want to divert rain water away from my house to prevent flooding in my basement, but I should not be able to divert my rainwater downspouts to my neighbor's house and routinely flood their basement. Edgewood is proposing to do something very similar to the analogy above. My concerns about crowd noise, lighting and parking are below.

I have heard everything from the stadium will only be used for the High School Football team for a few games at night; to it will be used for 40 night games for various events; to it would be a great asset for the neighborhood and benefits many other organizations in Madison. I have a hard time believing that this stadium is only going to be used by the Edgewood High School which is why in the past I have asked the question concerning the number of events projected. Edgewood is going to want to maximize the return on the investment of this privately held asset.

I am very concerned about crowd noise. If we get lost in the technical solution provided in the presentation, it is easy to lose sight of the human impact (e.g. a crowd cheering for their team). It can be a vicious cycle of cheers of joy supporting your team when you are winning or being the "twelfth man" trying to prevent from your opponent's team from being able to communicate. The average volume provided in the presentation (average over duration) is not a good representation of what my neighbors are going to experience from peak noise levels. If this is allowed to move forward, crowd noise is not enforceable, and the community residents will have to live with noise. This will have serious effects on my neighbors to the point I fear we will not be able to enjoy our residential properties, so this private, tuition-based institution can have a stadium in our neighborhood. We should be allowed to make enhancements to our properties, but not when they are to the detriment of our neighbors.

Personally, I do not want to see this neighborhood change. We chose this neighborhood because we recognized it was special. We do not want the noise and light pollution and other challenges the stadium is going to bring. Edgewood's presentation was for 30 fc based on what they received from the group trying to sell them the solution. We saw members of the sales team once, and they were more Account Executives than engineers who would or could honestly answer questions when challenged on what was presented. Edgewood's presentation was modeled for 30 fc of lighting.

I am disappointed there was not verification of the study provided to Edgewood to certify the results and assumptions made by the sales team trying to make the sale. The sales team is selling a solution and will assure Edgewood it will work for their application. Edgewood will implement the solution, and when it does not work as projected. Edgewood will request

additional changes that will invalidate what Edgewood presents to you and will continue to negatively impact its neighbors. For example, Edgewood will cite something like student athlete safety requiring the light illumination level to be raised to a higher value (50 fc is the NCAA recommendation). I do not want to see anyone get hurt due to poor lighting on the field because Edgewood decided to believe what is was presented.

I am also concerned about parking based what is proposed. Edgewood would like us to believe parking will not be a problem because they have sufficient parking stalls based on their estimates, but once people who are not local to the Dudgeon Monroe community figure out that it is faster for them to park in our neighborhood and walk to the stadium, they will park in our neighborhood, and they will walk to avoid parking on Edgewood campus and the associated traffic issues to them when they try to either get to a game or leave from a game. There is a reason we have 2-hour enforceable parking limits without a residential permit during the day on our streets near Edgewood's campus.

Finally, a point was made concerning what happens to property values if this moves forward. We have something special here today. Once it is gone, it is gone forever and there is no turning back. I firmly believe if this change is allowed to move forward what makes our neighborhood special will be gone. As a result, I believe property values will decline because of the negative effects presented, noise, parking, lighting, etc. The neighborhood will become a less sought location for families and the result is property values will decline. Who is left to absorb the financial impact when the revenue generating property taxes for the Dungeon Monroe neighborhood public school drop?

It would be financially irresponsible for Edgewood to invest additional funds to the existing "practice field" to see what the impact would be to neighborhood. Based on what the existing practice field looks like today they may have already been financially irresponsible, or maybe they always had the intention to have a permanent stadium in Dungeon Monroe even though this was not what was presented in its 10-year plan. Perhaps this was always the plan despite the damage Edgewood would cause to their neighbors. It is impossible for me to know what is in the hearts and minds of the people behind Edgewood, but it does not feel like they are living to up to their values.

Based on past their past performance with promises made (e.g. practice field used for games), Edgewood cannot be trusted to implement a solution that will not create problems for its neighbors. There are other places not in this peaceful, treasured, densely populated residential community where this private tuition-based institution can have a sports facility that would not be immediately adjacent to a dense residential community. We have something special here. Once it is gone, it is gone forever. Please vote no on the Edgewood stadium proposal.

I am disappointed I will not be able to attend the planning commission meeting personally. I will be out of state due to military commitments.

We definitely oppose this new attempt by Edgewood to bypass agreements and city regulations in one more try to get to build their stadium and host athletic competitions on their field in spite of the limitations in their Master Plan.

We live at 2254 Monroe Street, directly across from Edgewood High School. Over the years we have been supportive of Edgewood's expansion plans, even though it has negatively impacted us (for example, closing off Leonard Street, heightened Monroe Street traffic from the expanded parking lots (which also lost an expanse of green space on Monroe Street) and changing the entrances to the Edgewood Campuses all to enter off of Monroe Street).

We have participated in the many public hearings and discussions with the neighborhood and Edgewood since 2017 when they proposed this expanded use of the athletic field and construction of a stadium with lights, sound system, concession stands, dressing rooms, and increased bleacher size for increased attendance at those games. We do not think that Edgewood has conducted those talks in good faith, and when their attempts have been blocked, by the city and the Zoning Board of Appeals, they are now trying to escape from their agreement with the city and the neighborhood (the Master Plan) after many of their expansionary projects have already been completed. Furthermore, the notion that Edgewood is entitled to have an on-campus stadium to help build school spirit is absurd. I graduated from West High School in 1963. None of the Madison high schools that existed then had an on-campus stadium, and the two that remain, West and East, still don't.

The assertion that this won't disrupt the neighborhood, including the tranquility of the Lake Wingra/UW Arboretum area is, I think, simply not accurate. Even back in the Edgefest days, noise from that event was noticeable and unwelcome.

Now, having been cited for violations their master plan, they want to withdraw it. Why, so they can host events that will not violate a master plan which has been nullified, but which events go to the very core of the objections to the proposed new stadium? Talk about a neighbor whose word is not worth the paper it is written on.

Keeping in mind the goals of maintaining the character of the neighborhood and holding institutions to their word, word which others have relied on, we hope that Edgewood will continue to be bound by its master plan, and that their proposed stadium does not become a reality.

Dear Alders and Members of the Plan Commission,

#### I urge you to oppose the resolution to allow Edgewood to repeal its Master Plan.

When the City of Madison developed its new zoning ordinances, there was never any intention of allowing an entity to abandon its Master Plan agreement. Edgewood has benefited from its Master Plan by completing building projects approved therein; they should not be allowed to take those benefits without accepting the limitations they wrote into the Master Plan to gain approval. If they would like to change something now, the City has provided a mechanism – the Master Plan amendment process.

Edgewood's Master Plan was negotiated over four years with the surrounding neighborhood associations and the City with the background of decades of discussions. Neighborhoods are the building blocks of Madison, and our zoning laws have been carefully designed to weigh the benefits of a potential development against the harm it could cause surrounding neighbors. Further, there is a space in the process for neighborhood input. Edgewood is trying to make an end run around their neighbors.

In a broader perspective, if the City allows Edgewood to repeal its Master Plan, any agreement made with other entities will be undermined. Public faith in zoning agreements will be lost. What would it mean if an institution could create a 10-year plan, develop buildings carefully negotiated against other policy and use, and then walk away? This is what Edgewood is demanding. The City should uphold the law, even facing the threat of a lawsuit, as essential to our democratic processes.

I would also like to share my perspective a Monroe St homeowner with property overlooking and within 100 ft of the Edgewood High School practice track and field. Neighbors are experiencing harm from the illegal uses of practice field. I ask that you **oppose any expansion of the facility due to the harm it causes to the livability of neighboring properties.** 

Homeowners surrounding the proposed stadium do not oppose it because we fear what conditions might be like; we object to the stadium because we know what a stadium would mean, having already experienced disruption in our homes and properties during games and practices held on the field since the 2015 changes to the field.

These are views from our home. Note that there is no buffer whatsoever between many homes and the field - contrary to Edgewood's claims of trees blocking light and sound.

Before 2015, there were about 4-6 lower level games in the fall (JV/freshman football) and 4-6 JV girls soccer games in the spring, and sometimes even less than that. These games were more of the nature of a practice with low attendance.

In the spring 2019 season alone, I documented over 40 games. All of these games occurred with Edgewood having been given notice that no competitions were allowed under their Master Plan agreement. Edgewood has shown they will not follow the rules.

Some of the games had nothing to do with Edgewood at all including the regional college lacrosse tournament that lasted 7 hours. This is not just about a few football games but about monetizing the field at the expense of surrounding residential neighbors.

As one example, this video of boys soccer, linked below, was filmed Oct. 25, 2018 at 5:23pm, with no zoom, from an open bedroom window as would typically be the case in spring, summer, and fall. Before filming, I took sound measurements using the National Institute of Occupational Safety and Health (NIOSH) Sound Level Meter app on my iPhone. This app has operated within +/- 2 dB of a calibrated sound meter, so readings provide a reasonable estimate of noise, and these levels are consistent with the professional sound studies performed by experts for neighbors and Edgewood itself.

Crowd noise was above 70 dB throughout the cheering with peaks above 80 dB *in our home* with the existing conditions. I have measured 84dB level noise during other games inside our home with crowd sizes of less than 200. The Madison Noise Ordinance limit is 65dB. They were using a portable amplified sound system to announce players; however, the amplified sound is almost completely eclipsed by the crowd noise. I did not take sound measurements at the loudest parts, since I was filming. Please note the increase in sound at 0:31 when the goal is scored; this is what has been so disruptive about the games played on the field.

This event disrupted our family's evening. My husband was up at 3:30am in Afghanistan, where he was deployed, to 'join' us via video chat for a rare family dinner. By 5:15pm Madison-time, *the noise in our home with the windows closed was so distracting that we gave up on having a family conversation.* The increased frequency of game events on the Edgewood High School practice field have so negatively impacted the livability of our property, whether gardening, relaxing on our back porch, watching a movie, or sharing a meal, that we had considered moving and converting our much-loved home into a rental property even before the stadium proposal was formally submitted.

Technological fixes cannot mitigate crowd noise; allowing Edgewood High School to increase the capacity of the stands to 1200, with no daytime limits of use, and to expand their hours of field use by installing 80 ft high mount lighting would create a burden on the surrounding neighborhood and further harm our ability to enjoy our properties. Even practices, which could utilize lights every day, are audible in surrounding homes with repeated whistles (above 70dB) and group chanting.

I appreciate your time reading my concerns as a neighbor. Edgewood's desire to develop a stadium is simply incompatible with the proximity of residential property and would create an unreasonable burden and harm to neighbors. A stadium is not a necessity at this location, Edgewood has other options. I hope the city will reject the resolution to repeal to Edgewood's campus master plan and enforce current zoning agreements.

#### I am writing to ask you to:

- 1. Oppose the resolution which would allow the Edgewood Campus to voluntarily withdraw from its Master Plan.
- Re-write/amend the Campus Institutional Zoning Code to clarify its intended purpose and close the unintended loopholes (ie. amending sections 28.097(2) and (3) to require conditional use approval)

Allowing Edgewood to abandon the Master Plan would go against the legislative intent of the Campus Institutional District Ordinance, which was designed to protect the City's interests, as well as the City's ability to balance the competing needs of the campus institution and the neighborhoods in which they are located.

**Edgewood High School's Objective** is to create an Athletic Complex that is WIAA compatible and to play all of their home games (day and night) on this field. To do this they need **80 foot lights** and an **amplified sound system**. They want to expand the current bleachers to the scale of a **grand stand for 1300 people**, with a press box, concessions and storage.

As a person who has lived on Woodrow Street for 25 years, adjacent to the Edgewood Campus, the use, value and enjoyment of my home is directly affected by what happens on the Edgewood Campus and will be directly affected by this decision. Homes lie within 100' of the field and campus and have an involuntary front row seat to every game and practice. The large increase of games to 40, hosted by Edgewood this year were disruptive to myself and my neighbors in terms of traffic, parking, noise, the use of portable sound systems and crowd behavior. Over the years, we neighbors have said "yes" to a lot of development on the campus. Development of the field into a stadium is a major issue that I have always vehemently opposed as completely incompatible with this historic neighborhood.

**Edgewood's desire for a Stadium is nothing new.** During the development of Edgewood's first Master Plan of 1997, Edgewood High School proposed the same plans for the field. This idea was rejected and dropped during Edgewood's discussions with the neighborhood as incompatible with the neighborhood.

The Current Master Plan (dated 2014, approved in 2015), which was negotiated in good faith by all involved parties, does not include light, sound or the grand stand. The Master Plan defines the use of the field to be for practice and physical education classes. Edgewood knew that expanding the use of the field for games, as well as the addition of stadium lights, amplified sound and a grandstand were opposed by the neighborhood. Edgewood High School President, Mike Elliot, in *The Wisconsin State Journal*, in a June 15, 2015 article about the field rebuild, stated that understanding. "We're between two neighborhood associations.

They have been vehemently opposed to us having lights or playing games here.' he said. 'We're really building this to be able to give our athletes the practice facilities that provide the best surfaces possible to expand the amount of outdoor practices we can hold especially in the spring. That is our focal point.'" Thus, Edgewood specifically chose the words "team practices" and "physical education classes" as the only two approvable uses of the field in the Master Plan. They are now trying to claim that those two uses "imply" or "obviously include" playing games. They do not.

In 2016 Edgewood came back with the proposal to turn the field into an "Athletic Complex" that is WIAA compatible, complete with 80 foot lights an amplified sound system and a grand stand for 1300 people, with a press box, concessions and storage building. In anticipation of this plan happening, Edgewood shifted playing the bulk of its home games to the Edgewood Campus (in violation of its Master Plan).

After the neighborhood once again opposed this proposed expansion as incompatible, Edgewood started its quest to get around the Master Plan and the Zoning Code. Edgewood proposed and then withdrew from amending its Master Plan. Next Edgewood tried to get a building permit for the 80' pole lights and amplified sound system to end run the Zoning Code and process. Next, Edgewood appealed to the Zoning Board.

**During the Zoning Board of Appeals meeting on July 11, 2019**, Edgewood sought to appeal a City Zoning Department determination of non-compliance with Edgewood's Master Plan. The non-compliance was due to Edgewood's playing games on the field that had been defined in the Master Plan as a field for "practice and physical education." During the meeting, the Zoning Department clearly stated that **the purpose of the Master Plan is to protect the City of Madison's interests and to enable the City of Madison to balance the interests of the Campus Institutional entity and the neighborhoods.** 

At that meeting a major flaw and loophole in the City of Madison's Zoning Campus Institutional district was exposed. That loophole, according to the Zoning Department, is that if a Campus Institution entity were to withdraw its Master Plan, then it can freely build anything that is less than 4000 sq ft of interior space without the need for a Conditional Use Permit process. For Edgewood, this would give them the ability to erect the 80' pole lights, amplified sound and grandstand seating for any number they choose without having to go through a conditional use process. There are a whole lot of things that Edgewood, or any Campus Institutional entity could do that would be below this trigger of a Conditional Use Process. At the same time, free from a Master Plan, Edgewood High School (or any Campus Institutional entity) would be free from the requirements and provisions defined by the Master Plan.

This loophole goes against the whole purpose of the Zoning Regulations, to protect the City's interests and to enable it to balance the interests of the Campus Institutional entities and the neighborhoods.

As a resident and neighbor of Edgewood, I count on you to protect my interests and to protect the trust I have placed in the city regulatory and input process. It is for these reasons that I ask you to oppose the resolution which would allow the Edgewood Campus to voluntarily withdraw from its Master Plan and to re-write/amend the Campus Institutional Zoning Code to clarify its intended purpose and close the unintended loopholes.

Please vote YES on Alder Tag Ever's proposal to amend city ordinance governing institutions without a Master Plan. I believe this is item 10.

Please vote NO on repealing Edgewood's Master Plan. I believe this is item 14.

If the Master Plan is repealed, you will then repeal all the neighborhood contributions it has made since Edgewood's Master Plan first developed in 1997. Edgewood and a neighborhood committee have been meeting monthly since 1997.

Edgewood High School in June walked away from discussions with the neighborhood despite hiring a facilitator to help resolve issues. I've included a link below with the minutes of the meetings.

In addition, I've included a link to the 2014 Master Plan and selected neighborhood involvement. As you can see, repealing the Master Plan also repeals the vehicle for neighborhood discussions and involvement. What is a city but a collection of neighborhoods that have a voice in what happens on their neighborhood?

2019 Collaborative Working Group:

Edgewood hired Russell Consulting for a facilitation. Edgewood did not want to use the Edgewood/Neighborhood Liaison Committee which has been in existence since 1997 and is also described in the 2014 Master Plan. Edgewood and the Liaison Committee had been meeting at least monthly since 1997. Instead Edgewood High School decided they wanted a new group, called the Collaborative Working Group. It was formed and started meeting in April, 2019 until Edgewood walked away from discussions to resolve neighborhood issues in June, 2019.

The 2014 Master Plan describes this as well as working with the Edgewood/Neighborhood Liaison Committee since 1997 and its Plan to be "sensitive to the impact that growth can have on surrounding neighborhoods" (page 6, 1.1, Master Plan Purpose)

I have taken the liberty to list some relevant sections of the Master Plan are relevant.

- Page 6, 1.1, Master Plan Purpose, "The Campus Master Plan will provide a basis for implementing development decisions so as to benefit all three institutions and the neighborhood by: ... Providing solutions for mitigating neighborhood impacts of future development and growth"

- Page 9, 1.3, Agreement on Master Plan Process Describes 2-3 year process of working with Edgewood/Neighborhood Liaison Committee from 2011 through 2014. page10 lists MasterPlan meetings.

Page 52 through 61, One of four sections of the 2014 Master Plan called titled "Neighborhood and City Processes". Describes the Edgewood/Neighborhood Committee as serving" as a coordination and communication vehicle" for Edgewood and surrounding neighborhoods for the last 15 years.

Page 54, 4.1, refers to documents in this section of the 2014 Master Plan contains documents that "are the product of our work as the Edgewood Neighborhood Liaison Committee."

Page 59, 4.3, refers to "Affirming Past Agreements" and states that "The three Edgewood Schools reaffirm their commitment to the Edgewood Neighborhood Liaison Committee as a primary vehicle for ensuring strong partnership and communication."

Item: Edgewood High School's motion to exit their Master Plan

Dear Ms. Stouder and members of the Plan Commission,

My wife Angela and myself implore you to oppose Edgewood High School's motion to exit their Master Plan. We have lived on West Lawn for 28 years and raised our family there. Like our neighbors, we love Dudgeon-Monroe. With sidewalks everywhere, we can walk to local parks, lake, stores and eating places, including Michael's. It is a quiet, calm, but energetic and family-friendly neighborhood. Living one block over from Edgewood High School's playing field, we have long learned to tolerate the intermittent intrusion of noisy games on weekday evenings and on Saturdays. These have become noticeably more frequent.

So we were appalled to learn earlier this year that Edgewood was circumventing its Master Plan and planning to erect a new stadium with sound and light systems to enable more games, including at nighttime. Unable to do this without due public process, Edgewood is now requesting you to exit its Master Plan so that it can impose crowds and noise pollution on us that recent studies show will damage our mental wellbeing. We have such respect for the public process that led to the approval of Edgewood's current Master Plan, and the balanced coexistence and wellbeing that it achieved in our surrounding neighborhoods, that we cannot believe that Edgewood would ask you to trash this process, and our public trust in it, for their own selfish ends. At issue is not the occasional high school football or soccer games, but the future scheduling of many more games and events with piercing sound system and searing stadium night lighting designed to hype up much larger crowds than currently turn up. Edgewood is fully aware of the suffering this will inflict on us, its long co-existing neighbors. Still, Edgewood ask you to circumvent a trusted public process to impose this blight on us. We implore you not to grant this request. Instead, guide Edgewood High School to engage in the trusted and open public process so that it is transparent as to what they are proposing and what alternatives can be proposed. You will then enable a better environmental outcome for all and provide a clear indication that due public process is real.

Here's a message I received from Edgewood College about them filing a discrimination lawsuit against the City because of unequal treatment in denying them use of their athletic field (see below). I don't think City resources should be spent in fighting this, let's use the money instead for something beneficial like Parks or services.

I haven't understood this controversy from the get-go, why all the yard signs in opposition? Madison Memorial High School plays games on their fields, including night games sometimes, UW Madison plays games that completely overwhelm this neighborhood... pretty much every school in the state plays games at their facilities, why can't Edgewood? Edgewood has been a good neighbor for many years and generously lets neighbors use their track. I feel somewhat shabby at how this neighborhood has treated them. Please do not use any City resources to continue this misguided fight. Erich

Edgewood High School (EHS) has twice promised not to build a stadium.

It is well documented that Edgewood agreed not to build a stadium in 1992 in talks that resulted in the Master Plan program that is still in force after 22 years. That was what the neighborhoods around Edgewood got from the agreement along with the less important predictability in campus changes. Edgewood got a much-streamlined process for city approval of new buildings. DMNA has supported all 15 major building projects completed over the years. If all Edgewood's new buildings are to remain, in fairness the stadium should not be allowed.

More recently, it is also well documented that Edgewood High School renewed its agreement to use its athletic field only for gym classes and as a practice field in the current Master Plan. Neighbors have summised it was because they knew the neighborhoods would not have signed off on it. Now that they have gotten their Plan-approved building project, they want to abrogate the agreement in order to build the foresworn stadium. Shameful! Even more problematic in the long term is the precedent set if they are allowed to terminate the agreement before its end date. It calls into question the reliability of these agreements and trust in city officials. It would be a shame as this process has worked well for all for many years and replaced an acrimonious one we are very reluctant to go back to.

It is laughable that Edgewood's sports program is religious in nature. Looking at West High, within a mile of Edgewood and with a similar campus (as does East High) in a similar residential location—and also without a stadium—points to the practical reason why EHS shouldn't have a stadium, and especially in the stadium's worst possible location (see below).

The behavior of EHS without a Master Plan is easy to imagine. There appear to be few brakes on the stadium—and potentially other aspects of the location in the middle of a residential neighborhood. I strongly urge you to oppose their early withdrawal from the Master Plan and to work to make sure that an unbending entity with no concern about its neighbors—or even to engage in discussions--isn't allowed to ride roughshod over the interests of its neighbors.

Neighborhood impact: a nightmare location for a new stadium It is the worst possible location on their too small campus, right at the edge of their property along 2 streets lined with small-lot houses. More than 80 households within 30 to 250 yards would be seriously affected by a heavily used playing field literally on their doorstep. This spring EHS held nearly 60 competitive events in 2 months (not counting those held outdoors the rest of the year, notably football). If they begin using their portable sound system for practices or rent out the stadium, the impact will be amplified. With a stadium neighbors would experience extreme degradation of quality of life. They wouldn't be able to use their yards or open their windows without the equivalent of being in the bleachers for a game in which most have no interest. Technical data on a professional sound study commissioned by No New Stadium showed that any event drawing a crowd and with a sound system would greatly exceed the current noise ordinance and on an extremely frequent schedule. For instance, it predicts 150 people alone will exceed the noise ordinance @ 65 decibels. Soccer with only 100 people at the field would be 80 decibels, again with no sound system or the music commonly broadcast over stadium sound systems. Most events would far exceed these examples of course.

The irregular roars of the sound system and crowd would extend to a much larger portion of the neighborhood. Last spring I was painting a fence on a windless sunny day when a track meet started. I know because, at 4 blocks away, I could make out the referee's almost continuous announcements. That is at an annoying level if it is as frequent as it would likely be, and competes even with conversation outdoors.

In addition, the tall lighting would disturb sleep of nearby residents—and wildlife--according to a study by No New Stadium. The crowds for a big game will likely clog surrounding streets for parking and traffic and provide late night entertainment for those same residents as they leave. We can't assume that all Edgewood parking would be available for every competition.

The home stadium would have no significant positive impact on the EHS Community Less than 25% of their students come from neighborhoods around EHS (I understand that the 25% includes all of the 53711 zip including Fitchburg) so nearly all would be getting into a car to attend any large competition whether it's at Edgewood or elsewhere! The field could be successfully located anywhere within a few miles as it has been at Middleton without inconveniencing anyone more than a few minutes.

It seems likely that a stadium sales pitch would only net them a few students who can't make the team at larger high schools. School spirit is nebulous and not really location based as public school staff will tell you. Further, it is unlikely a small school of 500 or so will be a football powerhouse, the probable goal. Lastly, high school football is widely observed to be on a downward path since the revelation of physical damage to players more than a decade ago.

#### A Stadium just a distraction from EHS core tasks

This project is an obvious distraction from the school's core mission: providing a quality small college prep school with excellent teachers and attention to each student. That is what will get their students into good colleges and attract more students. Fights & lawsuits with neighbors over the stadium's impacts will take a lot of time and money from other tasks like marketing the superior college prep experience needed to increase the small enrollment. The poisonous atmosphere will take a terrible toll on needed future cooperation with the neighborhoods.

#### A Chronology of recent EHS behavior

EHS began to talk at the periodic liaison (with neighborhood reps) committee meetings about a stadium approximately 6 months after the current Master Plan was signed, fueling suspicions that this EHS strategy was used as they knew the neighborhoods wouldn't allow a stadium in the Master Plan. They refused to engage in a discussion of compromise, or even neighborhood concerns voiced at the public hearing, at Edgewood-Neighborhoods liaison meetings and refused repeated attempts by the Dudgeon-Monroe Neighborhood Assn. (DMNA) president last fall to begin a more formal discussion—or any discussion at all--to find a compromise.

EHS told us at the fall 2018 public hearing for a Plan Commission presentation that they could no longer play at Middleton and they had been unable to find another venue. Edgewood created the crisis: Per Middleton High officials EHS stated they wanted their own stadium and refused to begin negotiations for another contract. Middleton told us they would be happy to take EHS back. If that falls through, 5 or 6 suburban highs are within driving distance with stadiums bordered by cornfields. An urban industrial area could also be considered.

EHS orchestrated a November and December daily letter to the WSJ editor campaign by parents that routinely disparaged the neighbors and never mentioned any neighborhood impacts. Only in February did EHS agree to talks with the neighborhoods, then shot down all ideas presented for compromise, and ended the talks midstream. They also attempted to evade the Master Plan prohibition by dropping the buildings, and unsuccessfully requesting a permit for the lighting. A sound system and bleachers apparently are beyond city control. The 3 features would have given them a functional stadium and even the two would have allowed stadium size events. Shockingly easy!

Then they began to play competitive events at the athletic field all spring in clear violation of the Master Plan. This summer they tried in vain to convince the city Zoning Commission that the stadium was never really denied in the Master Plan. And now a lawsuit contending religious persecution! Edgewood High School is behaving as though the world owes them exactly what they want regardless of how it affects others.

#### Worries for the future

I—and many of my neighbors—are very upset about the gap in city ordinances. That Edgewood could have a functional and fully impactful stadium with only a lighting permit is horrifying. We apparently need a definition of a stadium that lists those elements (a sound system, special lighting, and/or a large quantity of seating) alone as constituting a stadium, as those are the elements that drastically impact neighboring homes. Obviously such stadiums must have close regulation in operation as well.

We are also very concerned about the enforcement of the noise ordinances. According to the Zoning staff, the police enforce the ordinance if and when they have time as a low priority. Since virtually all competitions will exceed the city sound ordinance of 60 decibels in a residential setting, this sets neighbors up for endless monitoring, fruitless complaints and frustration. Efforts this spring to report game violations didn't go well. Clearly the ordinance does not deal with an extreme and regular violator and the Police Department hasn't the time or tools to enforce it effectively.

And dealing with EHS without an enforceable Master Plan, whether it is now or at the end of the current Master Plan period, is an alarming proposition as we would have little leverage. A number of operational concessions Edgewood has made over the years would be unenforceable and it is clear that they have no interest or concern for their neighbors or regard for municipal rules. With apparently failing schools, who knows what they will do? For instance, Edgewood initially outlined a larger stadium with 1200 seats and expressed interest in renting out the stadium to other schools and non-sport events. Edgewood College has just moved its weekend continuing education program from a remote location. Other changes may be in the offing.

Dear Plan Commission,

# I am writing to ask you to amend sections 28.097(2) and (3) of the Campus Institutional Zoning Code to require conditional use approval, as suggested by Legistar file #56981.

The Campus Institutional District without a campus master plan should not allow for significant land use changes without conditional use review. Because there are many land use cases that can significantly affect neighboring properties without the construction of a 4,000 square foot building, it would be poor policy to allow changes to occur simply because a property owner is in a CI district.

I live immediately adjacent to the Edgewood campus CI District, and—should Edgewood ever be without a Master Plan—do not believe they should be able to change their usage of their property to include a parking structure, transportation center, stadium, or any other secondary use without conditional use review. Nor do I think residents living next to other CI districts should be at risk of a development that could have significant impact on their property, without a public process that allows them the opportunity to address the development.
