In doing a fast review of your submittal, my comments remain the same as our previous discussion: while your narrative says that all of the dimensions of the windows/window components are the same, I think that the Landmarks Commission will want to know exactly what those dimensions are for the existing vs. the current and how they compare (the muntins are x" wide on the original and x" wide on the replacement, the top rail is x" wide on the original and x" wide on the replacement, etc.; and if you can show those things in a visual, that's even better). But the submittal is complete enough to go on the agenda.

Kayla,

I'm going to recommend a few changes. First, I recommend making a page for each window with a description of that window (materials, type/operation, location) and why it needs to be replaced, and a picture of the current conditions paired with a picture of the proposed replacement. For the comparisons, please include information about how the dimensions are similar (size of the sash, size of the muntins, are the muntins simulated or full divided light? If the sashes or muntins are of substantially different dimensions, then the look the window will be very different). Of the current

condition photos you included, the interior pictures are too dark for the commission to be able to make out details of the window condition. Your proposed replacements are of a different design than what is historic to the building and that is unlikely to be a successful request.

While you've made it clear you're opposed to exploring repair of the windows and mitigation of any possible lead paint, because you are also located within a National Register historic district, this work would be eligible for preservation tax credits, which would help offset those costs (whereas replacement would not be eligible). Thanks for your input! Regarding energy efficiency I do agree with some of your statement but the percentage is much greater going from old single pane glass to a double pane, insulated unit. In my opinion the largest loss comes from around the perimeter of the unit especially the large uninsulated void where the old weights lockets are located which we would fill with low expanding foam insulation. Any ways, thanks so much again and please let me know if there is anything else we should submit to increase approval chances.

The Commission evaluates these projects based upon the guidance we received from the City Attorney's Office (which I'm attaching). Replacement of all original windows is a challenge. The priority for properties in historic districts is to retain original materials whenever possible. This is why we request applicants submit information on each window, in order to determine if each window is deteriorated beyond repair. If that is the case, then they evaluate if the replacement window adequately replicates the original. It seems that these likely do replicate the originals (although I'm still uncomfortable saying that they match without comparable dimensions for the width of the stiles/rails or muntins for the sashes). Making arguments for this being energy efficient or a conservation choice are problematic because most energy loss is from perimeter infiltration (only 10-20% of heat loss is due to transfer through the glass panes), which is why we recommend maintenance actions such as weather stripping and replacing glazing putty. Lead paint is a concern, but there's EPA guidance on mitigating lead paint for historic properties and we've had property owners do both encapsulation and full remediation.

All of which is to say that this will be a challenge.





Thank you. I think that this is more in line with what they need. I think it would be helpful to have actual dimensions of the window sashes rather than just a statement that all dimensions on the windows are the same, because it is hard to imagine that the dimensions would be identical. Are these full divided lite, simulated divided lite, or grill between glass? Are the replacements aluminum clad? Fiberglass? Wood?




