Thank you, Lance. I will go through each crash, separately, by date of crash:

- 11/30/16—this is the crash we have
- 12/4/16—the crash occurred on Baldwin, not on Spaight, even though it is pinned as the intersection.
- 4/24/17—this crash was actually on the 1500 block, so that is why it did not show up in my database.
- 9/17/18—I cannot find this crash report in our database. I am not sure why, but I will attempt to find out prior to the meeting on Wednesday.
- 8/31/19—we do not have crash reports for 2019, yet. There is about a six-month delay until WisDOT releases the crash reports for the year to us, so we won't get these until next summer, at the earliest. WisDOT changed crash report forms to all electronic, which is their first change to the form since the mid 1990's, so there is an extra-long delay now).
- 9/11/19— again, we do not have crash reports for 2019, yet.

The 2019 crash information is good to have, though, and worth noting at the TC meeting. We just only use the crashes that are released from the State after their review to make things fair when ranking streets in our Neighborhood Traffic Management Program.

Thank you for the email/report. Thank you, Tom and TE, for going through the work to get some data on these options.

I wanted to point out something concerning, however. In early September, I contacted the MPD Records Dept and asked for the past *three years* of crash data for just the 1300+1400 blocks of Spaight. I was given the attached spreadsheet showing *five accidents in three years*. Your report shows just one accident in six years. I think it's important to get the crash data right if we are to appropriately assess the problem to search for a remedy. Perhaps having five reported crashes in a residential/school zone over just three years leads to a more appropriate outcome than assuming just one crash over six years.
