Dear Mr. Verbick:

The Stipulation to terminate the proceeding before the Alcohol License Review Committee on Assistant City Attorney Zilavy's complaint seeking revocation of the liquor license of T.C. Visions, Inc., requires that three internal Visions policies be submitted to your office by today: a weapons screening policy, a policy for inspecting purses and other bags for possible weapons, and a customer ejection policy.

We enclose Visions Weapons Screening Policy and Visions Customer Ejection Policy.

Although the Stipulation treated the weapons screening policy for hand-held metal detectors and the policy for inspecting purses and other bags for possible weapons as separate policies, we found it much more practicable to combine these into a single policy.

Although the Stipulation required only the hand-held metal detector policy to be "acceptable to the Captain of the North Police District," we have discussed both of the

enclosed policies with Captain Brian Ackeret and revised both of them based on his requests. Since we have incorporated 100% of his input, we expect that the enclosed policies are acceptable to him, but we copy him on this letter, with enclosures, to give him the opportunity to indicate if we are mistaken.

These policies are in effect at Visions.

Visions Customer Ejection Policy

In most circumstances, customers who have engaged in boisterous, unreasonably loud or otherwise disorderly conduct in Visions may be given one warning that further misconduct will result in their being asked to leave without a refund. In the event that the same customer's misconduct is repeated, the customer will be asked to leave.

Customers who engages in violent, abusive, indecent, profane, boisterous, unreasonably loud or otherwise disorderly conduct that significantly disturbs others will not be served and will be asked to leave without a warning.

Customers who are asked to leave will not be physically ejected except in an emergency. Every effort will be made to persuade customers who are being ejected to leave the premises without the use of force. If force is required to eject a customer, only the minimal amount of force necessary to achieve the customer's ejection is permitted. Other customers will not be permitted to assist in the ejection of an unruly customer except in an emergency. If a customer is unwilling to leave when asked, staff are encouraged to call the police for assistance.

Visions Weapons Screening Policy

- Each entering customer (including customers who have left and returned) will be screened for weapons before being permitted to move about the club.
- Screening will consist of:
 - Scanning customers' persons with a hand-held metal detector, and
 - Visually inspecting purses and other bags.
- No weapons (meaning guns, facsimile guns, knives, pepper spray or mace) may be brought into the premises.
- If a staff member encounters a pocket knife, pepper spray or mace during the screening process, that item will be confiscated and will generally be returned when the customer is leaving. However, if the customer has become intoxicated and/or unruly, he or she will have to return another day to retrieve the item.
- If a staff member encounters a gun, the police must be called. If the customer has a concealed carry permit, the police will allow the customer to leave and take the gun to his or her car or home. If the customer does not have a concealed carry permit, or if the customer is otherwise not eligible to possess a firearm, the police will confiscate the gun.
