All known burial sites in Wisconsin are protected under State Statute 157.70 – please see this link for additional

information. https://wisconsinhistory.org/Records/Article/CS15239 In brief, burial sites are divided into two categories — catalogued and uncatalogued. Cataloguing a burial site awards the site additional protections. In order to complete ground-disturbing work within the boundary of a burial site, owners and/or contractors must submit forms and plans (a Request to Disturb form) to our office at the State Historic Preservation Office to get our authorization or permit. Our office also maintains the boundaries of these sites.

The Panther Mound at 4918 Lake Mendota Drive has portions that are both catalogued and uncatalogued. The mound itself is catalogued, providing it with the highest of protection, while the surrounding area is uncatalogued. The area that the house that will be demolished is within the uncatalogued portion. The property owners and the contractor are aware of the site and the law. They have the boundaries of the mound and have been including them on their architectural site plans. They have already submitted a Request to Disturb form for this work. They are required to have an archaeological monitor on-site during any ground-disturbing activities. Since the site is challenging due to the mound, we have continued contact in case any additional issues

come up during construction.
