The Spearmint Rhino club met these requirements, and in February the club gained permission from the Police Permit Review Panel to open in Van Nuys, foiling a two-year battle by residents.

State regulations prohibit bars featuring full nudity from serving alcohol, leading these businesses to operate as "nude juice bars."

Like many such bars, Spearmint Rhino bills itself as a "gentlemen's club," with fully nude dancers, lap dancing and tipping by patrons. (Lap dancing is a private tete-a-tete in which the stripper sits in the lap of a patron, who pays extra for the one-on-one performance.)

The emerging Los Angeles ordinance, which officials expect to be completed by year's end, is modeled after laws in two cities that so far have passed legal muster.



The City of Sin is filled with numerous attractions. From the family-friendly showings of the Rat Pack to the risque performances of Cirque du Soleil, Vegas has something for just about everyone. But for those of us who's inclination is for something of the more scandalous variety, only Las Vegas strip clubs can offer the much needed break from the status quo of daily life.

But what's entertainment without a little liquid-aid for what ails us? Needless to say, alcohol and strip clubs go together like peanut butter and jelly. Unfortunately, there were those in the mid-90's that decided no one should be able to enjoy both vices at the same time. As a result, section 6.35 in the Las Vegas Code of Ordinances was amended to include the prohibition of alcohol in Las Vegas strip clubs which opted to host full-nude erotic dancing.

Making Strip Clubs Go Dry, Then Go Away

With its fish-market-perfumed air, waste-transfer stations and a moored prison barge visible just off its coast, the industrial peninsula of Hunts Point in the Bronx has long been somewhat of an indifferent haven for the city's topless bars and pole dancing parlors.

With names like Club Heat and BadaBing, they proliferated amid the warehouses and next to the Bruckner Expressway after restrictive zoning laws instituted by the Giuliani administration forced them from other neighborhoods.

But one by one, the clubs began to close: Just two years ago, there were four strip clubs in Hunts Point's 1.6 square miles. Now there are none.

The strip club industry is under broad attack in New York, as opponents have embraced a startlingly effective strategy: Spare the strip clubs, but punish their liquor.

In the last several years, community leaders have found increasing success petitioning the State Liquor Authority to revoke the liquor licenses of numerous strip clubs in New York and deny the applications of new clubs. The opponents cite crime, noise or other quality-of-life issues, or highlight a club owner's lack of qualifications or possible criminal ties.

The tactics have led many owners to try to operate without selling alcohol — a status that, ironically, because of vagaries in the rules governing exotic dancing, allows the clubs to be totally nude. But the resulting loss of customers makes clear that the presence of alcohol is far more important than the absence of pasties.

And when there is no champagne in the champagne room, the flow of revenue also dries up.

"You go after their liquor license," said Rafael Salamanca, the district manager of Bronx Community Board 2, which covers Hunts Point. Mr. Salamanca has spearheaded efforts that led to the closing of four clubs in the last two years. "They can't make any money if they don't have a liquor license."

In determining whether to award a license, the authority considers criteria like the proximity of other such establishments and the background of an applicant. The authority also "places substantial weight on the recommendations of community boards and residents living near a proposed bar or restaurant."

Some of the arguments against a club can be rather straightforward. Mr. Salamanca cited one Hunts Point venue, Club Eleven, that he said was a magnet for trouble; the police were called to numerous fights and assaults that stemmed from the club. And in December 2011, a woman was shot and killed outside.

Other battles require more effort. Club opponents have set up their own task forces and begun to investigate club owners, reporting any dirt to the Liquor Authority. As a result, established venues have seen their liquor licenses contested for reasons that sometimes amount to technicalities.

In the case of Platinum Pleasures in Hunts Point, club owners did not notify the authority and surrender its license when it was temporarily shut for construction work. The owners also failed to disclose that they received \$126,880 from an unidentified interest. The authority revoked the club's license, saying that officials must know who is providing financing. The club closed in 2013; last week, a State Supreme Court justice upheld the decision to revoke its license.

Platinum Pleasures' sign, featuring female silhouettes, has now been replaced by a For Sale banner. A local pastor has expressed interest in converting the space into a church.

The co-owner of a downtown Milwaukee strip club is a key figure in a federal investigation into sex trafficking, money laundering and torture involving a club he owned in Dodge County, newly released court documents show.

Radomir Buzdum was the owner of TNT Gentleman's Club in Lebanon, which he said has closed and is for sale. He co-owns Silk Exotic strip clubs on Old World Third Street and in Middleton. Silk is trying to open a second downtown Milwaukee location, "Silk on Water," at 144 E. Juneau Ave.

Two people have been indicted in the case. Christopher Childs, 46, of Hartford, faces federal charges in Milwaukee of sex trafficking involving force, fraud and coercion and conspiracy to engage in sex trafficking. Jennifer Campbell has also been charged with conspiracy to engage in sex trafficking.

Buzdum has not been charged, but he acknowledged in an interview with the Journal Sentinel that he is under investigation. Court documents make it clear that investigation is ongoing.

Search warrant applications targeting both TNT and another Dodge County strip club became public in March after being filed in federal court.

Longtime Silk Exotic strip club owner Jon Ferraro secretly pleaded guilty to conspiring to commit money laundering and racketeering nearly three years ago in a federal case known as "Russian Laundry," recently unsealed court documents show.

Ferraro, who is no longer a Silk owner, told the Milwaukee Journal Sentinel that he had "entered into a bad business deal in Las Vegas" several years ago.

"As a result, I left myself exposed to criminal liability for which I have accepted responsibility for and I am deeply remorseful," he said in a statement.

"I love the city of Milwaukee. I have been honored to do business here, and I appreciate the trust people have in me," Ferraro said. "I apologize for my bad judgment in this instance. In the future, I will do everything I can to be worthy of that trust again."

Ferraro agreed to cooperate with the government in that case and related investigations as part of his plea agreement, records show.

Ferraro's plea deal is the latest twist in a series of federal criminal investigations linked to Silk Exotic, which now has two strip clubs in downtown Milwaukee.







The leader of the workforce development agency serving Milwaukee County has been charged with wire fraud for allegedly accepting \$30,000 by falsely claiming he was negotiating on behalf of a Milwaukee alderman to accept a bribe in exchange for their vote for licenses for a downtown Milwaukee strip club.

Willie Wade was named Employ Milwaukee's CEO in July 2018 after spending the preceding two years on the workforce agency's staff following a 13-year tenure as a Milwaukee alderman. In April and May 2017, a little more than a year prior to his appointment as CEO, Wade allegedly operated a scheme to defraud an individual associated with the Silk Exotic strip clubs as that business was seeking licensing for a new downtown location, which opened in May 2018.

According to an indictment filed in the U.S. District Court in the Eastern District of Wisconsin Wednesday, which charges Wade with three counts of wire fraud, Wade claimed to be working on behalf of an unnamed Milwaukee alderman and accepted \$30,000 from the Silk representative purportedly in exchange for the support of the alderman, who the indictment says was unaware of Wade's dealings.

Silk Exotic isn't named in the indictment, but listed dates of meetings held by the city's Licensing Committee and the Common Council cross-referenced with archived meeting minutes show Silk's future downtown location was discussed on the dates in question.

Wade was a Milwaukee alderman from 2003 to 2016.

Don Layden, Employ Milwaukee's board chair, said Wade has been put on administrative leave without pay. He said Wade informed him about the possibility of the charges about a week ago and they both felt it was appropriate for
