For projects also requiring Plan Commission approval, applicants must also have submitted an accepted application for Plan Commission consideration prior to obtaining any formal action (initial or final approval) from the UDC. All plans must be legible when reduced.

*Electronic copies of all items submitted in hard copy are required. Individual PDF files of each item submitted should be compiled on a CD or flash drive, or submitted via email to <u>udcapplications@cityofmadison.com</u>. The email must include the project address, project name, and applicant name. Electronic submittals via file hosting services (such as Dropbox.com) are not allowed. Applicants who are unable to provide the materials electronically should contact the Planning Division at (608) 266-4635 for assistance.

7. Application Filing Fees

Fees are required to be paid with the first application for either initial or final approval of a project, unless the project is part of the combined application process involving the Urban Design Commission in conjunction with Plan Commission and/or Common Council consideration. Make checks payable to City Treasurer. Credit cards may be used for application fees of less than \$1,000.

- Planned Development (PD): General Development Plan (GDP) and/or Specific Implementation Plan (SIP)

Each submittal must include fourteen (14) 11" x 17" <u>collated</u> paper copies. Landscape and Lighting plans (if required) must be <u>full-sized and legible</u>. Please refrain from using plastic covers or spiral binding.

Introduction

The City of Madison's Urban Design Commission (UDC) has been created to:

- Encourage and promote high quality in the design of new buildings, developments, remodeling, and additions so as to maintain and improve the established standards of property values within the City.
- Foster civic pride in the beauty and nobler assets of the City, and in all other ways possible assure a functionally efficient and visually attractive City in the future.

Types of Approvals

There are three types of requests considered by the UDC:

- <u>Informational Presentation</u>. Applicants may, at their discretion, request to make an Informational Presentation to the UDC prior to seeking any approvals to obtain early feedback and direction before undertaking detailed design. Applicants should provide details on the context of the site, design concept, site and building plans, and other relevant information to help the UDC understand the proposal and provide feedback. (Does not apply to CDR's or Signage Variance requests)
- Initial Approval. Applicants may, at their discretion, request initial approval of a proposal by presenting preliminary design information. As part of their review, the Commission will provide feedback on the design information that should be addressed at Final Approval stage.
- <u>Final Approval</u>. Applicants may request Final Approval of a proposal by presenting all final project details. Recommendations or concerns expressed by the UDC in the initial approval must be addressed at this time.

Presentations to the Commission

Primarily, the UDC is interested in the appearance and design quality of projects. Emphasis should be given to the site plan, landscape plan, lighting plan, building elevations, exterior building materials, color scheme, and graphics.

When presenting projects to the UDC, applicants must fill out a registration slip provided in the meeting room and present it to the Secretary. Presentations should generally be limited to 5 minutes or as extended by motion by consent of the Commission. The Commission will withhold questions until the end of the presentation.

Applicants are encouraged to consider the use of various graphic presentation material including a locator map, photographs, renderings/model, scale drawings of the proposal in context with adjacent buildings/uses/signs, etc., as may be deemed appropriate to describe the project and its surroundings. Graphics should be mounted on rigid boards so that they may be easily displayed. Applicants/presenters are responsible for all presentation materials, AV equipment and easels.

Dear Janine and Urban Design Commissioners,

The owner of 7 W Main Street desires to enhance the aesthetics of the property with a façade alteration including recladding the exterior with modern and cohesive materials. The building is located in the Downtown Core (DC) zoning district and requires review with the zoning code and Urban Design Guidelines. The zoning district's purpose and guidelines are addressed below for reference.

7-9 W Main formerly operated as two distinct buildings for decades, and most recently were combined to form a single building being operated as a restaurant. Opportunities were analyzed for the property, with the result being that tying together both buildings into one cohesive design would enhance the architecture of the building and the pedestrian experience along the Capitol Square. We have incorporated feedback from two prior presentations to the Urban Design Commission to create a more comprehensive façade alteration that respects the urban design guidelines.

Zoning: DC Downtown Core

- 28.074 Downtown Core District
- (1) Statement of Purpose.

The DC District is established to recognize the Capitol Square, the State Street corridor, and surrounding properties as the center of governmental, office, educational, cultural, specialty retail and recreational activities for the City and the region. ... This district is intended to allow intensive development with high-quality architecture and urban design.

Repurposing traditional buildings for contemporary use will help 7–9 W Main continue to play a relevant part in the specialty retail, cultural and recreational activities in the Downtown Core district.





Urban Design Guidelines

The design guidelines were developed to ensure that...alterations to existing buildings, are compatible on a city, neighborhood, and block level, have an engaging pedestrian orientation, and are designed to reflect the use of the structure.

Prior remodeling and façade improvement at 7–9 W Main joined two buildings into one building for the former Brocach restaurant. The ground level façade bridged the two similar facades to appear as one unified storefront. The proposed exterior material upgrade seeks to further unify the building façades across the two original buildings as well as from first to second floor. This will bring more continuity to the project as well as hierarchy of the pedestrian experience as 2 existing entrances to one space can cause confusion.

4a. The size and rhythm of windows and doors in a building should respect those established by existing buildings in the area where a clear pattern exists, and the residential and/or mixed-use nature of the building.

The existing clock, installed with the most recent façade remodeling, would be removed as it was more closely tied to the branding of the former restaurant. The existing window and entrances will be maintained to respect the existing building and history. It also allows the façade to continue to tie in and not disrupt the rhythm of the existing context.

5a. A variety of complementary exterior building materials may be incorporated to provide visual interest to the building. The palette of materials should not be overly complex.

The existing brick exterior cladding will be covered with Nichiha rainscreen system panels to create a more contemporary aesthetic over the existing brick facade. The use of 2 different colors and textures will keep complexity down while providing visual interest and a level of durable design to unify the entire façade.
