"A payment of \$389,059 due to Seller 90 days after the commercial operation date of the New Lisbon Solar Facility, which is full payment for 100% of the RECs to be produced by such Facility during the entire Term ("Prepayment 1");

and \$4.75 per REC to be produced by the Argyle Solar, Cumberland Solar, Elroy Solar and Fennimore Solar Facilities during their first year of operation."

Fiscal Year 2020 (January 1, 2020 - December 31, 2020):
