The brewery is in a building of 5,800 square feet constructed of metal with a stucco facade. The public area consists of an entryway and restroom of approximately 600 square feet and a taproom and additional restroom of approximately 1,513 square feet. The wine will be served in the taproom from behind the bar and will be stored behind the bar. The private areas consist of a locked office of approximately 300 square feet, a locked cellaring space of approximately 300 square feet, and approximately 3,087 square feet of locked brewery and warehouse space, including a walk-in cooler. A small outdoor seating area of approximately 288 square feet is accessible from the taproom.
