Thank you for sharing this information with me. I can understand the hesitation with speed humps. I was wondering about the report. Were the speeds checked only between Putnam and Piedmont? I'm asking because it seems like speeds are faster than what's reported here by the time the cars get in front of our school. It also seems like the flashing speed limit sign may help initially in dropping speeds but I wonder what speeds they are reaching near our crosswalk as they go down the hill?

Lowering the speed limit to 25 mph may help. I also think building out the curbs may help. Last week we had a driver who had to slam on their breaks because they were watching the buses and kids on one side of the road and didn't see the crossing guard walking out on the other side of the road. It may be beneficial if the crosswalk was more visible. I think the flashing signs are quickly ignored as people get used to seeing them.

I am not able to be at the meeting on Wednesday due another meeting already on my schedule. I believe there may be a PTO parent who lives in the neighborhood and regularly uses the crosswalk that is planning to attend.

I wanted to give you an update on the speed hump situation for Prairie Rd at Huegel Elementary. As mentioned in the emails below, the City's Transportation Commission asked for further speed data and exploration of options other than speed humps for Prairie Rd. I have compiled the speed data, and that is attached to this email. This data will be discussed at the next Transportation Commission meeting on Wednesday, February 26 at 5pm in Room 215 of the Madison Municipal Building. This is a public meeting and would be your chance to speak in favor of speed humps for Prairie Rd. Each member of the public is allowed three minutes to speak. You also have the option of sending an email to the commission to publicly state your support or opposition.

As far as options other than speed humps, I see three main options:

- 1. Lower the speed limit signs from 30 mph to 25 mph
- 2. Construct curb "bump-outs" at the crossing-guard location to increase pedestrian visibility and shorten the crossing
- 3. Install a "Rectangular Rapid Flashing Beacon (RRFB)" at the crossing-guard location

If you could let me know your thoughts on any or all of these, that would be helpful.

The Transportation Commission did NOT approve speed humps on Prairie Rd at the 1/22/20 meeting. Their reason for this, was the relatively low speed data—only 1% of traffic over the "Posted Speed Limit + 5". From my understanding, the plan moving forward is to further analyze the speed study, rather than only using the "posted speed limit +5" metric and possibly propose an alternative to speed humps. We have not yet determined which future meeting we will discuss this. However, we will need to do this soon (February or March), in order to maintain our contract bidding schedule for the work. I will let you know when that meeting date is scheduled. Thanks,

Alder Albouras and Barb,

Thank you for getting the ball rolling on this issue! I will try to cover everything regarding the traffic situation along Prairie Rd at Huegel Elementary in this email.

We understand that speed is still an issue on Prairie Rd at the school. The nature of the street leads to higher speeds, which include:

- Downhill slope from Putnam Rd to Pilgrim/Monticello
- Straight street geometry
- Relatively wide street—44'
- Open field of vision on the east side of the street—no trees, driveways, or buildings close to the roadway
- Regular commuters who are familiar with the street

All of these factors naturally lead to relatively high driver speeds. While the radar speed feedback board that was installed for northbound drivers just north of Piedmont is a helpful tool, it does lose effectiveness as drivers become familiar. We painted crosswalks, bike lane lines, and parking lane lines in 2017. While this also is helpful, the effect on speeds along a straight stretch of roadway like this is minimal.

Regarding possible additional Stop signs at Piedmont Rd--we do not recommend installing an all-way stop for a few reasons. Stop signs are an important traffic control device, and when used at the right location, under the right conditions, are a valuable and effective device. At the same time, when used incorrectly their use can create problems and worsen conditions and safety. Stop signs are used to assign the right-of-way when there is a crash problem or where traffic volumes are so high that people cannot find a safe gap in traffic. However, stop signs are often requested with the goal of reducing traffic speed and/or for improving safety for pedestrians. It is logical that if you make someone stop then the speeds overall will decrease. While speeds near the intersection are reduced, they are not affected along the greater length of the street and in some instances drivers, who do slow or stop, try to make up for the lost time and increase travel speed away from the intersection. Studies have found at locations with unwarranted Stops, motorist compliance can be poor. When drivers start rolling through

an intersection safety is reduced. It is also a concern for children who believe adults obey the law and follow the rules, and when they enter a street believing approaching traffic will stop and it does not, the end result can be the very thing the neighborhood is concerned about--a crash involving a child.

For this case, the most effective way to permanently reduce speeds is with speed humps on Prairie Road. There are no bus routes on this stretch and the Fire Department is okay with speed humps here. Prairie Road does have relatively high traffic volume for speed humps (close to 5,000 veh/day), so we do need to consider traffic diversion. Some thru traffic may divert to Sara Rd, but if we limit the number of speed humps, I do not anticipate major traffic diversion. For these reasons, I will move forward with the traffic calming process by ordering a speed study. Hopefully, our crews are able to collect that data yet this winter (snow or very low temperatures do not allow our hose-counters to work). If we can get the data this winter, here are the remaining steps to get speed humps installed:

1. City ranks the street compared to all other streets in the city that are being considered for traffic calming.

2. Top ranking streets are chosen by Traffic Engineering staff for next year's contract.

3. Projects are approved by the Transportation Commission, Board of Public Works, and Common Council.

4. City TE surveys residents on the street for final approval.

5. Projects that have at least a 60% approval of surveys returned by residents will be constructed the next summer/fall .

So the number one goal for now, is for us (TE) to get the speed data on the street. I will let you know the results of that, when it comes in.

I will also send this information to the Principal at Huegel Elementary, so school staff can respond to parents with the most up-to-date information.
