- UWPD Downtown liaison officer starts patrol
 - Specific questions to UWPD
 - 2019 staffing report showed a need to reallocate 12 specialty positions to patrol
 - Langdon St. Neighborhood Officer was one of two NPOs chosen
 - Plus two Gang Unit Officers, two Community Outreach Officers, and six CPT Officers (one from each team)
- Madison Police credits drones to recent success
 - Program started in 2017
 - UAS Team has 17 members
 - 13 Operators that can fly
 - 4 Visual Observers
 - Train multiple times per year
