PURSUANT TO SECTION 38 OF THE MADISON GENERAL ORDINANCES AND CHAPTER 125 OF THE WISCONSIN STATE STATUTES.

Tavern Premises: 3,252 square foot space on the first floor of the L.L. Olds Warehouse Lofts Apartments. Street-facing with large windows, open concept with two-stall men's and women's bathrooms. Alcohol to be stored behind bar for sale and locked cabinets in locked back room for storage. Records stored in locked cabinets in the basement, inaccessible by patrons.

Granted by the Common Council on 5/1/18 with the following conditions:

- 1. Capacity shall not exceed 155 persons.
- 2. The establishment will close no later than 11 p.m. Sunday-Wednesday and no later than midnight on Thursday.
- 3. Food shall be available at all times the establishment is open.
- 4. The sale of alcoholic beverages shall account for 75% or less of the establishment's gross receipts.
- 5. The establishment shall operate as a Recreation Premises per MGO 38.05(9)(d) 7.a.v through the business model of a Video Arcade.
