Bremer moved to not install speed humps on Dorsett Drive, seconded by Kliems. With no further discussion, the motion passed by voice vote/other.

Brown moved to install a traffic circle at North Star Drive and Orion Trail, seconded by Foster. With no further discussion, the motion passed by voice vote/other.
