Dear Ledell Zellers:

While our city is struggling with the upheaval of a global pandemic, Edgewood High School has put in a Conditional Use application to light their playing field. Therefore, I am compelled to write you this letter.

I have been a neighbor of the Edgewood campus for 35 years. I understand how the high school would like to install lighting for a stadium on their practice field to give their alumni and students a stronger sense of identity and unity. However, the community that Edgewood resides in already HAS a strong sense of identity and unity. It involves tranquil mornings at the breakfast table with the windows open, gardening or cooking dinner in the backyard, and paddling a canoe on Lake Wingra. The sense of identity Edgewood wants to create for its alumni and students would be fine if it didn't mean that the community surrounding the campus would see theirs downgraded in exchange, which is what 80 decibel-level crowd noise and 80-foot pole lighting will do.

In the Conditional Use Ordinance 28.183 MGO, there are Approval Standards in subsection (6)(a) that read in part, "No application for a conditional use shall be granted by the Plan Commission unless it finds that ALL of the following conditions are present:," and it lists several conditions. #3 of this list reads, *"The uses, values and enjoyment of other property in the neighborhood for purposes already established will not be substantially impaired or diminished in any foreseeable manner."*

A sound engineer working for Edgewood College in 2010-11 measured the ambient sound level of a typical summer evening on Woodrow Street rimming the west side of campus. It was around 43 decibels. 43 decibels is the level of hum your refrigerator makes. Other measurements while games were actually in session in October 2019 taken inside houses *with windows open* found the decibel level to be 84. That's what a diesel truck going 40 mph 50 feet away from you sounds like. Residents could not converse with each other in their livingrooms. Add to the above mix a sportscaster wanting to be heard over the crowd, a pep band or canned music or two of those at the same time. Can you imagine trying to put your kid down for a nap or even trying to sleep yourself *until 11 PM or later every night?*

In the Imagine Madison Comprehensive Plan, under Special Institutional uses, it states, *"SI uses...should be designed to fit gracefully within, rather than dominate their surroundings...campus development should be compatible with surrounding uses and their design characteristics, and mitigate potential impacts on adjacent areas."*

Make no mistake. A stadium at this location would be anything but "graceful."

Edgewood makes the case that they've been at this location nearly 100 years, before anyone else was, therefore, they have the right to a stadium.

I say they've been at this location nearly 100 years - and can obviously survive without one.

Please recommend against granting them a permit to light their field.

To the Plan Commission,

As a resident in the DMNA neighborhood living 4 blocks from Edgewood High School, I am writing in opposition to the Edgewood stadium expansion plan, which will have significant environmental (noise and light pollution) and community impacts. The installation of lights on this campus field in such close proximity to homes and the Lake Wingra watershed is a mistake. Lights will allow the school to use the field continuously. Paired with the amplified sound that will accompany events, it introduces a health hazard and diminishes the intrinsic value of the community.

It is clear that the Edgewood board has this expansion "hard baked" into its strategic plans as a means for economically saving the school--which has been losing enrollment--at the cost of the residents who have long lived in the surrounding community. I would add that when one asks, Who benefits? it's not just the Edgewood campus: Look no further than to the President of the Edgewood Board whose sports business stands to make a killing.

It's in situations like these, when local business/organization demands threaten the interests of residents, that we need the leadership and support of our elected officials, city agencies, and planning commissions. Indeed, the very notion of a shared "commons," established long ago on the Boston commons, is at the heart of why we need your support for us as residents.

This situation reminds me of our fight as eastside neighbors against the Kipp Corporation years ago when it expanded its operations in close proximity to long-time residents. The result was increased noise and air pollution, both of which permanently damaged the surrounding neighborhoods. 15 years later, a class action lawsuit against the Kipp was resolved on behalf of the residents--a win for the "common people" in the "commons," and a clear signal we were in the right. But nonetheless the damage to the environment had been done and continues to this day (see City well pollution issues near Kipp).

My point is, if you don't stop this NOW, we as a City will be living with this decision--and regretting it--forever.

Ironically, in the midst of the fear and anxiety of a pandemic, cynically, the Edgewood board continues its bullying behavior and insistence on expansion. We are counting on you to push back and speak up for us, whatever it takes.

Hello,

My husband and I live at 815 Terry Pl, two blocks from Edgewood. I do have some concerns about their proposal to install lights.

My biggest concern is that the light install will lead to a lot of night games with amplified sound. We have young kids and our backyard has always been a quiet haven for us, since we moved into the neighborhood. We are mostly surrounded by quiet older neighbors and value the peace and quiet of the street. It suits our family well and is a really important part of the reason we chose our house, on a dead end near a park.

I'm worried if the lights are installed, since Edgewood has dealt with this issue over the last year by pushing the limits, not necessarily adhering to previous agreements or laws about when they could use the field, that it will be a slippery slope to a lot of nights where game sounds will be kind of loud in our backyard and we can't just chill out with our family.

I personally think that the occasional night game (like every Friday night during football season) is fine. I'm not intrinsically opposed to some use of the field and some noise. But I am worried about it escalating into a lot of use. I'm worried about there being no limits, or if limits are put in place, Edgewood just ignoring them. I want Edgewood to follow the rules of whatever agreement gets put in place, and I'm honestly worried they won't.

Having been neighbors with Edgewood for a while, I feel like sometimes I do doubt the integrity of their leadership. I read over the documents related to the lawsuit against the city, and it felt like there were places where they stated conflicting information (for example, I feel like they said early in the process that they had originally intended the field only for practice, and then changed their mind; then later they said it was an oversight to describe the field this way in the neighborhood agreement and that the field had always been used for games). I also feel like it's a little sketchy to keep pushing forward with this issue while the community is super distracted with other, much more important things right now.

My husband also serves on the farmers market board and I have gotten to know about them a little that way too. This year, they sent the board notice that they were going to start charging \$20,000 a year to host the market in their lot. I think this happened in March, less than two months before the market was supposed to start – a market that some of the vendors make a substantial portion of their living on, and had already started planting crops for. (This market operates on very little budget, I'm not sure of the exact amount, but I think they're raising a few thousand dollars a year from the vendors.) They eventually settled on a smaller, affordable amount with the market, which was great – but it was a haphazard and weird approach to the relationship. It sounded like this wasn't the first time a last-minute change had been presented before the start of the season, bringing a lot of uncertainty to vendors and the board, which is a pretty small volunteer group with a lot on their plate. I bring this up partly because Edgewood cites the market as one of the things they do for the community. Actually I think it's awesome

that they host it, and I'm really appreciative (and attend the market almost every Sunday). But twice in the last year the board has been suddenly scrambling to find a new location for the market, so it feels like an uneasy relationship.

Finally, I was surprised at the beginning of this whole saga that they were going to put money into their field, and not into increasing parking, which is really needed in the neighborhood.

I think that a number of their actions over time have just led me to doubt how truthful they're always being, the amount of integrity they're acting with, and whether they're just saying they care about the neighborhood because they have to say that. Call it a character reference, from a neighbor who started out open-minded on the issue, and has been a little bothered by how Edgewood has acted over time.

I would personally love to have a really great relationship with Edgewood, as a neighbor, and I think that there is a compromise here that could be reached that everybody could be pretty happy with. I think that the tactics of the No New Stadium group have also been pretty strong. I'm just worried, because of the divisiveness of the situation and everybody being escalated, and how Edgewood has been approaching things, about how they might proceed, and I feel like that has to be taken into consideration when figuring out how to move forward on this issue.

Dear Tim Parks,

I didn't think it would be possible but I am shocked that Edgewood High School is pursuing a conditional use permit at this time. It almost seems like they are taking advantage of the pandemic.

EHS' permit application does not meet conditional use permit standards. The Edgewood High School letter of intent, March 11, 2020 states:

*Field Lighting use may exceed the turnoff times to accommodate specially scheduled activities including, but not limited to, playoff games, games requiring overtime periods, weather delays, or health and safety delays.*

This suggests that the lights can stay on as late as Edgewood deems necessary. On any night.

And as you know, with lights comes the accompanying amplified sound. Crowd noise, announcements, and starter pistols are sounds that those who live as close to the field as I do are very familiar with. Last spring I had to take a business call in my basement because there was no room in my house in which I could escape the noise and hear my client. If this permit is approved the noise will be relentless and inescapable. This seems in clear violation of the [Conditional Use Standards for Review](#) Approval Standards

*6 (a) item 3. The uses, values and enjoyment of other property in the neighborhood for purposes already established will not be substantially impaired or diminished in any foreseeable manner.*

The enjoyment (and I suspect, the value) of my home WILL be substantially impaired. I would not be able to use my screened-in front porch or my deck. I would not be able to leave my windows open on cool evenings. Now that many of us are working remotely, I hope it is much easier to understand how disruptive and stressful the constant noise from the field was last spring and fall. I wore headphones and kept the windows of my home office closed. To allow that to continue into the night is inhumane.

It is a tragic irony that the community surrounding the athletic field is experiencing its last quiet spring as a result of COVID-19. People are flocking to the the Park and Pleasure Drive and unfortunately, the playing field for much needed refuge and recreation.

EHS is in violation of the state's "safer at home" order. Leaving their field unlocked encourages people to congregate: playing soccer, frisbee, an exercise with huge a tire and track practice with orange cones. I have witnessed as many as 5 groups using the field simultaneously. There is a small 8.5 x 11 inch sign stating that fines will be imposed if users climb the fence and use the field when it is locked but zero health warnings. I am not insinuating that these are Edgewood-sanctioned activities but by leaving the field unlocked and open and not posting any health department signs like the ones posted in Vilas and Wingra parks, EHS again reveals their blatant disregard for the health and welfare of the greater community.

The installation of lights on this campus field in such close proximity to homes and the Lake Wingra watershed does not meet the approval standards. Lights will allow the school to use the field continuously. Paired with the amplified sound that will accompany events, it introduces a health hazard and diminishes the intrinsic value of the community. Other standards that are not met include those concerning parking and traffic.

I believe that neighboring property owners have every right to use their property. Last year, the City did not penalize



or restrict Edgewood from playing games despite a zoning violation, even after the Zoning Board of Appeals affirmed the City's zoning interpretation.

Denying Edgewood lights is the only reasonable way to ensure that neighbors' ability to use and enjoy their homes will not be further diminished by use of the field.

To the Plan Commission,

I live across the street from Edgewood with the practice field visible from within my house. As it is I hear every announcement, every gun shot for races, every whistle/clap/cheer, etc, and while I support Edgewood's desire to use their facilities as they are now for daytime games and practices, I am very concerned about the effects the requested LED lights and amplified sound system and late games will have on the surrounding neighbors' health, well-being, and enjoyment and value of their own homes. The lighting expansion in particular will encourage the scheduling of late/after-hours games. Edgewood has previously stated intent to hold games regularly into evening hours, at times as late as 10pm, for ~40 nights/year. They have said that other non-football games might end earlier by 8:30 pm, but they also have not ruled out the idea of renting their field out to other schools beyond those 40 nights/year. The lights would likely remain on even later until the crowd dispersed. The day-to-day impact of this on individual families' quality of life will be high. I do not trust based on witnessing the lighting and sound of a similar stadium at [Waunakee High School](#) that it would be as inobtrusive as advertised. And if Edgewood does exceed sound or lighting levels allowed, how would it be enforced once these systems are installed? If neighbors record higher light/noise levels than allowed will we have to sue or will the city step in? I do not have much faith that Edgewood will comply with any citations regarding noise or lighting once their equipment is installed based on their recent actions.

LED lighting in the evening hours even in short exposure has been linked to retinal problems and sleep disturbance, and there is concern it could have effects on cardiovascular disease, diabetes, cancer and obesity. Noise pollution is linked to problems with mental and cardiovascular health. (And there's also the impact on wildlife to consider which I'm sure you have heard mentioned elsewhere.)

To a certain degree I am sorry that Edgewood did not plan for future needs properly, putting their field in an area so close to their neighbors that they have boxed themselves in. But I don't think the neighborhood, especially those neighbors directly across from their field, should have to pay the price so that they can play a home football game and make some money by renting their field. No one is stopping them from playing. They are still playing football at other stadiums or in the daytime at their own field. But to me the harm caused by installing amplified lighting and sound systems with neighbors living less than 100 ft from their field is greater than any potential benefit.

**Subject:** Community access to Plan Commission hearings

Dear Ms. Stouder, Mr. Tucker , Mr. Parks, and Alder Evers,

First, I would like to express my deep appreciation for how the City of Madison has handled the COVID-19 crisis. Staff and alder commitment to the well-being of citizens, and all of the hard work behind efforts to protect health and ensure voter access, has been heartening to witness and a source of pride in our city.

However, it is unfortunate that Edgewood is pushing a stadium proposal during a pandemic when the City of Madison is managing the emergency, and surrounding adjacent community members are dealing with job loss or other financial burdens, trying to maintain businesses or work from home, and struggling to care for and educate their children. Some adjacent neighbors are currently suffering from COVID19. For most, this is a time of tremendous anxiety, sorrow, and loneliness. Truly this is not an essential development project during State “safer at home” orders, and hearings should be postponed until our community is beyond this crisis.

But if it does proceed as planned, I am writing to learn how community members surrounding Edgewood High School will have equal access to the public hearing before the Plan Commission, anticipated May 11, 2020, regarding the development of a stadium at Edgewood (file #60001).

Many adjacent property owners and community members will participate in any hearing regarding development of a stadium. While a recent Common Council Meeting allowed limited voice participation for citizens, a black screen and lack of ability to present figures and images are not the same access as an in-person hearing. How will the surrounding community have an equal playing field to the developer to present during a pandemic? Visual images, whether human faces or presentation of data, are important aspects of our testimony.

Further, the neighborhood associations are unable to host in-person meetings for the community at this time. We have no effective way to present what Edgewood is now proposing nor to coordinate our testimony. You may not know that we have always tried to be very respectful of city staff time and ensure that we are not repetitive in what we present. It is important for the community to know what is happening and how to prepare testimony to discuss a proposed stadium that would have such a negative impact on the surrounding community.

**Subject:** Edgewood's Stadium Plans

Thanks much for taking the time to consider this comment on Edgewood College's stadium expansion plans. Considering your limited time in your service to the public, I'll try to be brief.

Considering that we live on Fox Avenue near Edgewood Avenue, about four blocks from the stadium, I have followed this story but not in great detail. I recognize that there are two sides to this story, the nuances of each I am not knowledgeable about.

Given this, my comment centers around the concept of a public resource/good. I hope that you will share my conclusion that Edgewood wants to use a public resource for its own purposes, taking it from the surrounding residential neighborhood that is almost as old as Edgewood College, both existing next to each other for a century or more. The people that would be most affected, area neighbors, would potentially have taken from them quite frequently the visual and auditory quiet that most residential neighborhoods of Madison commonly enjoy. This seems to be a public resource, shared by those in any neighborhood. An apt analogy is to the industries, municipalities, and other users of commonly-held natural resources, such as air, surface and groundwater prior to the 1970s. These users were taking these otherwise untainted resources for their own needs to get rid of their waste streams, at no cost to them but at tremendous cost to the environment and to other users of these resources, such as people needing clean air to breathe and clean water to drink. The federal government stepped in with the Clean Water Act and Clean Air Act in the early 1970s to force those polluting users to pay for that use through requirements to clean effluent, for example, before discharge.

This analogy breaks down at the point of clean-up before discharge in that Edgewood can't stop light "pollution" or sound "pollution" at its property boundaries. However, it can, or should be made to, limit the frequency of such events to the extent that all surrounding users of the resource of neighborhood quiet are not taken from them to an unreasonable extent. It seems that the City of Madison is in an analogous position to Congress and the Environmental Protection Agency in the example above.

My request as a neighbor to Edgewood and to those more impacted by its plans is that you do what you can to limit as much as possible the impact of Edgewood's stadium plans on the surrounding area. Thank you for this consideration.

Dear Alders and Members of the Plan Committee:

I write with deep concern regarding Edgewood High School's proposal to install lights on its playing field. My wife (Wendy Vardaman) and I (Thomas DuBois) have lived in our home at 2336 Monroe Street for some twenty years. Our home is just a couple of houses down from the corner of Monroe and Woodrow, and the EHS stadium field—once a living, green field, now a swath of garish, petroleum-filled outdoor carpeting—is plainly visible from our front yard and front living room and bedroom windows. In our view, EHS's plan to install lights over its field would gravely damage the quality of life in our neighborhood and home, increasing nighttime noise pollution, creating horrendous light pollution, and robbing the neighborhood of its more quiet, relaxed evening hours.

My wife and I raised three kids in our family home on Monroe Street. We raised our kids to believe that living in a green urban residential neighborhood ensures an excellent quality of life and makes a real contribution to environmental and economic sustainability for communities like Madison that want to make a difference in our resource-wasting American society. Walking or biking to work, shopping locally, and frequenting locally-run small restaurants and businesses helps create and maintain a community that does its part to respect the environment and that combats the loss of valuable rural and wild lands to human development. Raising kids on Monroe street is not all that easy: we were never really able to use or enjoy our front yard with the kids when they were little because of all the traffic, noise, and danger. But our back yard has always been a haven, where one can sit and relax outside, listen to the birds, read a book, paint a picture, or do some gardening. Regrettably, that has become harder and harder in the last several years, as EHS has ramped up its gaming activities. Now afternoons in the backyard are filled with the sounds of nasal sports announcers, raucous cheers, and the honking of horns. Letting EHS extend those activities into the evenings through granting them permission to install lights would rob my family and my neighbors of our quiet evening dinners in the backyard, our peaceful evenings, when one can hear the owls stirring, or see the bats come out for their evening activities, or just enjoy the end of a long day of work.

For cities to be sustainable, they need residents who live in and love their neighborhoods. Giving away the darkness and peace that the animals and human residents of our neighborhood cherish in order to facilitate drive-in commerce on the Edgewood campus just seems like a bad recipe. That's not what Madison is all about, and I hope the city's leadership says no to the EHS's unneighborly and unreasonable request.

Dear Ms Stouder,

Please share these concerns with the members of the Plan Commission.

I am deeply concerned that the quality of life for Madison's neighborhoods is being undermined and that legitimate concerns of neighbors are being ignored. While the City could do little to stop the locating of F-35s at Truax and save hundreds, if not thousands, of neighbors from the coming degradation of their living spaces, the City can and should protect the Monroe Street neighborhoods from the degradation proposed by Edgewood High School's request for night lighting of their stadium.

Nearby neighbors are already experiencing disruptive noise during daylight hours, and their complaints are justified. The chief problem is the very close proximity of neighboring properties to the field. Even Edgewood's own professional sound study (Legistar file #53954, attachment 9) estimates that noise levels from games with as few as 150 spectators would exceed the City's noise ordinance limits. Unfortunately, the city's noise ordinance is not written in a way that applies to stadiums.

Allowing Edgewood to have night lights will extend that disruption into the evenings, and invite even larger crowds to nighttime events. This will increase harm to those closest to the stadium while extending noise to many more households in the neighborhood. This is not just about kids playing football several nights per semester. EHS will surely seek to monetize the night-time use of this facility by renting it out to other entities for as many nights per week per year as possible. The only way to prevent the incessant degradation of the neighborhood's livability is to deny the request for night lighting. Please do so.

To the Plan Commission and Madison alders,

I am a homeowner on Terry Place and my back yard faces Edgewood High School's field. We moved to Terry Place five years ago, in large part because it is such a quiet street. Our street and Woodrow are both dead ends that culminate in natural areas surrounding a no-wake lake, which itself is largely undeveloped along its banks. This is such a rare thing in a city and so when the house we live in came on the market, we jumped at the chance to live here because of the unique peace and quiet it provides.

Though we are technically a block away from Edgewood High School's field, from our back porch we can see players on the field when they are playing games or having practice. We can also hear all amplified and much of the non-amplified noise from the field. Most of the time, this is not a significant problem, as games with amplified sound are few and far between and only tend to happen on the weekends during the days when it is not very disruptive. For the most part, the field as it is meshes well with the neighborhood.

But, the addition of lights to the field, which would almost certainly shine into our back yard, would allow many more night games to be hosted at Edgewood's field. These games with their use of lights and amplified sound would significantly impact the use of our yard in a very negative way. We regularly eat dinner as a family with our two young children on our back porch and sit around a fire into the evening enjoying the quiet and watching the stars. We worry these activities would be lost with the addition of the proposed lights.

Also, I am concerned about Edgewood's commitment to following any restrictions on the lights' use that might be put in place during a compromise arrangement. They have shown, much to my surprise, over the past year or so, that they are more than willing to go ahead with scheduling and hosting games that violate their prior agreements with the City when they see fit. I wish it were not the case, but I do not trust Edgewood to follow their word in limiting games to a certain number based on their past actions. If such a deal were to be arranged, I think there would need to be a clear accountability and enforcement mechanism put in place to deter similar future actions by the school.

Lastly, I will say that Edgewood already has a mildly negative impact on our street in that they clearly do not have sufficient parking on campus for their teachers and students. When school is session, every parking spot on our street is taken by Edgewood traffic for the entire day. Several times we have been parked into our own driveway because the street is so packed with cars. This is not a major concern, but it does show that they are already spilling over into the neighborhood and I would propose they invest in adequate infrastructure to support their current levels of use

and traffic before putting money into expanding that traffic and expecting the neighborhood just to absorb it.

Thank you for your attention to this and, again, I would urge you to vote no.

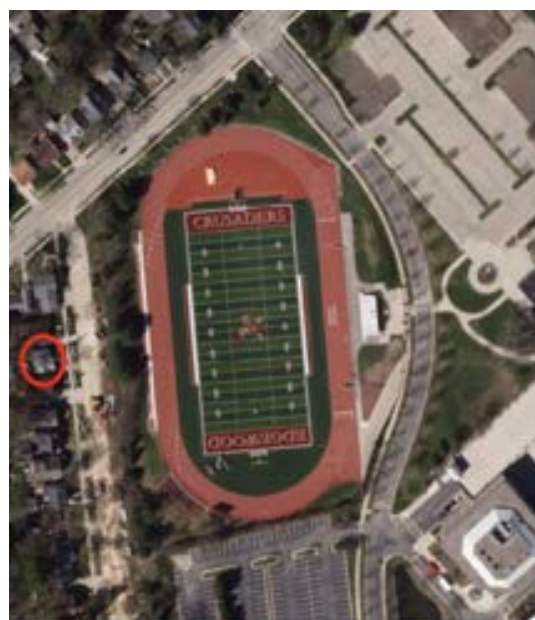

- My family has lived at 810 Woodrow Street for over 25 years and is where my husband and I have raised our two children. We are located in District 13, directly across from Edgewood's property.
- Our house, built in 1940, was well established before EHS decided to upgrade their practice field into a competitive sports facility.
- The current field does not fit gracefully in its surroundings. Rather, it dominates our neighborhood and greatly impacts all of us.

Per the **Imagine Madison Comprehensive Plan**: "SI uses...should be designed to fit gracefully within, rather than dominate their surroundings...campus development should be compatible with surrounding uses and their design characteristics, and mitigate potential impacts on adjacent areas."



The first photo shows the practice field when we moved into our house (circled in red). Not only is the current field larger but it dominates the entire area. The bleachers, located directly across from our house, can get so loud during a game that there is no escaping the noise. We cannot enjoy a meal, have a conversation or just relax without the sound of screaming fans and whistles blowing. It is well documented that during the spring and fall 2019 semesters, Edgewood hosted 77 games!

I am also a **proud Edgewood parent**. My son attended Edgewood from 3rd grade through high school. He earned his MBA from UW-Madison; is currently employed by an international company based in London, and lives in the Netherlands. I thank Edgewood for giving him the education and confidence to help him get where he is today.

Edgewood's sport's teams do not suffer. They have always played their competitive sports on fields outside the city limits, just like West High and East High. They could easily continue to do so.



The above photo was taken from my kitchen. As you can see, the grade of the field is much higher which puts us in direct shot of any and all noise coming from the field. There is also no question that we would be subjected to any lighting they install.

Per **Campus Institutional Code Ordinance** : "No application for a conditional use shall be granted by the Plan Commission unless it finds that the uses, values and enjoyment of other property in the neighborhood for purposes already established will not be substantially impaired or diminished in any foreseeable manner."

As stated before, my home was already established before EHS upgraded their field and the noise level definitely impairs and diminishes the enjoyment on my property. Having lights would just extend the games and noise throughout the evening - as well as flood my property with light. Together, I would call that "substantially impaired."

Please deny their request for lights.

To Members of the Plan Commission:

I hope you are well and safe during this challenging time. Your continuing attention to the work of city government is heartening and I, among so many others, am grateful. It is my deepest hope that the city will continue to function well with critical recognition that adapting to new realities is also essential. I am writing to implore you and other city leaders to do everything in your power to prevent Edgewood's proposal for stadium lights from being considered during this critical Covid19 period of quarantine, seclusion, sheltering at home, awaiting testing, fearing exposure, caring for others, and enduring a first ever pandemic. I'm hoping you will find the ways to freeze-frame the #6001 proposal. It is not urgent at this time of other unprecedented urgencies .

I am a 38 year resident of the Dudgeon-Monroe community. I live 300 feet from Edgewood's playing field. I am a member of the No New Stadium Steering Committee and eldest in an extended family also living in our neighborhood. We are, as we all should be, focused on the well being of our family and on all those we can help within our community. No one has been able to credibly describe how we all will come out of this crisis but many are envisioning a kinder, more caring world. To be blunt, Edgewood's proposal with all that it implies, would be a nightmare at the end of the tunnel. We count on our city government to support understanding of and respect for those of us who have worked tirelessly to research and verify reasons for our opposition. The value of public input is stressed as core to your decisions. Addressing the CU application at a time when we can participate fully is extremely important.

If you will, please take the few minutes to review the following .

1. Please read the statement recently released by the Dudgeon-Monroe Neighborhood Association (attached). Those of us in the grassroots, research-based NNS group have been extremely pleased by the strength of the DMNA position. It is clear, powerful and informative. And, the core message describing the mistrust of Edgewood's intentions is clear and verified and provides a strong argument for denying their current petition.

2. And, please take 4 minutes to watch the video linked below. The city of Clairemont, California provides a cautionary tale for all of us. We don't have to *imagine* what a stadium in a residential neighborhood would do to a community. It is *documented* in the video. Subsequent media in follow-up searches indicates an emerging trend to exploit school sports facilities by creating entertainment complexes that are far beyond "letting the kids play ball."

I believe Madison will, as we often have, go against the trend. But it is up to all of us to "Imagine Madison" in the best possible ways.

More than a year ago, I interviewed a resident in the Clairemont community who said their neighborhood now looks like "the town dump." I'm sure you can imagine what it would mean to our city to have our beautiful area - Lake Wingra, the parks, the ecology, trails, our homes - subject to a sports entertainment complex with unabated noise, lighting, crowds, traffic, and other disruptions, for unlimited events as proposed by Edgewood. Once done, it could never be undone.

## **Dudgeon Monroe Neighborhood Association opposition to the addition of lights to the field at Edgewood High School – April 1<sup>st</sup> 2020**

### **DMNA's recent relations with Edgewood**

During the City Council meeting when the Edgewood Master Plan was repealed, the Mayor urged the two parties to come together and compromise. I think it's important to give some context on what DMNA has tried to do to compromise with Edgewood, and how that informs our opposition now.

For many years, discussions between Edgewood and neighbors have occurred through the long-standing Edgewood/Neighborhood Liaison Committee, which brings together all three Edgewood entities, Vilas Neighborhood Association, DMNA, and the District 13 Alder. Repeatedly in the past year or so, Edgewood has refused to talk about the athletic field during liaison committee meetings, or has said they have no updates regarding the field, only days before revealing a major update to the city. Recently, without explanation, Edgewood stopped inviting Alder Evers to liaison committee meetings.

Early in 2019, the two neighborhood associations and Edgewood decided to form a collaborative working group to facilitate dialogue about the athletic field, with the goal of finding a way forward that could best serve the interests of all parties. At the start, Edgewood refused DMNA's requests to include the alder. Halfway through the twelve-week timeframe, Edgewood abruptly withdrew after agreeing to ground rules stating precisely that neither party would walk away before we concluded. Edgewood claimed to be withdrawing in order to prepare a modified proposal for our associations' review, but Edgewood never followed up.

These actions occurred on the heels of an abrupt change regarding the athletic field. After years of referring to it as a "practice field" in liaison meetings, in the Campus Master Plan, and in the press, shortly after the resurfacing of the field Edgewood vastly increased use of the field not only for practice, but also for competition. Prior to resurfacing of the field, fewer than 10 games per year were played on a field that was primarily used for practice. During the Spring and Fall 2019 semesters alone, without lights, Edgewood hosted 77 games. To date, Edgewood has yet to acknowledge that their use of the field has any adverse impacts on neighbors, despite numerous and increasing complaints to the school and the past three alders.

Edgewood High School has repeatedly stated that they have been a good neighbor, or were continuing to work with neighbors, or have sought compromise. From our perspective, Edgewood's assertions are not only false but deliberately so. Edgewood has been attempting to steamroll neighbors and has used the institution's resources and influence to bolster their false narrative in ways that adjacent neighbors or a neighborhood association could not hope to match. Edgewood has tried to convince everyone that the school is somehow a victim of neighbors' intransigence, when in reality the school has only engaged us briefly since the field surface was upgraded, and then unilaterally withdrew from that engagement.

### **Noise, and why it leads us to oppose lights**

Nearby neighbors are already experiencing disruptive noise during daylight hours, and their complaints are justified. The chief problem is the very close proximity of neighboring properties to the field. *Even Edgewood's own professional sound study* (Legistar file #53954, attachment 9) *estimates that noise levels from games with as few as 150 spectators would exceed the City's noise ordinance limits.* Unfortunately, the city's noise ordinance is not written in a way that applies to stadiums. This is why Edgewood has been able to claim that noise levels will comply

with City regulations. But that oversight in the noise ordinance does nothing to mitigate the decibel levels that seriously impact the use, value, and enjoyment of adjacent properties. Allowing Edgewood to have lights will extend that disruption into the evening, and invite even larger crowds to nighttime events. This will increase harm to those closest to the stadium while extending noise to many more households in our neighborhood.

### **No protections if lights are granted**

We have also talked to the City of Madison about what enforcement mechanisms are in place if we agree to certain limitations with Edgewood, and then Edgewood does not comply. In addition to no protections offered by the noise ordinance, the City also has told neighbors that no matter how loud or frequent usage gets, it is unlikely any action will be taken under the City's disturbing the peace ordinance, because responding police officers will consider all noise related to a sporting event reasonable for an athletic field. Beyond noise, City staff have indicated that they have no enforcement mechanism to stop Edgewood from playing more games than agreed upon, or when games are played, or to restrict use of the field to only Edgewood or other specific organizations, or to restrict the rental of the field to others. We have every reason to believe that Edgewood wishes to maximize use of its property.

We believe that neighboring property owners have every right to use their property as well. Last year, the City did not penalize or restrict Edgewood from playing games despite a zoning violation, even after the Zoning Board of Appeals affirmed the City's zoning interpretation. It appears that denying Edgewood lights is the only reasonable way to ensure that neighbors' ability to use and enjoy their homes will not be further diminished by use of the field.

DMNA has found itself in a position where the negotiating partner does not follow their own rules, and the City has no way to enforce the rules. In this case, we can only reiterate that adding lights to Edgewood's field would damage the livability of the homes near the field, by extending the hours of use, inviting even larger crowds, and increasing the disruptiveness of competitive games.

### **A troubling policy precedent**

Edgewood has threatened to re-establish their lawsuit against the City if they don't get their way tonight. We are also concerned with the precedent that this sets. Recently, several large organizations – whether Taco Bell Cantina, Amazon, Silk Exotic or Edgewood – have determined that threatening the City with legal action is the best way to get what they want, regardless of what the City or local neighborhood thinks. The City has said repeatedly that it values neighborhood input and prioritizes the livability of neighborhoods, but when an organization with deep pockets can extend its lawsuit indefinitely, that seems to take priority. We hope that other entities don't realize that a lawsuit is an easier way of getting what they want than a real discussion and a democratic vote.

For these reasons, we strongly urge the Plan Commission to deny this permit.

Dear Heather Stouder and members of Madison's Plan Commission:

I write as a long-term resident of the Vilas neighborhood to register in the strongest possible terms my opposition to Edgewood High School's request for eighty-foot tall lights so that they may play and host night games. Please vote no.

My home lies in the 2000 block of Jefferson Street, only a few blocks from the Edgewood campus. This is a tremendously desirable, gracious neighborhood of older homes. It is so desirable because while in the heart of Madison--close to the UW campus, to excellent public schools, and to the Monroe Street shopping area--it maintains a quality of almost rural peacefulness. Edgewood's plans threaten to destroy what makes this neighborhood, currently one of Madison's jewels, so special. The Monroe Street shopping area, one of just a handful of streets in Madison that maintains its vitality as a tasteful commercial area, will, if Edgewood gets what it wants, lose its particular charm.

My home is both the center of my life's pleasures and my nest egg. The quality of life here is threatened by Edgewood High School's proposal to have a stadium or stadium-like features such as tall lights. The night games these lights would enable would add significant noise and traffic as well as light pollution, all of which would ruin evenings currently enjoyed in the neighborhood's yards, gardens, and patios. Our lives are already disrupted by the increasing number of games played at Edgewood in recent years, but the proposed developments would bring in significantly more traffic in addition to producing nighttime noise and glare. That glare would disrupt the migration patterns of the many birds that use the area around the Arboretum and Lake Wingra, as well as the lives of the humans like myself living nearby. If Edgewood's development plan goes forward, assessed values of homes like mine are likely to plummet, affecting Madison's tax base.

It makes no sense to develop a new stadium or stadium-features like these tall lights in a densely populated urban area. Such developments only increase traffic congestion, crowd local parking, and negatively impact residents' quality of life. Appropriately, West High School, where my own children were educated, has no stadium or 80' lights on their campus—and West High serves many more children from the neighborhood than Edgewood High School does.

I understand that both Madison's master plan and the Monroe Street commercial plan specify

that the impact on neighborhood viability must be taken into account when considering a development request such as this one. There is no question but that the vitality of this special neighborhood will be compromised if Edgewood is allowed to go forward.

Edgewood has powerful lawyers and is spending lots of money to get this through. I beg you to listen instead to the people who live in the surrounding Vilas and Dudgeon-Monroe neighborhoods and who, in resisting Edgewood High School's development proposals, are speaking out for the good of this area and of the city as a whole. The neighborhoods surrounding Edgewood have resisted lights and stadium plans for decades, but Edgewood now is ignoring us. I ask you please to listen to our voices and grant to our well-being the importance it deserves. Please vote no.

I am extremely concerned about Edgewood's request to install lights on its field. If Edgewood installs lights, it will use the field all of the time with amplified sound much of the time. The field is simply too close to homes and Lake Wingra for this kind of disruption.

For me personally, the idea of trying to put my 2 year old and 7 year old to bed during evening games with lights and sound is beyond stressful. I have no problem with a reasonable number of events taking place during the day but the evening is a time for rest and quiet. Even just lights for practices, without sound, seems totally inappropriate due to the light pollution and the proximity of homes and Lake Wingra. This is a residential neighborhood and for this reason other neighborhood schools like West High don't have the facilities Edgewood wants to build.

If Edgewood's proposal were just for a 5-6 home football games, as many appear to think it is, and Edgewood could be trusted to stick to that commitment, that might be a different matter. Our family could certainly accept rare special events like that. But Edgewood's intended use is much, much more far-reaching and would have much deeper consequences for local families. It is therefore totally inappropriate for the community. Moreover, the disingenuous way that Edgewood has conducted itself during this process - now even pushing this matter during a global pandemic when many local residents are too stressed to fight back - indicates that Edgewood cannot be trusted to stick to any promises.

In short, Edgewood is seizing a public good (darkness and quiet) and destroying it for its own private use and financial gain. Please: I am begging you to stop them from doing this. I hope that you will put an end to this inappropriate request and vote no.

Dear Director Stouder, Members of the Planning Commission, Mayor Rhodes-Conway, and Alder Evers,

I am a resident of the Vilas neighborhood, and I am writing to ask you to oppose the conditional use permit application by Edgewood High School. I will make three points in this letter: (1) the lights will substantially diminish the enjoyment of other property in the area; (2) this stadium is unique compared to the locations of other high school stadiums in Madison; and (3) Edgewood's actions regarding the stadium demonstrate its administration cannot be trusted to comply with rules or respond to complaints, and the city will not take actions to enforce its rules.

First, I live on Garfield Street, and I frequently enjoy Vilas Park and the Park and Pleasure Drive. I hope that my home is far enough away from Edgewood to not be directly affected by the lights in my home (though, based on the experiences of neighbors of stadiums with similar lights in other parts of the country, sky glow may be a problem), but the park and the Park and Pleasure Drive absolutely will be. Having lights installed in Edgewood's stadium will substantially reduce the enjoyment of at least parts of Vilas Park and the Park and Pleasure Drive as it will be affected by lighting and noise from night games. In addition, I believe that allowing Edgewood to install lights at their stadium will be excessively disruptive to the community around Edgewood and significantly and negatively affect the quality of life of my neighbors—particularly those whose properties are across the street from the stadium and in the neighboring blocks.

Second, I have explored the neighborhoods that surround existing high school stadiums that have lights in Madison—those by Memorial High School and by LaFollette High School. Neither of these neighborhoods resemble that of Vilas or Dungeon Monroe. Memorial has very few residences near the stadium—most of the stadium is surrounded by Memorial, a middle school, and a multi-lane road. The LaFollette stadium is surrounded by both the school and a golf course. These stadiums are located at a greater distance from residences; the layout of the stadiums at these high schools that have lighted stadiums do not resemble the layout at Edgewood. Edgewood is uniquely located close to residences.

Third, Edgewood has, since at least 2015, been deceptive about its intentions regarding the stadium. At the time of the refurbishment of the field, Edgewood president Mike Elliot stated in a newspaper article that there would not be lights or sound at the field. However, the refurbishment of the field included laying the wiring for lights and sound installation. Edgewood also declared that it had to play home games at its field because Middleton had ended the contract that allowed Edgewood to play on Middleton's fields. This was not accurate; Edgewood was the party that ended the contract. These dishonest statements turned into actions by Edgewood that violate city ordinances—playing over 70 games last season despite city officials informing Edgewood that it was in violation of its zoning. It is clear from this history, that Edgewood has little regard for honesty or complying with city rules when it comes to the stadium. Compounding this troubling history, is the City of Madison's unwillingness or inability to stop Edgewood from violating its prior zoning requirements. If there are complaints about the lights or noise from night

games, its prior behavior leads me to believe that Edgewood will not care. Further, and even more troubling, the City of Madison will be unable or unwilling to act to protect its residents. This would be a frankly horrible precedent for Madison.

I appreciate your attention to my letter, and I again urge you to reject the conditional use permit application by Edgewood High School.

Attached is a letter to the Plan Commission dated October 31, 2018 and signed by 174 residents, opposing Edgewood's request at the time to amend its Master Plan to allow for 80ft high pole-mounted night lighting and amplified sound on its athletic field. As one of the signatories, I submit this to you in opposition to Edgewood's latest request for conditional use approval to install lights on its athletic field. This letter reinforces that our neighborhood's opposition to Edgewood's pursuit of an ever-expanding number of games—including night events with lights and amplified sound—has been strong, well-reasoned, consistent and shared by a broad number of residents.

Our 2018 letter remains relevant to Edgewood's current Conditional Use Permit application. While the Master Plan amendment process and the conditional use process have some differences, there are fundamental similarities. Each process requires the Plan Commission to consider whether the proposed use is consistent with the City's Comprehensive Plan and any adopted neighborhood plans. Each process requires consideration of negative impacts on surrounding neighborhoods. Each process is informed by the understanding that property development should not come at the expense of livable urban residential communities.

Use of the field has expanded enormously since 2015. Day games, practices, and tournaments on the athletic field in 2017 and 2018 interfered with residents' use of adjacent properties, due to nuisance noise levels that are well-documented, even at the current maximum seating of 450. Edgewood's bald assertion that "the Field Lighting will not create additional noise" conveniently ignores the fact that night lighting will mean field noise will continue long into the night hours, *when currently (and historically) there is and has been no noise from the field after dark.*

Light pollution and noise pollution from the athletic field go hand in hand. Both interfere with the adjacent community's livability, as well as the surrounding nocturnal ecosystem. Installing lights on Edgewood athletic field will permanently change this neighborhood for the worse. I urge you to protect citizens from this harmful development and vote no on the Conditional Use Permit. Such a major modification should not be approved because, under sec. 28.183(6)(a)3., MGO, the "uses, values and enjoyment of other property in the neighborhood for



purposes already established” *will* “be substantially impaired or diminished” in a very foreseeable manner.

Dear Chairman Opin:

We are a grassroots group of concerned citizens that formed after the public meeting held at Edgewood High School on October 17, 2018. We strongly oppose Edgewood's recently unveiled plan to turn its new athletic field into a stadium with 1,200 seats, 80-foot high-mount night lighting and an amplified sound system. We respectfully request that you circulate this letter to the members of the Plan Commission prior to the November 5, 2018 meeting.

Under the existing Campus Master Plan, approved in 2015, Edgewood built a \$1.5 million outdoor athletic field. At that time, the neighborhood was led to believe the field would be used for practices only, and would not include lights or a sound system. Edgewood High School president Mike Elliott declared in the Wisconsin State Journal (6/15/2015), that neighborhood associations have been "opposed to us having lights or playing games here. We're ... building this to be able to give our athletes the practice facilities that provide the best surfaces possible." Three years later, Edgewood has changed course and now plans to add a stadium to the practice field. They propose to host night events for football, soccer, lacrosse, track and field, and numerous other unlit sporting events during the day and early evening that would use amplified sound. This is a significant change in use of a significant part of their campus, which will have a significant impact on the neighborhood.

A Dudgeon Monroe Neighborhood Association survey in April 2017 showed two-thirds of respondents were opposed. Recently, David Hoffert, president of DMNA, stated that since the

2017 survey, “the rough breakdown of two-thirds opposed and one-third in support has [not] significantly changed” (Capital Times, 10/16/18).

Edgewood claims that neighbors would be largely unaffected because it has a technological fix for the livability problems of bright lights and noise pollution. We believe these claims are unproven. For example, data gathered by Ethan Brodsky, a Dudgeon-Monroe resident who has a PhD in Electrical & Computer Engineering, at a Waunakee High School football game, call into question the low decibel figures and mitigated light-spill claimed by Edgewood’s vendor. However good the technology, if this stadium is built, there will be additional noise, light and traffic, and increased use over time.

The Campus Institutional Zoning District ordinance Statement of Purpose (sec. 28.097 (1)(c), MGO), says that Campus Master Plans should “balance the ability of major institutions to change ... with the need to protect the livability and vitality of adjacent neighborhoods.” There are two criteria listed in the CI Zoning Standards for Master Plan Approval by the Common Council (sec. 29.097 (6)(a) & (b), MGO). The first is that “the Plan shall serve the public interest as well as the interest of the institution developing the plan.” The public interest in reasonable peace and quiet currently cherished by nearby residents would not be served by a continuous series of events punctuated by a play-by-play announcer, pep bands, and crowd noise. This would profoundly change the neighborhood’s essential fabric as a quiet, friendly residential community. The impact to the adjacent neighborhoods will be decidedly negative, with spillover effects on recreational use of Lake Wingra, traffic issues on Monroe Street and neighboring streets, and a tragic breach in relations between Edgewood and its neighbors.

The second CI zoning criterion is “the Plan shall be consistent with the goals of the Comprehensive Plan and adopted neighborhood, corridor or special area plans adjacent to campus boundaries.” The Edgewood proposal is inconsistent with the Monroe Street Commercial District Plan, adopted by the City on March 3, 2007. One of the stated Commercial District Plan goals is “to preserve and enhance the residential character of the neighborhood around the commercial districts” (p.9). With respect to Edgewood specifically, the Plan states that “Edgewood . . . is an important presence on Monroe Street. . . . [It] will be critical for any

future plan to carefully coordinate with surrounding neighborhood and land uses to avoid any negative impacts” (p.43).

Moreover, to the extent that a Conditional Use Permit may be required, such a major amendment could not be approved under sec. 28.183(6)(a)3., MGO, because the “uses, values and enjoyment of other property in the neighborhood for purposes already established” will “be substantially impaired or diminished” in a very foreseeable manner. Even if not directly applicable, this standard provides helpful guidance as to what is in the public interest as related to substantial alterations of a CI zoning district Master Plan.

When Edgewood’s request to amend its Campus Master Plan in order to build this stadium comes before the Plan Commission, we will be asking the commission to hold Edgewood to current standards (both those we have referenced and others), reject the request, and protect the adjacent residential neighborhoods.

As stated in the city’s Comprehensive Plan, “Neighborhoods are the basic building block of the city” (p. 46). We have provided this early communication to let you know how strongly we feel about this, and how committed we are to protecting the quality of life of our community.

### To the Plan Commission

For twenty years I lived on Woodrow Street directly across from the Edgewood High School field. I therefore have a lot of first-hand experience of the past field use, the traffic problems, the neighborhood ambiance and the general public use of the area for recreation. I had already concluded that I didn't want to live across from a stadium should Edgewood succeed in getting their lights and sound system, especially as they propose using such a facility with no limits. When an ideal apartment in the same neighborhood became available, I sold my house and moved.

Like most neighbors, I had generally supported Edgewood. But the stadium, if built, will ruin this quality neighborhood. First, the lights and sound will disrupt the current peace and quiet, and any suggestion that the sound will be minimal is ludicrous. When games are being played now, with or without spectators, and without amplified sound, they can be heard up and down the street. When Edgewood College held an outdoor event last fall with amplified sound, I could hear it clearly in my new apartment three blocks away. Eighty foot lights will cast a glow that will require neighbors to draw shades. Parking on Woodrow Street is almost impossible when the Edgewood campuses are in session during the day despite their attempts to mitigate the problem. As it is an historic neighborhood with minimal driveway and garage space, holding numerous evening events will extend this problem into the night so that working residents with more than one car, as well as evening visitors, will have no place to park.

Finally, this field is located on a block adjacent to one of Madison's gems, Lake Wingra. It's Madison's only undeveloped lake with the surrounding natural areas of the Park and Pleasure Drive next to the Edgewood campuses and the Arboretum across the lake. I have walked the Park and Pleasure Drive at least three times a week for years as well as watched, from my house, the hundreds (thousands?) of others who walk, with and without dogs, birdwatch, jog or bike this route. It is quiet and beautiful now. However, I lived in the area when through traffic was still allowed, and remember the beer cans and other trash littering the road. It was a favorite haunt of youthful experimentation and I would guess has that potential again if the

stadium is built.

As a birdwatcher and conservationist, I am concerned about the disruption to bird, (especially at migration time) and animal life by the night lights. And as I kayaker who uses Lake Wingra in the evenings, I am concern by amplified sound which carries so well over water.

The neighborhoods and natural areas surrounding Edgewood are very desirable for many reasons. It will be a cause for great sadness if these qualities are lost to Edgewood's determination to build this stadium for their own gain. The fight over this stadium has been going on for years with the neighborhoods always objecting for the very good reasons of protecting their homes, quality of life and safety. Good sense has always prevailed in the end. Edgewood High School has been particularly unethical in this round of the battle using misleading PR and threats to the city. Please do not let intimidation, especially in this disruptive time of pandemic, win.

# Answers to frequently asked questions regarding the proposed changes to the Edgewood Campus Master Plan

## Why is Edgewood High School seeking changes to its Campus Master Plan?

Edgewood High School has a nearly 100-year history of using its athletic facilities for practice purposes, hosting day-time sporting events and allowing access to the community for game and recreational purposes. The Goodman Athletic Complex has deeply enriched our ability to serve as a community-wide asset for the greater Madison area. When the Edgewood Campus Master Plan was originally developed and approved in 2014, Edgewood leadership was up front about the continued desire to have the ability to have a true home field that could enrich our athletic program by hosting night games as required by the Badger Athletic Conference, but were very sensitive about how a limited number of night games may impact our surrounding neighborhoods.

Two major factors prompted us to begin the formal amendment process over a year and a half ago, as outlined in our Campus Master Plan:

1. Our primary agreement with Middleton to serve as a "home" field is no longer feasible. This is due not only to Middleton's own athletic program demands, but financial ramifications, safety concerns and scheduling for Edgewood's athletes. This fact has left Edgewood scrambling to find a location for "home" games, often ending up with multiple locations for our games — a scenario that few other schools have to address.
2. Advancements in both lighting and sound technology have made it possible to ensure that two of the major neighborhood concerns we acknowledged early in the Campus Master Plan process — light and sound — could now be addressed in a fashion that not only meets, but exceeds the City of Madison requirements.



As with our efforts during the original Campus Master Plan process, Edgewood High School remains committed to engaging with our neighbors and community partners as we follow the deliberative amendment process outlined in the 2014 Master Plan.

## Does the Campus Master Plan allow for amendments?

As with other City of Madison-approved Master Plans, the Edgewood Campus plan specifically details the City-required process for making amendments to the plan. Edgewood High School has spent the last year and a half following this process by engaging city officials, local neighborhood associations and our neighbors to ensure that the amendments we are seeking address neighborhood issues and meet or exceed City of Madison requirements.

## Who ensures agreed-upon amendments are enforced?

The amendment that Edgewood High School is seeking to enrich the Goodman Athletic Complex will include very specific requirements related to such things as the number of allowable night games, the specific times that lights are allowable and the fact that the Complex *will not* be available for other nighttime events. Edgewood is committed to adhering to these parameters and all of the agreed-upon restrictions will be fully enforceable by the City of Madison.

## Wasn't the original intent of the Goodman Athletic Complex to be for use as a practice field only?

As mentioned previously, Edgewood High School has a decades-long history of using its athletic facilities not only for practice purposes, but actually hosting day-time sporting events and allowing access to the community for recreational purposes. The proposed amendments to our Master Plan do not change the intended usage of the Goodman Athletic Complex, but rather take advantage of new technologies that will allow for a limited number of night games and afford Edgewood the ability to host home events for all of its teams.

## What, if any, concerns have been raised by neighbors and how is Edgewood responding to those concerns?

As part of the Campus Master Plan amendment process and our commitment to positive neighborhood relations, Edgewood High School hosted neighborhood listening sessions to share our ideas and gather feedback from area residents. Those sessions helped identify the following areas that we have specifically addressed as we move through the process:

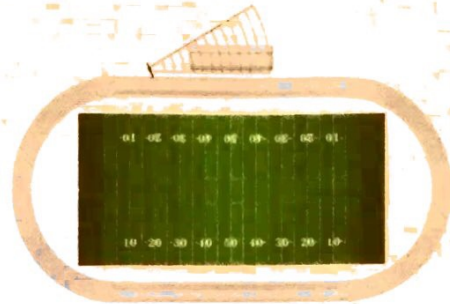
1. **Lighting:** The amended plan includes the incorporation of the latest LED lighting technology that will minimize glow, light spill and glare. This new technology, along with the height of the poles in our plans, will ensure that lighting from the limited number of night games will not go beyond our property. The plan meets and even exceeds the City lighting requirements.

2. **Sound:** The amended plan also includes a directional amplified sound system that is custom-designed for the site and meets all City sound requirements. The sound system will only be used during games and we have agreed to prohibit music being played over the PA system, with the exception of the national anthem. Edgewood High School continues to work with sound engineers to model natural sound and identify the best approaches for managing sound.



3. **Traffic:** Based on the study that was conducted as part of the Master Plan process, engineers concluded that traffic for the anticipated crowd size for the Athletic Complex would not increase and, in fact, could potentially decrease traffic during peak times due to the scheduling of events during non-peak travel hours. The Monroe St. entrance is to be used for all events.
4. **Parking:** The Edgewood campus currently has 560 parking stalls, a number that could accommodate even the largest anticipated crowd size so there should not be an increased parking impact on neighborhood streets. Visitors attending athletic events will be provided on-site parking information and discouraged from parking in the neighborhood.

Many more detailed conditions are being developed and specified for each of the key components. Stay tuned for more answers to frequently asked questions in upcoming editions of our neighborhood newsletters related to our plans for enriching the Goodman Athletic Complex.

Bottom Line Upfront (BLUF): The only purpose of this proposed legislation is to create another loophole for Edgewood and its lawyers to exploit against our city. To understand why I feel this way, please see the references accompanying this letter. It is sad for me to say, but the dishonest nature of Edgewood has eroded community trust in this organization.

City Council needs to fully appreciate the ramifications of their vote on Edgewood's request to be released from the Edgewood Campus Master Plan. From what I have seen, the catalyst for all of this is the Stadium Edgewood has been trying to force on its neighbors. City Council needs to see firsthand where Edgewood put the athletic field to gain a full appreciation of what will happen if city council decides to vote to release Edgewood from the Edgewood Campus Master Plan. All that was agreed to in this substantial document would be nullified if the Campus Master Plan was removed.

Edgewood and the surrounding communities have both benefitted from having a Master plan in place. Edgewood has been able accomplish projects and the neighborhoods have benefited from knowing what to expect and consideration for how things would be done to protect the neighborhoods. Edgewood is in effect saying I got what I need now let me out of the agreement without consideration to other stakeholder, like the city and the neighborhoods. Legislating a special exemption to benefit only one party is not a precedent to set. There is a process for Edgewood to move forward with changes today. It is to amend the Edgewood Campus Master plan.

Edgewood withdrew from this option and instead decide to first have the zoning administrator interpret the language of the master plan citing that was not was not was meant by the language in the document. When that plan failed they then appealed to the zoning board. The Zoning Board of Appeals voted 4-0 against Edgewood and to uphold what was in the master plan. When Edgewood again did not get what they wanted they petitioned the administration to introduce legislation to allow the Master plan to be withdrawn. Then they then sued the city in federal court. After the Mayor withdrew her support, they petitioned another Alder to carry their request forward.

You must decide if you want to create an opportunity for Edgewood to further exploit the city and its neighbors. Please vote in opposition of allowing Edgewood to exit the Edgewood Campus Master plan. Please ask yourselves: What if this was my neighborhood and my neighbors? Do you support the private nonprofit corporation and its transient stakeholders, or the citizens of Madison you represent? I encourage you to listen to what the different neighborhood associations have said regarding the impact. There would be harm to the public

and neighborhoods if Edgewood is allowed to create this loophole through your legislation to be further exploited.

Please vote against repealing the Campus Master Plan for Edgewood and encourage Edgewood to return to the master plan amendment process. Thank you for your support.

Edgewood is a private non-profit tuition-based school campus that resides in the Dungeon Monroe neighborhood ([www.dmna.org](http://www.dmna.org)). I attended multiple meetings for the proposed Edgewood Stadium with my neighbors and Edgewood. Edgewood wants to have a permanent stadium playing field immediately adjacent to its neighbors on Woodrow and Monroe Streets in Madison. You must see the “practice field” location to truly appreciate what they are proposing to visualize the effect a permanent stadium will have on the Dudgeon Monroe neighborhood.

Personally, I believe you should be able to do whatever you want to do on your own property as long as it is not to the detriment of your neighbors. For example, I may want to divert rain water away from my house to prevent flooding in my basement, but I should not be able to divert my rainwater downspouts to my neighbor’s house and routinely flood their basement. Edgewood is proposing to do something very similar to the analogy above. My concerns about crowd noise, lighting and parking are below.

I have heard everything from the stadium will only be used for the High School Football team for a few games at night; to it will be used for 40 night games for various events; to it would be a great asset for the neighborhood and benefits many other organizations in Madison. I have a hard time believing that this stadium is only going to be used by the Edgewood High School which is why in the past I have asked the question concerning the number of events projected. Edgewood is going to want to maximize the return on the investment of this privately held asset.

I am very concerned about crowd noise. If we get lost in the technical solution provided in the presentation, it is easy to lose sight of the human impact (e.g. a crowd cheering for their team). It can be a vicious cycle of cheers of joy supporting your team when you are winning or being the “twelfth man” trying to prevent from your opponent’s team from being able to communicate. The average volume provided in the presentation (average over duration) is not a good representation of what my neighbors are going to experience from peak noise levels. If this is allowed to move forward, crowd noise is not enforceable, and the community residents will have to live with noise. This will have serious effects on my neighbors to the point I fear we will not be able to enjoy our residential properties, so this private, tuition-based institution can have a stadium in our neighborhood. We should be allowed to make enhancements to our properties, but not when they are to the detriment of our neighbors.

Personally, I do not want to see this neighborhood change. We chose this neighborhood because we recognized it was special. We do not want the noise and light pollution and other challenges the stadium is going to bring. Edgewood’s presentation was for 30 fc based on what they received from the group trying to sell them the solution. We saw members of the sales team once, and they were more Account Executives than engineers who would or could honestly answer questions when challenged on what was presented. Edgewood’s presentation was modeled for 30 fc of lighting.

I am disappointed there was not verification of the study provided to Edgewood to certify the results and assumptions made by the sales team trying to make the sale. The sales team is selling a solution and will assure Edgewood it will work for their application. Edgewood will implement the solution, and when it does not work as projected. Edgewood will request

additional changes that will invalidate what Edgewood presents to you and will continue to negatively impact its neighbors. For example, Edgewood will cite something like student athlete safety requiring the light illumination level to be raised to a higher value (50 fc is the NCAA recommendation). I do not want to see anyone get hurt due to poor lighting on the field because Edgewood decided to believe what is was presented.

I am also concerned about parking based what is proposed. Edgewood would like us to believe parking will not be a problem because they have sufficient parking stalls based on their estimates, but once people who are not local to the Dudgeon Monroe community figure out that it is faster for them to park in our neighborhood and walk to the stadium, they will park in our neighborhood, and they will walk to avoid parking on Edgewood campus and the associated traffic issues to them when they try to either get to a game or leave from a game. There is a reason we have 2-hour enforceable parking limits without a residential permit during the day on our streets near Edgewood's campus.


Finally, a point was made concerning what happens to property values if this moves forward. We have something special here today. Once it is gone, it is gone forever and there is no turning back. I firmly believe if this change is allowed to move forward what makes our neighborhood special will be gone. As a result, I believe property values will decline because of the negative effects presented, noise, parking, lighting, etc. The neighborhood will become a less sought location for families and the result is property values will decline. Who is left to absorb the financial impact when the revenue generating property taxes for the Dungeon Monroe neighborhood public school drop?

It would be financially irresponsible for Edgewood to invest additional funds to the existing "practice field" to see what the impact would be to neighborhood. Based on what the existing practice field looks like today they may have already been financially irresponsible, or maybe they always had the intention to have a permanent stadium in Dungeon Monroe even though this was not what was presented in its 10-year plan. Perhaps this was always the plan despite the damage Edgewood would cause to their neighbors. It is impossible for me to know what is in the hearts and minds of the people behind Edgewood, but it does not feel like they are living to up to their values.

Based on past their past performance with promises made (e.g. practice field used for games), Edgewood cannot be trusted to implement a solution that will not create problems for its neighbors. There are other places not in this peaceful, treasured, densely populated residential community where this private tuition-based institution can have a sports facility that would not be immediately adjacent to a dense residential community. We have something special here. Once it is gone, it is gone forever. Please vote no on the Edgewood stadium proposal.

I am disappointed I will not be able to attend the planning commission meeting personally. I will be out of state due to military commitments.

Edgewood wants to have a lighting installed to extend use of its athletic field immediately adjacent to its neighbors on Woodrow and Monroe Streets in Madison. You must see the field location to truly appreciate and visualize what stadium lights will do to the Dudgeon Monroe neighborhood. Exhibit A in their application shows a top view of the outdoor athletic field placement, but you really have to see the land first hand to appreciate what is being asked, and why it is so detrimental to the neighborhood. Please vote to deny Edgewood's light application permit.

Having an outdoor athletic field adjacent and within 300 feet of over 20 residential properties is incompatible to the health and safety of not only residence immediately across from the athletic field on Monroe and Woodrow streets, but also for the larger surrounding neighborhood. I live about 2 blocks away from the field. I could hear the illegally hosted events last year from inside my house while the field was still governed by the Edgewood Master Plan. I could also hear the repetitive blowing of whistles from the athletic field during practices and games.

I am very concerned about crowd noise. It is easy to lose sight of the human impact a crowd cheering for their team, or making noise to limit their opponent's team ability to communicate. It can be a vicious cycle of cheers of joy supporting your team or being the "twelfth man" in opposition trying to prevent the visiting team's ability to communicate. The safety and welfare of the neighborhood residents is at stake because the neighborhood is no longer protected since the city has released Edgewood from the master plan allowing it to turn its practice field into a competitive athletic complex that will not be enforced by Madison's residential noise ordinances.

Edgewood has not negotiated in good faith with its neighbors, the Dudgeon Monroe neighborhood association, or the city. Edgewood abandoned its master plan, it abandoned discussions with the neighborhood association, and it filed a frivolous lawsuit to bully its way to get what it wanted against the city and advance its desires to host games. I do not listen to what people say; I watch what they do. I am watching. I am interested to see what the city values more: the desires of a private institution with

transient stakeholders and a legal team, or the actual neighborhood residents that have voiced their concerns about their health and safety time and time again as a community.

My position is quite simple the noise that will be produced from the athletic field that was foolishly placed across the street from not one, but two densely populated residential streets is incompatible with the health and safety of the surrounding Dudgeon Monroe residential neighborhood and the peaceful enjoyment of personal property - see DMNA opposition letter to the addition of lights to the field at Edgewood High School. In my opinion having a source of noise adjacent to residential property that is not regulated is irresponsible. **To have that noise generation extend to more hours in a day facilitated by lights is reckless.**

Ultimately, I would like to see the Campus Institution zoning amended to protect the residents of my neighborhood and other city residents to include language that any Campus Institution zoned outdoor athletic field that is within 300 feet of 10 residential properties be limited to 10 events per calendar year (as measured from the closest point of a residential property to the closest point of the athletic field). I would also be clear in my definition of what 10 means (for example 2 boys' soccer games, 2 girls' soccer games, 2 track competitions, 3 football games and 1 graduation commencement equals 10 events). The institutions can host whatever events they want, but the total number of events cannot exceed 10 for an outdoor athletic field that is within 300 feet of 10 residential properties.

I heard and understand we need to follow our laws, but what do you do if the laws are flawed and loopholes are exposed? Based on the flawed language used in the Campus Institution zoning that was interpreted to mean voluntary in allows voluntary out in regards to Master Plans perhaps we would be better off removing Campus Institution zoning and rolling back to the zoning that was in place previously. Alternatively, something like my proposed solution in the paragraph above could be applied as an amendment to protect the residents of the city by **limiting the annual rate of occurrence of noise producing outdoor athletic field events.**

You should look closely at what happened in other places with similar situations. We have something special in the neighborhood today. Once it is gone, it is gone. I firmly believe if this change is allowed to move forward what makes our neighborhood special will be lost. As a result, I believe property values will decline because of all the negative effects including additional health risks resulting from unregulated noise exposure. I am also concerned about parking, lighting, traffic issues, and property values as described in my initial letter dated 01 JAN 2019, but unregulated noise is my major concern.

Based on their past performance, (e.g. practice field used for games, abandoning the master plan process, misleading claims of working with neighborhood, etc.), Edgewood cannot be trusted to implement an outdoor athletic field solution that is compatible with adjacent neighborhood residential property use. It will create problems for its neighbors and the surrounding community. It will damage the health and welfare of its neighbors

and the surrounding community. There are other places not where this private tuition-based institution could have an outdoor athletic field with lights not immediately adjacent to densely populated residential areas. Please vote to deny the conditional use permit application by Edgewood High School for athletic field lighting.



Edgewood decided not to act on its amendment request for the Edgewood Campus Master Plan for only reasons Edgewood can answer...

I am not a lawyer, but I do meet the reasonable person standard. In my simplest terms, the one hundred and eighty-seven page master plan is an agreement with the following key elements:  
Offer – Willingness to enter into an agreement on certain terms  
Consideration – Each party gets something of value (development of property, public use, and knowing what to expect for the duration)  
Acceptance – Meeting of the minds to agree upon benefits and concessions of all stakeholders.

Edgewood voluntarily entered into the master plan agreement to get the benefits it desired. They should not be able to walk away from the agreement after benefitting from it without consideration to other stakeholders that are also part of the agreement. Changes to master plans are permitted if needed. This is why there is an amendment process for master plans. I suggest if Edgewood wants to terminate its master plan it should also do this through the amendment process to ensure all parties agree on how the master plan agreement will be terminated. Legislating a special exemption to benefit only one party is not a precedent to set.

Your vote matters. Please vote in opposition to repeal the Edgewood Campus Master Plan and ask Edgewood to pursue their desires through the amendment process that is in place.

I am writing to express my strong opposition to Edgewood High School's application for a conditional use permit to install lighting on their practice field.

I live about four blocks from the Edgewood campus. While I don't live in immediate proximity to the campus, I often walk through the nearby Park and Pleasure Drive and Wingra Park, where I was delighted to encounter a trio of Sand Hill Cranes strolling on the grass recently. As has been observed in many parts of the country, wildlife have appreciated these quieter times.

Our neighborhood's treasured natural areas are among the "uses and enjoyment" that would be significantly diminished by the installation of elevated lighting on the Edgewood athletic field. Such impacts would not only affect adjoining natural areas, but would be extremely disruptive to those living in direct proximity. Neighbors already report being bothered by noise from a growing number of daytime events. Lights would only exacerbate this situation, allowing games to be played well into the evening hours. Noise from the crowds, loudspeakers and scoreboard would increase at the time of day when people most value peace and quiet within their homes.

I have followed Edgewood planning activities for many years. As a past president of president of the Dudgeon Monroe Neighborhood Association, I was actively involved in negotiations to establish a new campus entrance at Leonard Street. Negotiations were contentious and time-consuming, but achieved a solution beneficial to all. Countless hours were spent in collaborative master planning initiatives with participation from Edgewood and the adjoining neighborhood associations. A stadium was never proposed during any of these discussions.

It is not surprising that Edgewood's recent proposal to construct a stadium met with immediate resistance from both adjoining property-owners and the broader neighborhood. No Madison homeowner should have to endure sound levels exceeding the City's noise ordinances (from which stadiums are apparently exempt) on a regular basis. This is a reasonable expectation, not NIMBYism. Moreover, the City does not need more traffic and congestion in the already busy Monroe Street corridor.

For all of these reasons, I encourage you to deny Edgewood High School's Conditional Use application.

Dear Commissioner,

I would like to register in favor of Edgewood high school's plan to add lighting to their athletic field. The school has done its due diligence to study the impact of adding lighting and how it would affect the neighboring community. The current proposal exceeds city requirements using directional LED lighting that is "dark sky" compliant which would eliminate any light "spill over" onto neighboring property. A striking example is their 4-80 foot lights (latest technology) compared to my local public school's (Memorial) 12-80 foot lights that cast a glare around the neighborhood. EHS lighting would be fully shielded minimizing the amount of blue light emitted into the nighttime environment. EHS has also decreased the power of the lights from 60 to 45 foot candles. We have previously communicated with you, our Alder, and the Mayor to support the Edgewood High School's proposal to add lighting to their athletic field. As this issue is again coming before the Plan Commission, we would like to reiterate our support for the lighting.

We are Raymond J & Debra S Robey. We reside at 2355 West Lawn Avenue, approximately 1000 feet from the center of Edgewood's athletic field.

We have lived at this address for ~ 10 years, have heard sounds from many games and practices at the field, and have no problem with it. We find it far more pleasant than the sounds of emergency vehicles on Monroe Street, or the recent construction & rehab work on our end of West Lawn Avenue. I live on Terry Place- one block removed from the EHS practice field. I have been a neighbor for over 25 years and have always respected and appreciated Edgewood as a highborn. I don't know how many more times I need to write or participate in community and government forums, but this is an important issue that will affect our neighborhood for generations so I do not plan to give up. People come to Wingra Park at night to observe meteor showers and other dark-sky events; children, and elders, like myself, often go to bed early; this simply is not the right place to build a stadium.

I am sure you have seen the 2015 news article in which EHS promised they would never play games or ask for lights- because it would never be accepted by the neighborhood. What do you make of this statement? Was it a straight out lie to get agreement on the practice field improvements? It seems to be a calculated deception; the same kind of deception EHS presented to the neighborhood when they said Middleton no longer allowed them to use their football field. That statement failed to let people know Middleton was perfectly willing to continue the arrangement for the field and thought it had worked out well. In fact, emails show Middleton was surprised when EHS ended their agreement to use the field.

To the Plan Commission,

I live at 2317 West Lawn Avenue, a block away from Edgewood's practice field. I am strongly opposed to Edgewood's proposal to erect 80-foot lights on that field. In the past year or two, we have noticed a dramatic change in the noise level generated by events on the practice field, including those held early on several weekend mornings when we were accustomed to enjoying the peace and quiet of our neighborhood, as well as events at other times on many days. We have tolerated this unhappily, but would find it unacceptable to have these noisy events extended into the evening hours, currently the only time when we can count on peace and quiet we used to enjoy.

This is a compact old neighborhood. The practice field is in close proximity to dozens of homes. Many of us have invested years and significant amounts of capital in our homes and neighborhood. Until recent years, Edgewood has been a good neighbor, but that is increasingly untrue. Their changes are significantly and negatively affecting the neighborhood. If they are allowed to expand the practice field activities any further, these effects will be intolerable. I find it hard to believe that the families of participants in those practice field events would welcome such changes to their neighborhoods, most of which are in Fitchburg and elsewhere in Madison.

It is grossly unfair of Edgewood to expect its neighbors to put up with any more noise than they already generate, not to mention more crowds, traffic, litter, and light pollution. A strong majority of Edgewood's neighbors oppose this and the school administrators know it. That they are pushing such changes at a time of a pandemic emergency is even more unfair and certainly unethical. I urge you to protect our neighborhood by denying Edgewood's applications for any further changes to its practice field, and to thereby protect all neighborhoods by preventing the setting of a bad precedent.

I have lived within 3 blocks of Edgewood for the last 4 years. I enthusiastically SUPPORT all athletic field improvements desired by the school, including, lighting, scoreboard, public address, etc. Camp Randall seats 80,000 people in a stadium less than a mile away!!

My name is Richard Friday. We have lived at 1050 Woodrow St. across the street from Edgewood for over 40 years. I'm asking you to turn down Edgewood High School's request for stadium lighting as well as future requests for amplified sound.

The Edgewood schools already intrude upon the neighborhood with noise and light pollution, traffic and parking issues. These have escalated significantly over the past several years and are getting worse. It is transforming the neighborhood. Some people have already moved because of it.

Last winter the Mayor, City Council, and the City Attorney threw the neighborhood under the bus when they allowed Edgewood to exit their Master Plan agreement. They did it in spite of overwhelming opposition from the DMNA, Vilas Neighborhood association, Greenbush Neighborhood Association, the Alder and the recommendation of the Plan Commission. There was also intense opposition from close neighbors who formed the "No New Stadium" group and obtained legal council. The decision to let Edgewood out of their agreement, perhaps because of the religious discrimination threatened lawsuit, was outrageous. ENOUGH IS ENOUGH !!! Just say "NO".

Edgewood High School is a tax exempt, private commuter school. About three fourths of their students come from outside of the neighborhood. They drive in from Fitchburg, Verona, Middleton, Shorewood, Maple Bluff and points beyond. When combined with college traffic and Monroe St. commuters as well as insufficient parking, the neighborhood is already stretched. Don't add to it with a sports venue.

Last fall there was a sporting event on the Edgewood athletic field. This was in violation of their Master Plan agreement which the city refused to enforce. That particular game was between the UW lacrosse club and Minnesota. There is no question that Edgewood's intent is to develop the field as a sport's venue. They refuse to engage in dialogue with the neighbors and the alder. It has nothing to do with six night high school football games. Their plans are not compatible with the neighborhood's needs and damage the livability of the neighborhood while decreasing the value of nearby properties. They are also not compatible with the city's guidelines for development. Do the right thing. Turn down their request.

As the Plan Commission reviews Edgewood's request for lighting at their athletic complex it is important to remind them to act in accordance of the 2017 Wisconsin Act 67 which addresses the standards for granting conditional use permits.

The decision by the Planning Commission and City Council has to be based on the following;

“Substantial evidence” means facts and information, other than merely personal preferences or speculation, directly pertaining to the requirements and conditions an applicant must meet to obtain a conditional use permit and that reasonable persons would accept in support of a conclusion.

If an applicant for a conditional use permit meets or agrees to meet all of the requirements and conditions specified in the county ordinance or those imposed by the county zoning board, the county shall grant the conditional use permit. Any condition imposed must be related to the purpose of the ordinance and be based on substantial evidence.

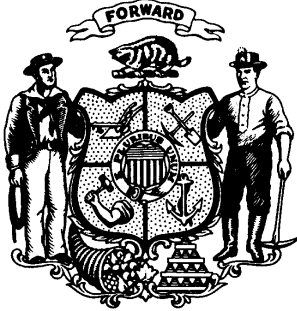
The request before the Plan Commission meets the requirements. If it is acceptable for MMSD, UW, and the City of Madison to utilize lights for activities, so should it be for Edgewood. If the health and well being of other neighborhoods hasn't prohibited the use of lights - then it can't be used in this instance either.

AN ACT *to renumber and amend* 59.694 (7) (c) and 62.23 (7) (e) 7.; *to amend* 59.69 (10e) (title), 59.69 (10e) (a) 1., 59.69 (10e) (b), 60.61 (5e) (title), 60.61 (5e) (a) 1., 60.61 (5e) (b), 62.23 (7) (hb) (title), 62.23 (7) (hb) 1. a. and 62.23 (7) (hb) 2.; and *to create* 59.69 (5e), 59.694 (7) (c) 1., 59.694 (7) (c) 3., 60.61 (4e), 60.62 (4e), 62.23 (7) (de), 62.23 (7) (e) 7. a., 62.23 (7) (e) 7. d., 66.10015 (1) (e), 66.10015 (2) (e), 66.10015 (4), 227.10 (2p) and 710.17 of the statutes; **relating to:** limiting the authority of local governments to regulate development on substandard lots and require the merging of lots; requiring a political subdivision to issue a conditional use permit under certain circumstances; standards for granting certain zoning variances; local ordinances related to repair, rebuilding, and maintenance of certain nonconforming structures; and the right to display the flag of the United States.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

**SECTION 2.** 59.69 (5e) of the statutes is created to read:

59.69 (5e) **CONDITIONAL USE PERMITS.** (a) In this subsection:

1. "Conditional use" means a use allowed under a conditional use permit, special exception, or other special zoning permission issued by a county, but does not include a variance.

(3), a housing cooperative may not adopt or enforce a covenant, condition, or restriction, or enter into an agreement, that restricts or prevents a member of the housing cooperative from displaying the flag of the United States on property of the housing cooperative to which the member has a right to exclusive possession or use.

**(3) EXCEPTIONS.** A homeowners’ association or housing cooperative may adopt and enforce a covenant, condition, or restriction, or enter into an agreement, that does any of the following:

(a) Requires that any display of the flag of the United States must conform with a rule or custom for proper display and use of the flag set forth in [4 USC 5 to 10](#).

(b) Provides a reasonable restriction on the time, place, or manner of displaying the flag of the United States that is necessary to protect a substantial interest of the homeowners’ association or housing cooperative.

**SECTION 28. Initial applicability.**

**(1) RIGHT TO DISPLAY THE FLAG OF THE UNITED STATES.** The treatment of section 710.17 of the statutes first applies to a covenant, condition, or restriction that is adopted, renewed, or modified, or to an agreement that is entered into, renewed, or modified, on the effective date of this subsection.

**(2) CONDITIONAL USE PERMITS.** The treatment of sections 59.69 (5e), 60.61 (4e), 60.62 (4e), and 62.23 (7) (de) of the statutes first applies to an application for a conditional use permit that is filed on the effective date of this subsection.
