Hello,

I would like to submit a comment regarding tonight's Plan Commission meeting item #61061 (416 S Park Street; 13th Ald. Dist.: Consideration of a conditional use in the Traditional Shopping Street (TSS) District to convert an existing tavern into a nightclub, and consideration of a conditional use in the TSS District to establish an outdoor eating area.)

We are residents of 415 S Brooks St and share an alley with the Mason's parking and outdoor seating area. We support local businesses in the neighborhood and are very grateful for the few bars and restaurants that we have around here, but are also concerned about the potential noise that may come from a nightclub license. In particular we are worried about outdoor amplified music because our and our neighbors' homes are so close to the bar. We have never had an issue with hearing the Mason before--even though they have hosted plenty of indoor music events--but given the proximity we would certainly hear outdoor events. This would be disruptive, especially in the new "work from home" environment where our home is now also our office. Rockhound Brewing is just a few doors down on Park St and recently installed an outdoor seating area that is very quiet and a great fit for the neighborhood. We would be supportive of a similar outdoor seating area at the Mason. There have been no issues with the Mason's current outdoor area including the additional seating they have added in their parking lot during COVID-19.

We have also heard from our neighbors that the bar that was in this location prior to the Mason caused a lot of neighborhood issues including persistent noise, parking and traffic issues, and even some gun violence. While the Mason has been nothing but a great neighbor to us thus far, we do want to avoid a similar situation ever happening here again and are sensitive that it has occured before.
