As noticed in a previous mailing, Madison Water Utility began a project to install new water main on Felland Road in July 2020. The work includes water main installation and pavement replacement of the west half of Felland Road between Bridle Way and Lien Road. Two side-by-side water mains will be installed. The larger of the two mains is a transmission main to carry water across large areas. The smaller main is a distribution main to provide water service and fire protection to the immediate area. The project is slated to be completed by the end of September.

This project will involve special assessments to the owners of property adjacent to the project. Property owners will be assessed for the costs associated with the smaller distribution main. The costs of the larger main and all street repairs and improvements will be borne by Madison Water Utility.

This letter serves as notification for the Public Hearing on the special assessments before the Board of Public Works. **The public hearing will be held virtually on Wednesday, August 19, 2020 at 4:30PM.** The public can attend the hearing using any device with internet access, or call in by phone. If you would like instructions on how to participate, please email BoardofPublicWorks@cityofmadison.com. This email may also be used to submit written comments. The Board will consider any objections that may be filed in writing or in person and hear all persons desiring to be heard.

A Schedule of Assessments in enclosed which shows the estimated costs for each property within the assessment district. After the work is complete, a final assessment will

be calculated based on the ultimate cost for all work actually performed. The final assessment will be billed after the completion of the project.

For property owners in the City of Madison, the assessment is payable in one lump sum or over a period of 8 years, with 3% interest charged on the unpaid balance. Property owners in the Town of Burke may pay the assessment in one lump sum or have assessments deferred until attachment to the City. By the terms of the Cooperative Plan between The City of Madison and the Town of Burke, attachment could be as late as 2036. While the City does not collect interest during the deferral period, the amount due is indexed to the Consumer Cost Index.

Burke property owners who want City water service before 2036 may obtain it by entering into deferred attachment agreement with the City. Under the terms of the agreement, they can connect to City water in the present and pay the assessment fee within five years, at which point they would automatically attach to the City.

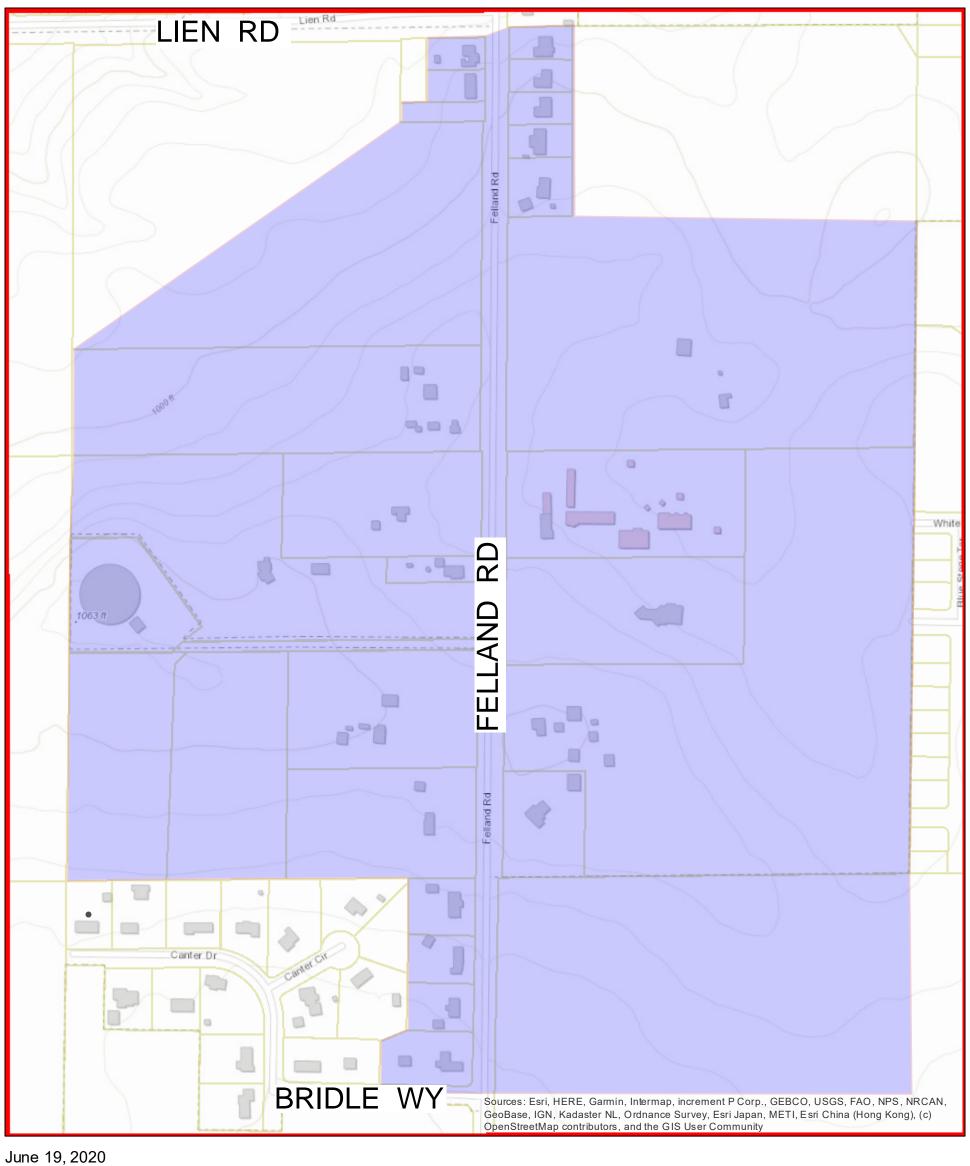

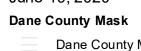
