>> As former president of the Water Board, I like you, spent time looking at the fluoride in water issue. Take a look at the warning on a tube of toothpaste. It instructs you that if more than a therapeutic dose is swallowed, you should contact the poison control center. The therapeutic dose is a pea sized portion. This warning is due to the known toxicity of fluoride. Fluoride while toxic in other ways, clearly prevents tooth decay. Given all the other possible ways to get fluoride to kids, maybe water isn't the best. But if you do eliminate it from water, you need to start some other public health program to replace it.
>> We worry about the other fluorinated compound in water (pfas) at the part per trillion level. Yet, we knowingly add Fluoride at levels 100,000 times higher.
>> >> My Madison raised kids got fluoride applied by the dentist, Fluoride in toothpaste and fluoride in the tap water. My oldest daughter ended up with brown spots on her front teeth, a common dental issue from being over fluoridated.
