**Applicant's Comments**: The University of Wisconsin-Madison is currently in design of the new School of Veterinary Medicine Addition project on the UW-Madison campus. As part of this project, funding was approved to remove the former Wisconsin Veterinary Diagnostic Laboratory (WVDL) at 6101 Mineral Point Road at University Research Park. The structure will be removed and the parking retained for continued use.

#### Applicant: Aaron Williams, University of Wisconsin-Madison

**Applicant's Comments**: The University of Wisconsin-Madison is currently in design of the new School of Veterinary Medicine Addition project on the UW-Madison campus. As part of this project, funding was approved to remove three vacant structures (house and two storage garages) at 5707 Mineral Point Road at University Research Park. The existing mature vegetation will be protected and the disturbed area restored with lawn. Future development of the site will follow the master plan of the University Research Park.

**Staff Findings**: A preservation file for this property does not exist. There is an entry in the WHS Architecture and History Inventory, but WHS staff says the file only contains the address and a finding that the property is not eligible to the National Register. Charmany Dairy Farm opened in 1931 and UW purchased the farm in 1946 with the intention of constructing a western campus at this location. The UW inventory of the property does not have a date of construction for the farm house and identifies the construction dates for the agricultural buildings on the campus from 1946-1981. The UW operated the farm as an agricultural research station and later as a site for the Veterinary program.

### Applicant: Justin Beck

**Applicant's Comments**: Submitting Land Use Permit to demo a 2 story single family home and replace it with a new construction 2 story single family home.

**Staff Findings**: A preservation file for this property does not exist. There is no WHS site file, but the property is located within the boundary of a previously identified prehistoric village or campsite, known as the Lakeside Street Camps, so the property owner will need to work with the WHS to determine if they need to secure a Request to Disturb before engaging in ground disturbing activities.

### 7601 Mineral Point Road

Commercial building constructed between 1873-1890 and remodeled in 1981 with an addition in 1991.

**Staff Findings**: The preservation file for this property indicates that the Italianate brick farmhouse was originally located on 160 acres. The original owner of the house is unknown, and the farm had several different owners throughout the 1800s. In 2018, a descendent of one of the previous owners wrote to staff regarding concerns of redevelopment and suggested the property be landmarked; she indicated the house was constructed in 1863. The Madison Intensive Survey style guide recommends this building has lost too much integrity to be individually eligible for the National Register. The current proposal from the developer is to relocate the historic portions of the building, which would be a technical demolition.
