The Board of Public Works and the City Engineer having made reports of all proceedings in relation to the improvement of Rockstream Drive Assessment District - 2020 pursuant to a resolution of the Common Council, RES-19-00807, ID No. 58344 adopted 12/3/2019, which resolution was adopted thereto, and the provisions of the Madison General Ordinances and the Wisconsin Statutes in such case made and provided. and the Common Council being fully advised.

## BE IT RESOLVED:

1. That the City at large is justly chargeable with and shall pay the sum of \$589,503.23 of the entire cost of said improvement.

2. That for those eligible property owners requesting construction of a rain garden in the public right-of-way adjacent to their property shall execute the necessary waiver of special assessments on forms provided by the City Engineer;

- 3. That the sum assigned to each separate parcel, as indicated on the attached schedule of assessment, is hereby specially assessed upon each such parcel.
- 4. That the Common Council determines such special assessments to be reasonable.
- 5. That the work or improvement be carried out in accordance with the reports as finally approved.
- 6. That such work or improvement represents an exercise of the police power of the City of Madison.
- 7. That the plans & specifications and schedule of assessments in the Report of the Board of Public Works and the Report of the City Engineer for the above named improvement be and are hereby approved.

Street Installation Assessment: The rate for the street installation is calculated based on the total estimated costs divided by 2 (each parcel pays for half the street along their frontage). The rate is then applied to all parcels.

Partial Street Subgrade Installation Assessment: The lump sum is calculated based on the amount of select fill and fill borrow needed to construct the street subgrade within the wetland boundary (STA 102+75 to STA 105+50) within the slope intercept limits. The lump sum total is assessed to Lot 1, Lot 3, and O.L. 4 evenly based on % square footage.

Street Lighting Assessment: The rate for street lighting is calculated based on the total estimated costs divided by the net linear frontage. The rate is applied to Lot 1, Lot 3, O.L. 4, & Madison Metro School District. Developer is responsible for street lighting along the Stormwater Utility and Park frontage, which is distributed evenly to Lot 1, Lot 3, and O.L. 4 based on % frontage.
