Hi All -

I am sure many of you have received either direct emails or as part of a commission group about this issue. I just wanted to give some background and the intent of the resolution. I hope this will help to clear some of the misinformation out there. Nothing in this resolution involves the police or criminalizing homelessness. I think we all should agree that the parks are not the best alternatives we have out there. Government should be accountable to all its citizens not just a few. No American should sleep outside particularly in these brutal winter months.

Background:

On May 6, 2020, Mayor Rhodes-Conway issued an emergency order establishing Temporary Permissible

Encampments (TPE) of homeless persons in city parks.

This order contravenes three city ordinances, one zoning ordinance and a state law- all prohibit camping

in municipal parks.

Since the order allowing TPEs, large campgrounds have been established in Reindahl, James Madison

and Central Parks.

Activities in the campgrounds have resulted in numerous police calls for disturbances and including a

homicide in Reindahl Park and arson of tents in James Madison Park.

Comments:

The Mayor's order to move homeless individuals from a city shelter to the parks created a set of new

problems without resolving the issue of disease contagion. Throughout much of the spring and summer

many of our parks have become "off-limits" to city residents as fights, drug use and other behaviors

became common.

Common sense and long-standing city ordinances and policies state the obvious: city parks are not for

camping. Parks officials acknowledge that areas that have been camped will be ruined for other use for

years to come. Just as parks that have been crime scenes will be avoided by local residents for many

years.

As winter approaches, the city must aggressively seek state and county funds to house as many of these

individuals as possible. This resolution is in no way written to criminalize any homeless person.

Proposal:

- 1. Rescind the Mayor's emergency order
- 2. City staff are directed to enforce the City's ordinances regarding camping in the City's parks and prioritize enforcement actions In encampments where there

are numerous police calls for service.

3. City staff will work with Dane County and local community outreach providers to assist the occupants of the encampments in obtaining support and other, more humane housing options. This

includes identifying county and state assistance through the federal CARES Act.

4. City staff shall prepare a report for the Council that assesses the extent of the impact of camping

sites on the City's parks, that details existing housing options for those experiencing homelessness.

5. Find immediate solutions to take the burden off of Warner Park Community Center which is not

suitable as a long-term shelter. I believe this option is already on works.

Greetings,

I wanted to share comments regarding the discussion about city parks being used as homeless encampments.

I have been a homeless outreach worker for 14 years. I am currently the Coordinator of the Briarpatch Street Outreach Program which targets and serves teens and young adults up to age 24.

To say homelessness has been a challenge to this community is an understatement. Since I began this work, I have seen the issue get worse, more complicated, more dangerous, and more desperate. Our shelters are overwhelmed, outreach workers are burning out because the movement from homelessness to housing is slow and often nonexistent. Unfortunately, homeless services are often the catch all for other systems (Health care, county care,

treatment, etc.). The need for a community wide strategic plan for those unable to or unwilling to access the shelter system has long been due.

To those of us doing the work it feels like our city continues to push the marginalized further out and limit where they can stay. Since the beginning of the COVID crisis, outreach workers were asked for input, told the city was working on plans to help unsheltered homeless families and individuals, yet those plans were often slow and came with many restrictions. We were asked about our ideas and then repeatedly told those ideas were not viable. Meanwhile our consumers are caught in the middle, and left to fend for themselves, make decisions and set up camp where they can.

We are experiencing a public health crisis that hasn't happened in 100 years, and exceptions must be made for those most vulnerable. For the 15-20 homeless individuals causing problems in our parks and streets, hundreds are just trying to get by, often unseen or unknown to the community. Trust me, the outreach community knows that problems exist, and we are also painfully aware that we are not getting nearly the level of resources to address the issue effectively. We are some of the lowest paid and under resourced providers in the community. We cannot sustain the work we are doing and be asked to tell people to move and vacate parks and other places... which we are often asked to do, completely compromising our relationships with our homeless community.

I believe before any recommendations or proposals are made by any city commission or committee, that so deeply affects the lives and safety of our most vulnerable, members of the committee or commission join any one of the outreach teams and look the people in the eyes and tell them of the enforcement of such city ordinances. The City staff overseeing homeless services specifically Sarah Lim, and Torrie Klopp-Mueller have committed themselves to joining us, meeting the people, and gaining a full appreciation of the challenges we face as a community and as providers. It's time our representative leaders do the same.

In this current state of the world (specifically the political world), humanity is being compromised and viewed as a weakness and liability. Caring and empathy are without a doubt some of the most challenging qualities to practice, especially during times of dire straits. Please consider homelessness a public health crisis, in need of the same level of concern and resources.
