I want to express my opposition to rezoning the Karmenta property for use as a temporary homeless shelter. I understand why the property is desirable and would work well from Salvation Army's standpoint but you have to consider the surrounding neighborhood. It's hard to imagine a worse location. There is a preschool and a park literally next-door and a liquor store directly across the street. It is surrounded by single-family homes.

I work with Madison's homeless population on a daily basis and there's a high amount of substance abuse and mental health issues within this population. The city and county's decisions to place homeless individuals at hotels in the East Washington corridor by East Towne has led to a spike in police calls in that area and I know from speaking with business owners there that it is driving them crazy and affecting their customers on a daily basis as homeless people panhandle, wander in the street and camp out in their entry ways.

I am glad people want to help support our homeless population but locating a center like this in this area is a bad idea and an unfair burden and risk to the residents, businesses, students and teachers that live in work in the immediate area. Hystand park just half a block away already has become uncomfortable to visit at times because of homeless people camping in the park and I can only imagine this will make it much worse.

This letter is in regard to my family's opposition to: Item #17, Legislative File 62435.

While we value the need for safe and accessible housing for our homeless residents, we strongly oppose the proposal to establish a homeless shelter near Hiestand park.

Hiestand park is an important community park for the area, with numerous secluded, wooded hiking trails and other recreational amenities which we feel would be jeopardized with a shelter of this size at this location. Furthermore, while it is not publically-funded, there is a school directly adjacent to the property, Toad Hill Children's House. This school provides safe, high-quality and affordable childcare for children ages 2-6 who utilize the outdoors space Hiestand park has to offer frequently. Placing a large homeless shelter near the public park and school raises questions about safety for the surrounding community.

There is an unfortunate correlation with homeless, mental health issues and alcoholism. This is particularly pertinent because the proposed location is also adjacent to a liquor store, adding an additional risk to the community that utilizes the park and the children of the school.
