COST PER SURVEY

The development of a "cost per survey" estimate is complicated by the fact that there are fixed costs incurred in every study, no matter the number of parcels, and also economies of scale that enable savings when evaluating many parcels. Our proposed pricing structure addresses both of these complications.

This estimate includes all mark-up for fringe benefits, overhead, profit, and other direct expenses. The Base Labor rate is based on MSA's Staff Planner (3-5 years experience) position. Quality assurance/quality control services and meeting attendance will be provided by Team Leader Jason Valerius, who normally bills at \$180/hour.

Base Labor Rate - \$105/hour

Additional meetings (e.g., with City staff or committees) would be billed on a "time and materials" basis for the staff involved. Expert witness services are available on a "time and materials" basis for \$200/hour (plus expenses).

MSA's experience over the past twelve years completing blight studies for the City of Madison allows us to offer a pricing structure that most closely matches our cost to complete this work promptly and efficiently. There are fixed costs with each study, and the incremental cost decreases as the number of parcels increases. As such, we propose the following:

*Pricing for a study of this size requires notice of intent to proceed by approximately February 1 and clearance to begin work by approximately May 1.
