Thank you for your thoughtful summary of the Edgewood stadium issue coming before the council. It is ridiculous to think that adding a stadium with lights and amplified sound will not impact the surrounding traditional neighborhood and lakeshore. As a resident within earshot of the proposed stadium, I am adamantly opposed to any compromise that involves new lights or amplified sound. We have made a decision to live in a dense urban neighborhood and as part of that we make daily sacrifices. But Edgewood's insistence that they are owed a stadium regardless of the impact it has on the neighbors' quiet enjoyment of their homes is obscene. Dear Alder Tag Evers and Other Members of the Common Council,

Please vote NO on the Edgewood High School appeal regarding its request to allow lights at school's outdoor stadium.

I have lived at 2233 West Lawn Ave for 28 years. Our block is parallel to Monroe Street and directly across from Edgewood High School's entrance.

I am greatly concerned that the installation of lights and the expanded night time athletic schedule will be seriously detrimental to the quality of life, use and enjoyment of our property which we have become accustomed to for nearly 30 years. We do not understand how the lights and the noise created from the night time sporting events will not impair the quality of living in our neighborhood.

I am also concerned that Edgewood High School has not worked with our neighborhood association in good faith to find an acceptable compromise for the light and sound installations on its athletic field. The Dudgeon Monroe Neighborhood Association has presented various methods to minimize the disruptive effects of Edgewood's proposal but these have been consistently set aside without engaging in meaningful discussions to reach a compromise.

Since it came before the Plan Commission, I am not aware of any recent activity Edgewood has conducted to measure and research the impact its current and proposed use of the athletic fields will have on the surrounding neighborhood. Such an assessment suggested by the Plan Commission when Edgewood's proposal was heard and denied earlier this summer. Thus, the neighborhood is left to accept on blind faith that Edgewood's request will not substantially impair or diminish the well established use, values and enjoyment of neighboring residents' property.

For these reasons I respectfully request that you vote NO on Edgewood's appeal.

### To the Common Council:

I ask that the Common Council leave it to the parties to work out the issues between them relating to the expansion of Edgewood's athletic field facility. In other words, please uphold the Plan Commission's action and deny Edgewood High School's appeal.

When it denied Edgewood's request for a conditional use variance, the Plan Commission encouraged Edgewood to work out the issues with the neighborhood. Some movement has been achieved: according to a recent Wisconsin State Journal article, Edgewood has agreed not to rent out the field and has agreed to limit the number of games next year, but it still wants permission to use lights at 40 games per year starting in 2022.

By comparison, Camp Randall down the street typically hosts seven (7) football games per year.

Having failed to achieve a compromise acceptable to both Edgewood and the neighborhood, Edgewood now seeks through this appeal to override the Plan Commission and the neighborhood and cut off further discussion about lights and amplified sound.

Please deny Edgewood's appeal and make the parties go back to negotiating a solution acceptable to both.

I live in the neighborhood. I believe that a solution can be reached, but what's been achieved so far will without question substantially impair and diminish the uses, values and enjoyment of property in the neighborhood.

### To the City of Madison Common Council:

I am writing in strongest possible opposition on behalf of my family to the request by Edgewood College to install stadium lighting and amplified sound on the sports field for nighttime games. I am dismayed at the way they are trying to sneak in this request to overturn the Planning Council decision during this busy time of the year when many of the neighbors will have heard nothing and won't have time to respond yet again. What kind of organization behaves like this?

I am speaking here for myself and for my family, all long-term residents who live very close to the Edgewood campus.

My husband and I live at 830 Terry Place, which is just one street away from Woodrow Street (bordering the playing field). We have lived here through many changes to the Edgewood campus and have thought that, with alterations made based on neighbor input, the results have been largely positive. However, this time is different. We have followed the arguments for and against the changes that Edgewood has requested for the stadium. I am convinced that the resulting late night noise and light pollution on an unlimited number of nights each year will drive us out of our home and out of this neighborhood after 30 years of residency.

My family members own three properties that have contiguous yards (our home at 830 Terry Place, 826 Terry where my mother lives, and 2415 Monroe Street where my brother lives). We have been dedicated Dudgeon Monroe neighbors with my husband, Bill Barker, serving as president of the neighborhood association many years ago. We deliberately shop on Monroe Street to sustain our small businesses and donate regularly to the neighborhood association, the Arboretum, Madison Parks, Libraries, Troy Gardens, Forward Theater and other civic organizations. We really care about the quality of life in our city and our neighborhood not just for ourselves but for all of us.

Edgewood is requesting 25 nights of scheduled play with sound and light during the first year, with no limits on the number of nights with sound and light in succeeding years. These game nights are going to be compressed within a few months. Imagine if you knew that every Friday night for months, after a long week at work, you were going to have to listen to loud game sounds inside your home until late in the evening. If this request from Edgewood is approved, then we expect that our peaceful home and beloved gardens will be invaded by noise and light on far too many nights to tolerate. The leaders at Edgewood cannot be trusted to adhere to any restrictions, as they have already shown in allowing games on the field in spite of the agreement prohibiting them. The Dudgeon Monroe neighbors who form the

NoStadium group shared videos of a similar situation in Claremont California. Looking at those yards in California communities that abut sports fields allowed to erect similar lights and sound systems, it is very clear that the amount of noise is unbearable. Property values dropped and the neighbors are miserable. The same will happen in our neighborhood.

By contrast, the sole benefits are to a small group of the wealthiest citizens who can afford to send their children to private schools. These supporters do not live next door to the stadium and will not share any of the burden if this is approved. I hope that our community leaders will put the needs of the direct neighbors first and protect a vibrant and engaged part of our city.



La Follette, Memorial, Middleton, and Edgewood


















### To the Common Council,

I live directly across from Edgewood and am impacted directly by many of the activities that take place on their campus, so I have been closely following the events relating to their field. I can see the practice field from my living room and can hear the many sounds it generates while in use even with windows closed. My primary concerns since the start of this have been the noise and light generated particularly by night games, as well as the number of night games proposed and the late hours they would keep since I often work early hours at the hospital.

As you know, the Plan Commission appropriately denied Edgewood's application for stadium light installation earlier this year in part because they could not provide evidence that the lights would not negatively impact the surrounding properties, namely the homes that are in the vicinity. The neighborhood wants reassurance and *evidence* that the noise and light generated from night games would be of minimal impact on their ability to live in and enjoy their homes. Edgewood would have the ability to measure this with day games they can already host. It baffles me that they are instead appealing with a proposal for even more night games than originally proposed a few years ago when they haven't addressed the primary concern of noise and light.

I have been disappointed these past few years by their aggressive actions related to the field enhancements as well as their diminished consideration for the impacted families. I and many others in the neighborhood have not been opposed to Edgewood using the practice area for games within reason, but Edgewood has gone for an 'all or nothing' approach with their insistence on light/sound modifications, increase in stadium seating, number of games played, and times of day games were played. It continues to puzzle me that they are not trying to negotiate in good faith with their neighbors and rebuild trust that they've lost. I would like to think some sort of plan can be created once Edgewood honestly takes part in finding an equitable solution instead of just putting in an appearance. I realize that Egewood might be seeing the field as a way to raise money but the reality is they chose a site that is uncomfortably close to people's homes, and there are consequences and responsibilities that stem from that decision.

Please oppose the Edgewood stadium light installation appeal.

In the middle of a pandemic that is threatening our state, country, and world, I am asking you to vote no on the Edgewood request for lights. One of the reasons I am asking you to vote no is because the lights, noise, and sound that go with this proposal not only pose a health threat to me and my family, but it threatens the well-being of our unique neighborhood too. In addition we are close to UW Arboretum that is home to wildlife and their health and well-being is threatened as well. The addition of high mast lighting and amplified sound were proven through engineering measurements and analysis to cause substantial impairment of the uses, values and enjoyment of the surrounding properties by both the residents of the neighborhood and those using nearby public spaces including Wingra Park and the Park and Pleasure Drive.

As you know this is a dense urban setting where homes are extremely close to the football field with no light or sound barriers in between.

Their proposal includes no sound limits. Multiple sound consultants demonstrated that sound levels would be excessive and widespread. For the nearby homes, it's been demonstrated that normal conversation with windows closed would not be possible during events.

Imagine if you were living in an established neighborhood, your neighbor installs an outdoor amplified sound system with lighting and proceeds to hold night time events disrupting your ability to converse within your home, put young children to bed or simply enjoy being in your residence or around your neighborhood.

And please don't be misled by Edgewood High School's claims of compromise or negotiation with the neighbors. There has been none. The plan before you is substantially the same one that has been proposed for the past two years. What has

changed is an increase in proposed use from 18-27 night games/8 day games in 2017 to 25 regular season night games, an unspecified number of post season night games, unlimited lighted night practices and unlimited day games.

I appreciate your support of the greater neighborhood in rejecting this request.

To the Common Council Members,

We live within a 100 ft radius of the Edgewood football field. We are strongly opposed to agenda item number 60646, the appeal to add lights to the Edgewood athletic field.

We have a young child who is 2 years old. Our child naps every afternoon and goes to bed at 7 pm each evening. The lighting and noise associated with Edgewood's proposal would interrupt his sleep. The importance of sleep for young children is well documented, with lack of sleep affecting his daily schedule, behavior, attention, and learning. Simply put, Edgewood's proposal would have a dramatic adverse impact on our family.

Edgewood suggests that their plans for lighting are designed to minimize impact on the neighborhood, but their plans consistently ignore the crowd noise associated with their sporting events. In past events, the noise of the cheering crowds for soccer and lacrosse has filled our house--the noise is disruptive when the windows are open or closed. One contributor to the volume of crowd noise that we hear in our home is the unique topography of the Edgewood campus, which has a hill behind the athletic field that acts as a natural amplifier, projecting sound in the direction of Edgewood's neighbors. The noise of traffic on Monroe Street is mild compared to the crowd noise coming from sporting events at Edgewood's field. So far, most crowds for Edgewood sporting events have been small--less than 100 people. The larger crowds of bigger night games would be far louder and far more disruptive.

We purchased our home on Monroe Street in October 2015. In June of 2015, Edgewood renovated their athletic field. Edgewood President Mike Elliot said in a quote to the Wisconsin State Journal, "We're between two neighborhood associations. They have been vehemently opposed to us having lights or playing games here. We're really building this to be able to give our athletes the practice facilities that provide the best surfaces possible and to expand the amount of outdoor practices we can hold especially in the spring." (Wisconsin State Journal, June 15, 2015) This quote was a factor in purchasing our home, as it suggests that Edgewood recognized and respected the opinions of the neighborhood.

In contrast to his statement to the Wisconsin State Journal, Mr. Elliot now claims that it has always been Edgewood's goal to play football games and host other nighttime athletic events on their field. It is now clear to us that Edgewood intended to add lights and, eventually, a sound system to its athletic field this whole time. Their piecemeal approach is obviously designed to circumvent engagement with the neighborhood association.

One of Edgewood's main arguments for why they should have a field is that they should be treated fairly and equally to other Madison high schools. On this point, we agree--the nearest public high school, West High School, plays football and other night games at an off-campus field. East High School does too. A second argument made by Edgewood is that their current proposal represents a compromise with the neighborhood. But the number of night games proposed is essentially the same as their original proposal. The ending times of those games remain the same as their original proposal. And Edgewood continues to ignore the issue of crowd noise caused by their athletic events. It is clear that the notion that Edgewood deserves to play its games on its campus is not based on fair or equal treatment but rather on a preference. Edgewood's preference does not outweigh the strong reduction on the quality of life of its neighbors.

For these reasons, we are opposed to Edgewood's plan to add lights to its athletic field. **We** ask that you reject their appeal on the basis that our use and enjoyment of our property will be substantially impaired and diminished.

Dear Alder Evers -

As a resident of the Vilas neighborhood for more than 70 years, and as a former member of the Madison Park Commission, I strongly oppose Edgewood school's proposal to build a football stadium. The building of this stadium at Edgewood school has been strongly and repeatedly rejected by the surrounding neighborhoods and by the Madison Plan Commission.

It has been rejected because the negative impacts on our neighborhood and on Vilas Park will be large. There will be obvious traffic and parking problems. The bright athletic field lighting located atop 80 foot poles would spill out into the neighborhood. Importantly, the noise from the athletic public address system will also boom through the neighborhood. In their current proposal Edgewood does not state any specific volume limits to this noise.

They also propose that there will be no limits on how often the stadium will be used. They do say that initially it will be used for up to 25 season night games. This desire for a limit of 25 season games is surprising. During the last decade the Edgewood Crusaders have generally played a total of only nine games per year. Occasionally, they have played as many as eleven but in no year has the number of games ever approached 25. Perhaps the rumor that Edgewood plans to rent the stadium to other schools explains their 25 season game limit. They say it will also be used for an "unspecified" number of postseason night games, and an unlimited number of night time practices, and unlimited day games. In short, they will use the stadium whenever and as often as they like. This stadium will not be a limited and occasional neighborhood problem. It will be a constant unremitting noisy commotion.

As a previous Madison park commissioner I worry about the effects of this stadium on the nearby city parks. Vilas Park is a short 1500 feet from the site of the proposed stadium and Wingra Park is only 1000 feet away. The noise, and in the evening the lights, from the proposed stadium will transform these parks. What is now a calming stroll across the grass at Vilas will be transformed by the jarring noise of football announcements. The peace and serenity of a kayak or canoe trip on Lake Wingra will be destroyed as athletic announcements boom across the water. By jeopardizing these parks, used and loved by all of Madison, the negative effects of the proposed stadium will reach far beyond the local neighborhood.

For all these many reasons I ask you to reject the football stadium plan proposed by Edgewood School.

I urge you to reject the request from Edgewood High School to install athletic field lighting: do not overrule the Planning Commission decision.

We own a home on the corner of Edgewood Ave. and West Lawn Ave, 900 feet from the EHS athletic field. I am greatly concerned that the proposed "improvements" will significantly reduce both our property value and the enjoyment of our property and quiet residential neighborhood.

Among our concerns and reasons to reject this particular proposal are:

- lack of independent assessment of lighting impact on neighborhood and Lake Wingra and Wingra Park wildlife, including reflected glare.
- lack of consideration of crowd noise and amplified sound during evening hours.
- no limit on number of games or events in evening hours; Edgewood has not shown that it can be trusted without specific limits and enforcement means.

### To the Alders and the Mayor of Madison:

Edgewood HS's attempt to ram a private stadium through in spite of multiple well-considered refusals is the zombie proposal that can seemingly never die. Once again we must ask our representatives and those we trust with the wellbeing of our city neighborhoods to preserve us from this damaging, unnecessary plan.

I am writing to you as I have written before, because this proposal--which in spite of Edgewood's pretense that they are bringing a "compromise" in fact now calls for even fewer limitations on their lights, noise, and number of events than the earlier versions--is not only wrong for our city, it flies in the face of the collaborative processes Edgewood itself invited its neighbors to engage in as it created a long-range plan over a period of years.

It is impossible to avoid the mental comparison to Pres. Trump, refusing to accept the results of the election process and searching over and over for a judge who will be partisan enough to overturn it all. Please do not allow Edgewood HS to find a way to do an end run around the planning process and all the good faith effort that has gone into it. Do not be that judge.

I am a longtime resident of the neighborhood, having lived for 12 years on West Lawn Ave. a short block from the site and now 15 years on Jefferson St., across Edgewood Ave from the high school building. We have raised 5 kids here who all attended West, and are privileged to have been involved as community volunteers in various ways, including recently Democracy in the Park on the shores of Lake Wingra. This proposal affects a neighborhood I love and have long been committed to supporting. I object to this as unnecessary, polluting, threatening to a protected natural environment, and finally as a complete failure of processes the city should uphold.

First, it is not necessary. The football team has been playing and has a place to play. Their parents would evidently like for them to play closer to the school and have lots of money to put behind that, but it's not necessary for their children. West High less than a mile away, serving 2000+ diverse students from south and west Madison, has no football stadium, nor does Madison's East High. A stadium at Edgewood HS is not "infill development" because it is not going to concentrate activity where the users already live. Edgewood students and fans will be commuting by car as they do daily, many from communities outside Madison. It is going to disrupt the interface with one of the most highly valued natural areas in urban Madison by bringing traffic, noise, and light pollution from elsewhere.

I am distraught at the lights and loudspeakers associated with this stadium plan. These will be unthinkably disruptive to daily peace and enjoyment of our neighborhood. We are all familiar with the sounds of loudspeakers from Camp Randall, which is farther away. For most of us, this will be much closer, and instead of a few football Saturdays a year there will be scores of events. Additionally, any expensive facility like this will be rented out for revenue, so when there are no games we can expect tournaments and runs and other events--what about concerts?--all involving blasting speakers. There is no structure between my home and my neighbors' homes on the east edge of the Edgewood campus and this stadium: we will hear everything.

In the past, Edgewood has hosted occasional tailgate events for its alumni and some charity events on its greenspace on weekend mornings, with blasting music to energize the crowd. Naturally, we didn't complain because these were rare and were for charity--but rousing music on weekends before 8 a.m. is not welcome. An expensive stadium that will host these events repeatedly will change the character of our livable city neighborhood forever.

Add lights and traffic to that noise, and I am afraid of the damage that will be done to the natural environment of this precious area. This site is on the edge of Lake Wingra and the UW Arboretum. These are not only beloved natural areas, they are fragile and preserve habitat which the suburban expansion of Madison has put at risk. Madison's 20th century planners made extraordinary efforts to preserve this interface between city and nature both for the plants and animals and for Madison's human residents. The Park and Pleasure Drive was created for this purpose and preserved from traffic flow to protect the area and provide access for people to nature. These areas are used and enjoyed daily by humans who find restoration in the natural world rather than a football game. But wild creatures do not remain when human encroachment of this kind is increased.

During this difficult time of isolation Madison has needed this area more than ever. Walking, running, boating or resting in the arboretum and along Lake Wingra is the daily activity of hundreds, so much that the city has closed a street to facilitate that. But we will throw it all away if we let development damage the fragile balance. I read with fear this article in December about how our continent has lost billions of birds, and we don't even notice because our short memories give us "shifting baseline syndrome." If this stadium is built with its environmental impacts on the edge of Lake Wingra, I fear I will have to tell my grandchildren in 15 years that we used to see loons on the lake on their migration north in the spring, and we used to hear owls on evening walks through the neighborhood. They will never see and hear these things on the near west side of Madison for themselves because Edgewood High School wanted a lighted stadium with loudspeakers.

Edgewood's choice to seek a permit by bypassing the processes it created itself promises consistent disregard for the community in which the school stands. Edgewood itself created a Liaison Committee that included representatives from both neighboring Neighborhood Associations and stakeholders from all its resident institutions. I served on that committee for several years and was part of the first master plan. Two versions of a master plan were created and ratified in a process that involved hundreds of person-hours at Edgewood's request. Now Edgewood has chosen to bypass that process completely, destroy its own master plan and abrogate all its agreements to push through this stadium by other means, ignore the liaison process, and silence opposition. That reflects a lack of goodwill and intent to ignore the

concerns of neighbors.

Sadly, that has been my experience as a neighbor to Edgewood High School. They are in our community but do not see themselves as a part of it and will not take responsibility for any impacts on the community. When we have had issues with irresponsible traffic putting local children as well as Edgewood students at risk, with vandalism, litter, and noise, Edgewood washes its hands. When Edgewood High School students vandalized my yard and tore down my political signs (Hillary Clinton and Russ Feingold signs), I spoke with the students, their parents, and the Madison Police. I told the police I would prefer this be worked out with the school and parents as a matter of civil society, rather than to take police time and consider this a criminal matter. The officers told me that when a complaint is referred to Edgewood HS administration they typically never get further response. Indeed that is what happened in my case: I never heard one word further from the parents or students involved, and Edgewood HS administration did not even reply to my messages to them. Since then my Black Lives Matter signs have been torn down twice. As an Edgewood HS neighbor I apparently have no recourse.

We can expect that all disruptive behavior associated with stadium traffic, alcohol consumption, litter, and noise in our neighborhood will be disavowed by Edgewood HS and either require a Madison PD response--unnecessary expense and not an appropriate use of our city resources--or just be suffered by local residents.

Most Edgewood High School families do not live in Dudgeon-Monroe or Vilas neighborhoods. If you proposed a stadium with lights and loudspeakers where they actually live they would not tolerate this proposal for a minute. They will trot out a couple of interested parties who live locally, but the vast majority commute here. Most of the consequences will fall on thousands of people who are neighborhood residents and the other Madisonians who enjoy the benefits of our peaceful area--a good mix of businesses, homes, and natural areas-every single day. This is much too much to demand for the benefit of a very few who do not care about the quality of life on the near west side of Madison and have underweighed the costs and risks.

Alders and Mayor, please do not make that mistake. We are counting on you to hear us. Please send Edgewood HS a message that it is time to stop playing games and trying to wear down its neighbors. What they are proposing is no "compromise," it is just a bad faith effort to get what they want through any means, no matter the consequences for our neighborhood, our city, our natural areas, and our faith in collaborative planning processes that should be embraced by all our institutions.

To the Mayor and Common Council members,

I ask you to again deny Edgewood's application to add lights to their current practice field. As I am certain you are aware, the Plan Commission on 5/11/20 concluded that Edgewood could not demonstrate that the uses, values and enjoyment of the surrounding neighborhood would not be substantially impaired and diminished by the addition of lights. In fact, the Commission had questions regarding the possible detrimental effect of their current escalated daytime use of the field and proposed a further evaluation of that daytime use. They also suggested the need for on going meetings with the neighbors to broker a compromise. Unfortunately neither has occurred. No evaluation of daytime usage has occurred and there has been no exchange with neighbors. Yes, Edgewood has met with neighbors, but Edgewood refuses to dialogue. They have simply continued to offer the same unchanged position that they originally proposed close to 4 years ago.

Edgewood's practice field is simply in the wrong place for expansion to a "lighted stadium" and Edgewood has made it clear that they will not abide by any restrictions of their usage of the field over the long term.

One may also find it surreal that at a time of worsening pandemic, new discussions regarding on-going racial injustice, a re-thinking of police roles, and widespread economic concerns, that an upper middle class private high school is again bringing this issue before the City of Madison and the neighborhoods surrounding Edgewood.

I live at 820 Woodrow Street and ask that the Common Council deny Edgewood High School's appeal of the Plan Commission's decision from May 2020.

There are four things I would like to address:

- 1) Why noise is relevant
- 2) How Edgewood has proposed mitigating noise
- 3) How the City treats noise from athletic fields
- 4) Why the Plan Commission's decision was correct.

### 1) Why Noise is Relevant

Edgewood has asserted that field lighting will not cause additional noise. This is simply not true. The entire point of lights is to enable use to occur for additional hours of the day. Daytime noise generated by use of Edgewood's athletic field has often proved disruptive to myself, my family, and my neighbors. Use of the field will obviously result in noise in the evening hours as well.

Noise from the field has interfered with reading, conversation, gardening, and more. Noise is a portion of how lights would interfere with evening-specific uses too. Here's what my then 10-year-old daughter wrote and presented to the Plan Commission in May:

I like at night to sit calmly in the hammock reading with a light. We just bought a firepit too. If Edgewood played games at night, we would not be able to enjoy the sparkles of our firepit. The hammock would not be peaceful if there were shining lights and loud noises coming from the field. I came home one day to play with my neighbor Mikey because we had made up a dragon game when it got dark out. We would not be able to play in the dark if there were lights. I also like to look at the stars and moon every night but if there were lights, I would not be able to see them. I have Harry Potter nights with my family every weekend, and it has to be completely dark to do it. If there were lights, I would not be able to do that. These are some of the reasons I don't want to have lights right in front of our house. My dog waldo also likes to sleep peacefully and so do I, and I get really tired if I fall asleep late. The bright light will keep me up when I fall asleep at 8:30pm.


### 2) How Edgewood has proposed mitigating noise

I am one of the DMNA representatives to the Edgewood Neighborhood Liaison Committee and as such participated in meetings of the weekly Collaborative Working Group in Spring of 2019, and again over the past several months with a similar group of representatives from DMNA, Vilas NA, and Edgewood. The problem of reaching some sort of compromise before Edgewood

unilaterally withdrew in 2019 came down to the fact that *Edgewood failed to return with a proposal that offered any noise remediation*. The same thing took place this year.

Edgewood's refusal to compromise with neighbors should be seen in the context of the school's own sound study. This study can be found in <u>Legistar File 53954</u>, <u>attachment 9</u>

Here's an image from that study showing projected decibel levels from a game::



Edgewood's sound consultants suggested barriers might help, stating:


"Effective barriers are non-porous with a minimum surface weight of five pounds per square foot. This could be concrete or wood. If wood, the gaps between wood sections would need to be relatively airtight.

Based on our SoundPlan evaluation, we have concluded that sound from the stadium as heard by the nearest residents could be reduced up to 5 dBA with a 16.6-foot tall barrier and up to 10 dBA for a 26.2-foot tall barrier, assuming neutral weather conditions."

A sound study commissioned by neighbors suggests even higher noise levels would occur.

One of Edgewood's Collaborative Working Group suggestions was formalized in their May application to the Plan Commission, which claims "the field has significant screening along Woodrow Street."

Here's a view from my front porch that month:



With only a single row of trees, it's hard to imagine what Edgewood would deem *in*sufficient. The sound experts with whom my neighbors and I consulted confirmed that the effect of a single row of trees on noise from the field is negligible; the number of trees required to mitigate noise from a crowd on the field would need to span across the entirety of Edgewood's property, to Vilas on the East.

This lack of screening is a problem not only for noise but for light itself. My bedroom window, higher than my porch, would see the field as clearly and brightly as the crowd in the grandstands.

### 3) How the City treats noise from athletic fields

Madison's noise ordinances do not and will not not protect neighbors from noise, no matter how loud or frequent, from the athletic field. City staff has affirmed as much.

Neighbors typically direct Edgewood concerns to DMNA's Edgewood liaisons, including myself. When I wrote to Madison Police Department Lieutenant Lori Chalecki about those concerns, she replied:

Hi Marc.

Thanks for your patience. I have had a chance to review your email and speak with Building Inspection.

Most of this issue is in the hands of BI and City Attorney. While I understand BI directed residents to call [MPD] for noise complaints, I think it is important for people to understand on the front end that likely the police will not take any action. We deal with noise issues based on reasonableness. A sporting event, with all that goes with a normal sporting event, would not be considered unreasonable. If they start having sporting events at midnight, that would be unreasonable and people should definitely call.

Marc- I understand you and other neighbors' general unhappiness with noise from the field use, and your recognition/respect for the Police and their workload/priorities. Thank you for that.

As you know, the noise issue from the field is a Police matter, not Building Inspection. If people complain, the only recourse is for the Police to respond.

After the repeal of Edgewood's master plan, neighborhood representatives met with our alder, Matt Tucker, Tim Parks, and John Strange. ACA Strange verbally confirmed that the emails from Building Inspection and MPD correctly represented the City's approach to noise from the field: complaints will be handled by the Police Department, which will likely not take any action.

In that meeting with City staff, When I subsequently asked what rights I then have as a property owner to protect myself from very loud noise that could occur on a nightly basis, Attorney Strange replied only that I have the right to present my case to the Plan Commission when Edgewood put forward its application. I did this, as did my neighbors.

### 4) Why the Plan Commission's decision was correct

At the plan commission meeting, negative impacts on the use, value and enjoyment of my property were demonstrated clearly through the documentation and testimony of myself and my family. Many neighbors shared their own similar experiences, and Edgewood's own sound study provides substantial evidence of the level of noise generated by games on the field. By disregarding the need for noise remediation, Edgewood effectively affirmed that harm will extend into the evening if approval of their application were to occur. The commission correctly determined that conditional use standards were not met.

Please deny Edgewood's appeal.

I am writing to express my strong opposition to Edgewood High School's attempt to overthrow the decision of the city plan commission earlier in the year to disallow the upgrading of their sports practice field into a stadium, including the hosting of evening and night games. Denying Edgewood's appeal is a matter of social and civic justice. As has been demonstrated beyond a shadow of a doubt at previous hearings, such a stadium would profoundly and irrevocably affect the quality of life of countless families living in the neighborhood, as anyone can surmise by simply walking along Monroe Street, Woodrow Street, and other nearby streets and seeing how close the playing field is to people's places of residence. Of course the unwelcome noise of sports events would not extend to adjacent streets only, but would impact a large swath of those living in the immediate vicinity, an area of dozens of city blocks and hundreds of residences. A stadium will subject people living within the affected area to the stressinducing screaming and shouting of crowds anytime a game takes place, throughout the school-year. Evening games will impose such completely unwelcome noise on families as they seek to retreat into the quiet of their evenings. How can such egregious imposition be allowed to happen? Edgewood's continued pursuit of this reflect a profound disregard for the lives and well-being of the community in which the campus is situated. Edgewood has consistently disregarded the will of the neighborhood, despite massive community pushback against its plan, and has remained doggéd in its efforts to destroy our neighborhood through its institutional bullying, going so far as to sue the city on the ludicrous grounds of having violated its religious freedom by not allowing it to destroy neighborhood tranquility. Who do they not show contempt for—they treat the city with the same arrogance, disregard, and sense of entitlement that they show their neighbors? They have been and continue to be dishonest about virtually every aspect of the stadium, practices which are well-documented by other citizens. 



## Light Impact - 4.2 million lumens

Sampling locations were chosen by overlaying a map of our neighborhood, with the current location of Edgewood's practice field, onto a map of Waunakee's stadium, and matching the horizontal distance from the sideline and position along the field for each sampling point to what they would be in our neighborhood. At each of location, collected quantitative data on sound and light using professional digital instruments. All light measurements were collected with an Extech 403125 digital illuminance meter. It reads out in 0.01 lux increments and is accurate to +-5% of reading + 10 digits in its low range. Measurements were taken of horizontal illuminance (typically used for measuring sky glow) and vertical illuminance (typically used for measuring light trespass).

At locations that correspond to homes on Woodrow, nighttime levels with stadium lights would be comparable to what you would experience at civil twilight (less than 20-30 minutes after sunset), rather than at nighttime, and are many times brighter than a full moon.

MGO 10.085(3)(a)(2):

"All fixtures greater than 1,000 initial lumens (equivalent to 70 watts incandescent)"

EHS proposal: 4,246,400 lumens (39,100 W)

Currently levels are 50x less (0.00-0.06 lux)

This will be an enormous change in the night sky over a large area

Stadium lights would illuminate the night to the point where it would be bright enough to drive a car without headlights. This would extend to neighboring homes.

Sky glow will be visible over an enormous area Middleton stadium lights @ 1.5 mi brighter than streetlights


Middleton High School football stadium viewed from 1.5 miles away





We am writing to express my thoughts about Edgewood High School's appeal of the 7-1 decision by the Planning Commission to deny conditional use permit application. We oppose any appeal of the Planning Commission's decision. As you can see from our letter and the distance their field is from our home, Edgewood High School cannot light their practice field for use in games, or evening practices or events without impacting the use, value and enjoyment of our home. The Planning Commission decision wasn't even close, please respect their decision.

We live directly adjacent to the athletic field off Woodrow Street in one of the houses on the upper end of the street that are very close to the athletic field. We are <u>opposed</u> to any plan to install lighting at the field. The current, expanded use of the athletic field, since the upgrade to artificial turf (2015) has already impacted our lives through more frequent and intrusive sound coming from the field. Given the proximity of our house to the field, we can hear the sound from practices and games on the athletic field in <u>every</u> room of our house. As is exists now this intrudes upon afternoon homework time, evening meal time, and even our youngest child's bed time (two of our three bedrooms face the field) the only thing that reduces the noise to normal residential neighborhood levels is <u>darkness</u>. The addition of lights would extend this time without the ability to limit, enforcement or recourse.

Use: The addition of lights to the field would curtail the use of our home. Quiet resting and sleeping hours would be impacted by the accompanying noise that a lighted field brings. Two of the three bedrooms in our home face the field so light and noise from the field would impair the normal use of those rooms. Everyday conversations are already disrupted by field noise. In addition – there is no physical barrier to sound or light from the field that would be practical (photo shows topography, fence around field is 8 feet tall for reference). The field is higher than the street level and is essentially even with the first floor of our home with no buffer. This same effect would happen with lights as the rest of the area would be dark, except for the field. Prior to Edgewood Campus changing the street lights on Edgewood College Drive, we could make shadow puppets from the glare of those lights inside our front bedrooms, and those lights were on the opposite side of the field from our home. As you can see from Photo 2 below, our home sits level with or slightly above the field with no barriers for sound or light. If the field is lit at night it will be visible, period.

Value: As the real estate saying goes, "Location, location, location." Similar athletic stadium construction in other cities in Wisconsin and around the country has negatively affected home prices and resale. Consider the difference between moving next to a school's practice field versus a stadium with 80 foot light poles looming over the adjacent neighborhood homes. Edgewood's actions would limit the number of pool of potential buyers as people would be concerned with the same impacts we are discussing here (frequency and hours of use, light and shadow falling on surrounding homes, noise from practices and competitions).

Enjoyment: As close as we are to the field, any time there are people using it, shouting, etc. it's audible both inside and outside our home. With lights, comes use, and with use comes noise. As with most families, our home is a source of work, enjoyment and refuge – a place to rest, have meals with family and friends and sleep. Since the upgrade to artificial turf and the constant pressure to expand this facility into a full blown stadium (lights, grandstand, sound system) has impacted the sense of well-being and permanence we feel now about our living here. It feels as if there will be no end to the requests to impose their wants over our needs. There are and have been other options for evening competitions that have worked for the entire history of Edgewood High School.



We live close to Edgewood HS, College and the Stadium. While we are not completely opposed to lights at the Stadium provided they are only used for limited home football games (that seems reasonable) and have noise mitigation, Edgewood does not seem to want to cooperate/negotiate with the neighborhood. Unlimited use of lights, the stadium and amplification would cause the uses, values and enjoyment of my residence to be substantially impaired and diminished by the bright lights, loud noise and traffic that accompany competitive night games.

I should add that Edgewood *had* been a good partner to the neighborhood. Unfortunately, they have changed tack and have again decided to act unilaterally and thumb their nose at their neighbors. They are not acting in good faith. To try to push this through during the time of the pandemic, when so many are distracted trying to maintain health, jobs, and food supplies, is irresponsible and borderline immoral. Likewise the constant threat of lawsuits to get what they want (big pockets trying to "buy" justice) - this is not compromise. Edgewood HS's mission statement is

Edgewood, a Catholic high school, educates the whole student for a life of learning, service, and personal responsibility through a rigorous academic curriculum that embraces the Sinsinawa Dominican values of Truth, Compassion, Justice, Community and Partnership.

These actions, especially now, are the opposite of "truth, compassion, justice, community and partnership." Negotiation is not take it or leave it. Unilateral action is not community and partnership (note most students do not live in the affected community).








#### Noise and problems with oral communication

... The signal:noise ratio (in terms of signal processing) should be at least 10 dB(A) to ensure undisturbed communication. In noisy work situations, people are able to converse with difficulty at a distance of 1 metre for a short time in the presence of noise as high as 78 dB(A). In order to be intelligible, the sound level of speech must be greater than the background noise at the ear of the listener. For prolonged conversations, the background noise level must be lower than 78 dB(A). In social situations, people often talk at distances of 2 to 4 metres. In such cases noise level should not exceed 55 to 60 dB(A). In outdoor play and recreational areas, people communicate at distances of 5 to 10 metres. In such cases background noise should not exceed 45 to 55 dB(A). Average sound pressure levels of the human voice at 1 metre distance range between 60 dB (normal conversation) and 75 dB (speech) (104).


Most of this issue is in the hands of BI and City Attorney.
