CCHIC At a Glance

- Joint committee created in 2013. Was a County committee prior to 2013, with members that included City of Madison alders.
- Current committee membership: 13
 - 2 City of Madison Alders
 - 3 County Board Supervisors
 - 1 City of Madison Police Officer
 - 1 Representative of a Downtown Business or Community Organization
 - \circ 3 Representatives of the HSC or other persons experienced in homeless services or advocacy
 - 3 Members with Lived Experience of Homelessness
- The Committee is advisory and, as with most other legislative committees, its actions are typically conveyed in the form of recommendations by the committee to the Common Council and/or County Board.

CCHIC Mission

The Committee shall examine, report and make recommendations to the Madison Common Council and the Dane County Board of Supervisors on issues related to homelessness. This includes housing for the homeless, jobs and job training, availability of public toilets and showers, access to storage lockers, and the provision of mental health, drug and alcohol services. The Committee may adopt rules for the operation of the Committee.

Results Related to Areas of Committee Focus

- City of Madison increased funding for Tree Lane supportive services by \$429,500.
- Changes made to 2019 County AHDF RFP to incentivize flexible tenant selection criteria and reserving units for individuals experiencing homelessness.
- Gaps Analysis work in 2020 Budget for Dane County Human Services HAA Division.
- \$4 million AHDF Dane County (\$1.3 for Salvation Army and Bayview, \$6.3 total for affordable housing development).
- \$5.5 million AHDF City of Madison (\$1 million additional for land banking).

Related Results, Con't

- \$50,000 for Eviction Prevention Dane County
- Staff working with Dane County and Madison Emergency Management to hold workshops in 2020 regarding emergency planning for shelter agencies
- CoC Applied for YHDP funding. While CoC did not receive funds, learned important lessons and intends to apply again in 2020.
- Staff reached out to SPARC several times, still trying to connect.
