### **Introduction – Eve Galantar (3-5 minutes)**

#### A. Introduction

Welcome, I'm Eve Galantar, your host today as we discuss the four advisory referendum questions that will appear on the April 6, 2021 spring election ballot asking Madison voters to weigh in on the size and shape of Madison's Common Council.

I am joined today by Brook Solveidt from the League of Women Voters, and Assistant City Attorney John Strange, who served as city staff to the eleven-member Task Force on the Structure of City Government that spent nearly two years examining the structure of Madison's government.

Together, we will introduce you to the questions that will appear on the ballot and explain how you can learn more about these issues before heading to the polls on April 6.

The questions will ask voters about alderperson pay, the size of the Common Council, the length of alderperson terms, and whether alderpersons should be subject to term limits.

- Q1. John, you were staff to the Task Force on Government Structure and are now helping the Common Council pose these questions to the voters. Why are they asking these questions?
- Q2. And why now? Why did the City create the Task Force and, now, decide to ask voters these questions?
- Q3. I notice this is an advisory referendum. What is an advisory referendum?
- Q4. So, will the results of this referendum make any immediate change?
- OK. Let's look at the first question.

#### QUESTION 1 (3-5 minutes)

The first question that will appear on the ballot relates to council member pay and status.
