

Re: Proposed Street Reconstruction & Utility Replacement Project & Public Hearing

The City of Madison is proposing to reconstruct portions of E. Dean Ave, Allis Ave., Tyler Circle, and Seth Circle in 2021. Enclosed with this letter is a fact sheet with some details on the proposed project, which includes a map of the project limits. Also enclosed is a notification for the Public Hearing before the Board of Public Works, which will be held virtually over Zoom. The date and time of the public hearing can be found on the notification, and, once available, links to register for the public hearing can be found at www.cityofmadison.com/clerk.

This project will involve special assessments to the owners of property adjacent to the project. Property owners will be assessed for various items included with this proposed project, and the costs of some of those items are assessed entirely to the owner. A table detailing the City's standard assessment policy is also included on the fact sheet.

Also enclosed is a Schedule of Assessments, which shows the estimated costs for each property adjacent to the project. After the work is complete, a final assessment will be calculated based on bid prices and work actually performed. The final assessment, which will be billed the year following completion of construction, is payable in one lump sum or over a period of 8 years, with 2% interest charged on the unpaid balance. We will also request that the Board of Public Works recommend that the 8 year period be extended to 15 years for this project.

To request accommodations for special needs or disabilities or if you have any other questions regarding this project, please contact the Project Engineer. This includes requests relating to the Public Hearing and also requests relating to the actual operations of construction. Proposed 2021 E. Dean Ave., Allis Ave., Seth Cir. & Tyler Cir. Reconstruction Project

Project Details - Proposed Work

Streets: The existing streets are mostly rural type street sections without curb & gutter and sidewalk. With the proposed project the existing pavement and gravel base will be replaced, and curb and gutter will be installed on all streets, and driveway aprons connecting to the new streets will be replaced (curb & 4' of pavement and driveway aprons are assessable). Sidewalk is proposed to be installed on both sides of E. Dean Ave. and on Allis Ave. (sidewalks are assessable, Safe Routes Grant will be used to cover 50% of costs), which includes ADA compliant sidewalk ramps at all intersections.

The proposed design on E. Dean Ave. includes a 24 ft. wide street with Advisory Bike Lanes on both sides of the street (dashed lane markings instead of solid lines), and parking pull-out areas will be provided at several locations along the street. Allis Ave. is proposed to be constructed at 26 ft. wide, with parking on one side, without any designated lane markings. Note that the side that will have parking has not been selected, yet. Seth & Tyler Cir. are proposed to approximately match the existing conditions.

Sanitary Sewer: Existing sewer mains are 8" diameter, clay pipes, installed around 1952. The mains will be replaced with new PVC pipe, and the laterals will also be replaced from the main to the property line (*laterals are assessable*).

Water Main: Existing water mains were installed around 1950 and vary in size. The water mains will be replaced with the project, and the existing services will be disconnected from the old mains and reconnected to the new mains, and new hydrants will be installed to current standards. The main on Allis between Shaffer & Turner was replaced in 2008 and will remain.

Storm Sewer: There is limited existing storm sewer in the project area, and most of the existing drainage is overland flow that eventually ends up on the golf course, drains thru yards, and/or connects to the City of Monona system, which is undersized. This project will include installation of new storm sewer to properly drain the streets, and will also include new storm sewer along the golf course to improve drainage and help limit flood risk to the adjacent properties.

Street Lighting & Traffic Signals: There are no proposed changes to the lighting or traffic signals. The existing lighting is on MG&E wood poles. Several MG&E poles will need to be relocated with the project, and the lighting will be re-installed on any poles that are moved.


Construction Schedule & Impacts

Tentative Schedule: This project is currently scheduled to be bid in late March, and construction is expected to begin in early June, 2021 and completed in Sept. 2021. During construction, the allowed work hours are 7AM-7PM (Mon-Sat) and 10AM-7PM (Sun).

Traffic Impacts: During construction, the streets will be closed to thru traffic (open to local traffic only). Access will remain open to driveways for the majority of the project, but access will be difficult or unavailable when work is taking place immediately in front of the driveways, and City specifications allow residential driveways to be closed for up to 20 days to complete work on or through the driveway. Options will be reviewed for where residents may park while driveways are closed, but typically parking is only available on nearby streets in the neighborhood.

Water Shut-offs: With the work on the water mains and services, there will be, on average, two shut-offs for each property during the project. Shut-offs may last up to 8 hours, and advanced notice will be provide to the affected properties, prior to the shut-off. The old, existing mains remain in service until the new main is installed, so there is potential that the existing mains may break during construction, resulting in an emergency shut-off. Should that occur, properties will be notified as quickly as possible.

Refuse & Mail Collection: Refuse and mail collection will continue as they typically do, and the contractor will be required to provide that access. Please mark your address on your refuse carts in case the contractor needs to move them for collection.



Terraces: The terrace is the existing space between the street and right-of-way (approximate 14'-15' from existing edge of pavement. This area will likely be disturbed with the project; if you have any landscaping or items in this area that you wish to save, please remove it prior to the start of construction.

Rain Gardens: There will be opportunities to install terrace rain gardens with this project. Rain gardens are great way to help improve water quality, promote infiltration, provide habitat, among other benefits. If you haven't already expressed interest in having a terrace rain garden installed, you may still request one by contacting Jojo O'Brien.

Tree Removals:

This project will include tree removals at the locations noted below. If it is determined that any additional trees need to be removed, the adjacent property owner(s) will be notified prior to removal. All efforts will be made to protect existing trees that are not planned to be removed, but some of the work included with this proposed project will be taking place close to or within the root zones of several trees:

- Tree & arborvitae at 219-221 E. Dean Ave

- 2 trees at 223 E. Dean Ave
- 1 tree at 223-225 E. Dean Ave
- 3 Arborvitae on the Allis Ave. side of 329 E. Dean Ave.

- 1 tree at 4701 Allis Ave.

- several arborvitae at 4705 Allis Ave.
- 1 tree on Allis Ave side of 4736 Spaanem

There are also several trees that we plan to work around and save, if possible, but are still at high risk for removal:

- 1 tree at 225 E. Dean Ave.
- 1 tree at 313 E. Dean Ave.
- 1 tree at 303 E. Dean Ave.
- 1 tree at 325 E. Dean Ave.
- 1 tree at 307 E. Dean Ave.
- 1 tree at 328 E. Dean Ave.
- 1 tree at 4704 Allis Ave.

Additional Forestry Information:

Prior to construction, City Forestry will prune street trees that are to remain. Tree pruning in advance of the project is necessary to reduce the risk of damage to the trees during construction. For certain species, especially oak and elm trees, the pruning must be completed by April 1st to reduce the chance of disease.

Following construction, City Forestry will evaluate the terrace for new planting sites and potential replacement sites. There is no additional cost to the adjacent property owner for a tree planting. Street trees are typically planted in the spring of the year following the completion of the construction project. Per Madison General Ordinance 10.10, City Forestry determines tree species and planting locations. Residents cannot choose or plant their own tree in the terrace.

For any questions regarding street tree maintenance or planting, please contact the general forestry line at 266-4816.

Private Trees: There are a number of trees on private property that overhand the street or generally into the right-of-way. City Forestry will not prune trees on private property. To avoid damage to the trees, property owners should make sure that all trees are pruned up to the required clearances prior to the start of construction, which is 13'-6" over streets and is also our recommendation for any trees overhanging the right-of-way.
