Dear Executive Committee members,

I urge you to join PSRC in recommending that item 63561 be placed on file with impunity, and call for a tear gas ban.

The Common Council asked MPD for a report on tear gas usage and alternatives. I didn't have high hopes in their ability to complete the task impartially, but I'm disappointed in what they produced. MPD had an opportunity to actually consider the wide-ranging impacts of these weapons. They had an opportunity to weigh the pros and cons, help the Council with the decision before you. They failed to do that. This report is pure "CYA" work.

Instead, we have a report that lists past usages of tear gas. It expects you to accept that these instances were all justified and necessary, simply because MPD deemed them so at the time, and (allegedly) wouldn't have used tear gas otherwise.

We have a report that, just like officers' individual Use of Force reports, fails to even account for who the victims of these uses of force are. They don't care who might have suffered respiratory distress, or corneal damage, or vomiting, or nonconsensual abortions, because of their usage of these weapons.

We have a report that perpetuates the false claim that tear gas plays any role in deescalating a situation, or coercing people into cooperating. Time and again, we've seen protests turn more aggravated when these chemical agents are used. Even in the barricaded situations, according to MPD's own accounts, tear gas was ineffective 2/3rds of the time at convincing the subject to come out.

It's flat-out irresponsible for MPD to put its officers at greater risk by using tear gas, just so they can inflict greater violence on civilians. If they won't show some common sense and put a stop to this practice, the city must.

In addition to concurring with PSRC's recommendations, the committee could also consider introducing a resolution banning tear gas for immediate consideration.
