The Purpose of This Report:

This report is a summary of the proceedings of the Board of Public Works addressed annually to the Common Council in accordance with Section 62.14(5) of the Wisconsin Statutes.

During 2020, the Board of Public Works convened for 21 meetings of which 13 included formal Assessment/Utility/Noise Impact Public Hearings. The Board did cancel 1 meeting (5/6) and meetings were held virtually starting April 1st.

The Citizen members of the Board were paid a salary of \$100 per annum in accordance with Section 62.14(3) of the Wisconsin Statutes.

Summary of Bids Received by the Board of Public Works Construction:

It is the goal of the City to maximize the competition for public works contracts in order to provide the best value for the expenditure of its property tax and utility rate payers. The receipt of three or more bids from prequalified contractors best accomplishes the attainment of that goal. However, the practice of the city is to open the bids for projects, which have two bidders without an extension of the bidding period.

When a single bid is received for a contract, the bid period is generally extended unless there is information indicating that there are insufficient bidders available or schedule constraints.

Best Value Contracting 2020

In 2020 a contract was considered a Best Value Contract per MGO 33.7 (7) if the contractor's bid was equal or greater than \$63,500 for a single trade contract; or equal to or greater than \$311,500 for a multi-trade contract.

The dollar value at which Best Value Contracting requirements are applied is adjusted each year based on the change in the construction cost index as published in the Engineering News-Record.

In 2020, 61 Public Works contracts were awarded. BVC information is now available for one contract from 2019 (7528). Therefore, this summary of apprenticeship utilization in 2020 is based on 62 contracts, which were made up of 29 general contractors and 83 subcontractors.

General Contractors were required to have active apprentices employed by their company in all apprenticeable trades used on the project in 36 instances. See Apprentice Utilization Chart for complete breakdown.

OTHER ACTIVITIES OF THE BOARD OF PUBLIC WORKS:

During 2020 the City Engineer reviewed the listing of potential bidders prequalified for City work by the City Engineer; 208 contractors applied for various types of work in 2020.

In 2020, the City Engineer approved 1,650 street excavation permits for main, cable, lateral, and pole locations for the Madison Gas & Electric Company, City of Madison Water Utility, Wisconsin Telephone Company, and others.

The Board reviewed various Resolutions, Ordinances, and Petitions referred to it by the Common Council regarding purchase of property, relocation orders, relocation claims, citizen complaints and petitions, official map changes, and street vacations.

There were no appeals regarding prequalifications of various contractors to bid on City of Madison Public Works Projects, and contractors applying to be licensed Concrete Layers, Asphalt Pavers, and Mudjackers. However, the Board did receive an appeal from one contractor regarding SBE Compliance. The Appeals Committee did find this contractor to be non-responsible due to their failure to submit a complete SBE Compliance Report and their bid was deemed ineligible for award of the contract.

The Board reviewed all Change Orders for projects which exceeded the contingency established at the time of award, exceeded \$20,000 or resulted in a change in the completion date.

BOARD OF PUBLIC WORKS HIGHPOINTS:

January 8, 2020

Legistar 58729:

Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for Warner Lagoon Pier and Ice Access.

This project is for the installation of a new pier on the east shore of the lagoon at Warner Park. Estimated cost is \$75,000.

March 4, 2020

Legistar 59718:

Amending the 2020 Sewer Utility Capital Budget to increase the Municipal Capital Participation funding by \$130,000 to fund project Rimrock Interceptor-Industrial Drive Extension.

We have a sewer that we jointly use with the City of Monona South of Industrial Drive. The City of Monona has 70% of the customer base while the City of Madison has 30%. Our cost share for maintenance is also the 70%/30% split. The sewer definitely needs to be replaced due to excessive groundwater infiltrating into the sewer main. Bids came in

higher than we expected but Monona has agreed to pay the higher project cost. We cannot bill Monona without a Budget Amendment to give us billing authority. The result was the need to make emergency repairs to roads, bike paths, drainage facilities, sanitary sewers, shorelines and other public infrastructure in order to protect the health, safety and welfare of the public. In addition, the City undertook a significant effort to protect properties from damage from high lake and rive levels.

April 1, 2020

Legistar 60128:

Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for Traffic Median Revegetation Trial project.

This project will transition a selection of newly reconstructed or existing medians from turf to a low-mow pollinator friendly turf, or a short-grass prairie mix. The Contractor will maintain previously seeded medians for the fall of 2019, and prepare and seed additional existing turf medians in the fall of 2020. The proposed plan will reduce mowing needs in trial medians from once every 7-14 days, to 1-3 times a season. The project will also reduce emissions and labor costs, protect operators in high-speed, high-traffic medians, create pollinator habitat and improve aesthetics along Madison's roads.

July 8, 2020

Legistar 60869:

SUBSTITUTE- Approving roadway geometry for the construction of Cedar Street (Fish Hatchery to South Park Street), construction of South Park Street improvements, realignment of the Cedar Street and Beld Street intersection, the reconstruction of South Street (West Wingra Drive to Midland Street) and High Street (cul-de-sac to Midland Street), and the resurfacing of West Wingra Drive (Fish Hatchery Road to South Street).

Transportation Commission returned to lead with the following recommendation(s): To approve the geometry west of Park Street, and the new Beld Street realignment, and the the geometry east of Beld Street with priority to bike lanes over parking. Recommendation that there are buffered bike lanes on Cedar Street rather than parking.

October 7, 2020

Legistar 62321:

Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for Tenney Park Lagoon Biostabilization.

Project may receive funding from FEMA to repair vegetation damaged resulting from the August - September flooding. The estimated cost is \$100,000.

October 21, 2020

Legistar 62425:

Approving the installation of a new bus stop, boarding pad and bench at 449 Toepfer Avenue.

Staff held a meeting with several of the residents that live on the block of Toepfer between Birch and Meyer. The residents preferred placing the bus stop at its prior location (pre-construction) which is at 3920 Meyer Avenue. The owner of that property indicated their support in writing to the Transportation Commission. The Transportation Commission recommended installing the bus stop at 3920 Meyer Avenue.

November 4, 2020

Legistar 62862:

Approving plans and specifications and authorizing the Board of Public Works to advertise and receive bids for Thurber Lift Station Replacement.

Project includes replacement of Thurber Pump Station pumps, plumbing, electrical systems, control systems, and new building. Existing wet well and dry well will remain in place. The project will also install a new emergency generator, which the station currently does not have. The estimated cost for this project is \$550,000.

Legistar 52352:

SUBSTITUTE Authorizing the execution of an Underground Fiber Optic Conduit and Cable Line Easement to Dane County across portions of City-owned land located at 7401 USH 12 & 18.

A motion was made by Branson to Place on file. The motion failed for lack of a second. Another motion was made by Ald. Evers, seconded by Johnson, to submit the edited draft document regarding the placement of F35 Aircraft at Truax Field 115th Fighter Wing. The motion failed.
