My name is Steve Hurst. I live on Windom Way on the south east corner of Warner Park and can view it from the house. The park is a real unique City treasure as it offers our community so many multiple everyday uses year round. Our folks bought a new house back in 1965 that over looked the Park from Randy Lane. So as we grew up this special park became our back yard play ground. Over 17 plus year's ago our Father at the age of 70, Jack Hurst got involved with the Warner Lagoon Project working with many like minded individuals to help stop the run off pollution into the Lagoon. Dad has always been a conservation minded person much like Aldo Leopold was. He and I are both Yahara Fishing Club members. He was a former President and board member of that great YFC organization. He thinks about our use or abuse of the land, air, and water and comes up with solutions for a better practice. He is like the "Lorax of the Warner Lagoon". What about the water, fish, and all the living creature's connected to this habitat including people? Jack asked me to come down to the park 3 weeks ago and look with him at the water edge. So being the good son I went over with him to the two ditches surrounding the shelter house. There were thousands of dead fish along the shore! He said, this is not the worst! have seen believe it or not, but, we have to do something about this right now! So, I started to count dead fish. There were 1,978! The species are listed from highest kill to lowest kill: Bluegill, Sunfish, Golden Shiner, Black Crappie, Largemouth Blackbass, +Black Bullhead, Carp, Dog Fish, Yellow Perch, and Northern Pike. By my calculation's I estimate a 80 to 95 % fish kill on the 27 acres at Warner Park. Thousands and thousands of fish died from this Winter kill. This last week two large Snapping Turtle's died that were twice the size of a basketball in diameter. Many of us have read the free Community Newspaper, "Northside News" April/May 2021. In this month's paper was a excellent article writen by a neighbor Patrick Hasburgh close City resident to Warner park and Wild Warner member. He wrote what was true about our park,

that Spring stinks: the smell of rotting fish is a sure but not inevitable sign of Spring at Warner Park. If you have a chance please read his article, as it is the spot on truth! The Warner Park Lagoon Restoration Project has everything in place. The meetings, discussions, listening, recording of information, and contacting of key individuals involved to get this project off the ground moving forward has been done. It is time for action folks! My pitch and message to the Commission is to make history, be proactive, and release the money funds now to finish the Warner Park project! Great water means everyone wins. Allowing the spending of money is simple common sense action to progressively go "Forward" like our Wisconsin motto is all about! This is what is needed now: Carp barrier installation's at the Lake Mendota inlet, installations of three additional stormwater catch basins in our streets, and Dredging of the lagoon to a depth of 8' to 15' in some areas to support healthy fish populations, aquadic weed habitat, and spawning grounds. Thank you for the opportunity to comment on the adoption process of the Warner lagoon water quality report, aka, the restoration plan document.

My name is Kurt Welke. I am a northside resident of 1409 LakeView avenue. I served as the Wisconsin DNR Fisheries manager for Dane county from 2000-2016. Upon assuming the duties of that position, I was the account manager for funds paid from an enforcement action which were earmarked for " work within the lake Mendota watershed". Beginning in 2001, I chose to direct efforts on the Warner lagoon as a significant local uban fisheries asset. With assistance from City Engineering and the Madison Fishing Expo, several stormwater features were added along the park's north and eastern stormwater delivery conduits in an effort to mitigate runoff issues.

During the ensuing years, I partnered with the Madison Fishing Epo and the Yahara Fishing Club (YFC) in many smaller projects to upgrade the lagoon as a recreational resource. It has served as the site of the YFC annual kids fishing day for many years, with the event typically hosting 300+ kids each year. While good things occurred in the period 2001-2013, the major issue limiting any significant progress was the lack of <u>a comprehensive documentation</u> of the lagoons' challenges, opportunities, limitations, and potential alternatives to address water quality and thus potential recreational enhancement that could be realized IF the lagoon were improved .

In essence, job 1 in the lagoon is to improve water quality. Doing so will proffer conditions that allow for the establishment of healthy aquatic vegetation, control of nuisance carp, augmentation of a recreational fishery, improved user access, and control of nutrient and sediment loading.

Before you is a document which can serve as the necessary roadmap to accomplish those goals. It is based on substantial field work, data collection and analysis, complimented by substantial professional engineering, biological, and water quality experience and expertise. The document has been thoroughly and transparently shared, edited, and negotiated with all stakeholders. Most

importantly, the report has cost and time information which allow for budgeting, bidding and construction of the identified and prioritized actions therein.

While this process was lengthy and complicated by multiple issues over the course of 2 decades, we are at a point where your adoption, advocacy and encouragement can drive a significant effort to improve a valuable asset and public amenity.

I urge your adoption of the plan and thank you for helping to see this project to fruition.

This report is for you to have and enjoy and read when you need help sleeping, but it's not open for comment. Not because I don't welcome all of your comments, but because I'm leaving City Engineering, and I don't have time to change it, or go through another round of public comment. There is nothing in this report that will be surprising to anyone. Everything being suggested is what has been thoroughly

discussed and voted on. The request for additional dredging, which came up after the second public meeting, can be accommodated and is noted in the text of the report.

Although the report text will not be revised, if anyone or any group would like to submit FORMAL comments, please do so in the form of a letter or email to Janet Schmidt, whose contact information is below. Janet will include these submission in the Public Comment Appendix, which will be a "living" section to record any changes in sentiment towards projects. The final report will be introduced to the Board of Park Commissioners and the Board of Public works for acceptance and at that point it will be considered final. These meetings are scheduled for February, but may be subject to change. Feedback may also be provided at that time and additional comments that were not included in this document will be read or provided to those bodies for consideration. Additionally, everyone will have the opportunity to comment further when these construction projects can eventually be implemented.

So, that brings us to the topic that I'm confident is on everyone's mind: Next Steps. As I'm sure everyone can understand, budgets are tight right now, and the August 2018 storm revealed issues that need immediate attention for the safety of our neighbors. Janet has included \$300,000 in the 2023 budget for Warner Lagoon. No specific project has been identified at this time. This money is not guaranteed, but I allows us to start some project planning. A new Warner Lagoon project manager will kick off that process in the relatively near future.

We've received comments about the possibility of private fundraising for lagoon improvements. We would welcome this effort, and support it in any way we can. However, City Engineering will not be spearheading a private fundraising effort; it would have to be led by members of the public and would require discussions on how that would be set up to accept donations.

Thank you all again for making the Warner Lagoon Water Quality Planning effort interesting and rewarding. I look forward to seeing improvements in the near future.
