Dear Alders,

I am writing to request the planning land use map as detailed within the Oscar Mayer Special Area Plan (OMSAP) is honored and utilized moving forward. Thousands of community members worked with city staff and city leaders on this plan over the course of several years. Area Constituents worked diligently in conjunction Common Council members to come to a common ground with a plan that reflects the smart and environmentally which you approved adopted in 2020.

The current "proactive" RMX type of development and associated recommendations presented by planning staff are <u>not</u> in keeping with OMSAP nor are in keeping with the common consensus of the constituency. **RMX is not what is recommended in the OMSAP.**

OMSAP details medium and high density housing but also reflects the missing middle housing concept that is talked about in the Comprehensive Plan as well as in the OMSAP. RMX does not represent this in any way shape or form.

During the planning process, grass roots action by Constituents, led to the eventual approval by the City Council for the retention of 16 acres for wetland and wetland upland protection including the creation of an urban wetland natural area, a public natural conservation space. These 16 acres now require and deserve the protection of proper zoning. Nothing less than CN.

I do not support the proposed roadways that surround the ancient oak trees located on Roth Street. The Hartmeyer property was once an Indigenous village site from Roth Street on down to Commercial and places to the south. This is confirmed by the Wisconsin State Historic Society. Two hundred and fifty year old oak trees, sentinels that witnessed changes from wetland marsh to agriculture and a return to established wetland. Animals including waterfowl, ducks, deer, migratory birds, snakes, turtles, frogs, and rare plants thrive on this land. Despite descriptions by city staff this is an active and thriving wetland ecosystem.

The roads proposed as detailed within the current plan will destroy this fragile ecosystem if the as testified by multiple wetland resource professionals from the public and private sector during the OMSAP plan process. The City of Madison professes to be a Tree City, which evokes the perception that at all levels proceed in an environmentally sound manner. The proposed roads need to be re-route at least 150 feet outside of the largest portion of the tree crown, as the critical root zone extends far outside the tree crown. If the roads are built as proposed the wetland upland and trees will be lost.

I respectively request that you do not vote in favor of the recommended "proactive zoning" as it

does not reflect the land use that is in the OMSAP that involved extensive community input.

I also request that the City enact a more publicly direct and thorough process that involves the public and allows for a better understanding by all for what is being recommended for zoning. The Constituents have a right to learn about proposed changes in zoning and all other issues affecting the future of their neighborhoods through direct personal engagement, town hall meetings, mailings rather than the slight of hand methods currently employed where actions are passed and the Constituents find out after the fact.
