My general question that I share with some of my other affected neighbors is based on the average listed (approved/proposed) expenditure in column J for areas assigned the 25 top point values:

If we use the average proposed expenditure by point for the top 25 areas as a metric, is it possible for us to be allocated funds for traffic calming based on our current point assignment? If this dollar value is not sufficient to install (for example) two speed humps, could the members of our neighborhood fundraise to make up the difference to reduce the dangerous speeding that happens here?
