Re: Common Council Hearing on May 4, 2021

The Forster Drive Resurfacing project was presented to the Common Council for approval of plans, specifications and special assessments on May 4, 2021. The project was referred to the Common Council meeting of May 18, 2021. City staff has since met with Alder Charles Myadze to discuss the project. It has been determined that a substitute resolution will be presented at the May 18<sup>th</sup> Common Council meeting to modify the payback period for assessments from an eight (8) to fifteen (15) installment period.

After the work is complete, a final assessment will be calculated based on bid prices and work actually performed. The final assessment is payable in one lump sum or over a period of 15 years, with 2% interest charged on the unpaid balance. In order to avoid any interest charges the assessment will need to be paid in full by October 31, 2022. If you choose the installment plan, you have up to 15 years and can also pay off the assessment earlier without penalty.

Attached is a summary of a 15 year payoff period for the median assessment of \$8167.
