Hello

I am writing in support of the TDM ordinance. I am thrilled to see such a program proposed. I agree that decreasing VMT is key if we want to meet our climate goals, decrease air pollution, and create a more welcoming and sustainable city for all people. It also means that things will be much more consistent for all developers, so there is not horse trading with opponents of a development.

The only feedback I have is that it seems there is a fee in lieu option for an unlimited number of points. I am not an expert in this, but it seems to me that there should be some sort of cap-like maximum 2 points? It is important that all developers are *actually* held to the same standard, rather than allowing them to pay their way out of it. Especially when some of the items are probably far less than \$10,000 to accomplish. Things like wayfinding signs, a real-time arrival system in a building lobby, or preferential carpool parking would cost much less than \$10k. Hopefully people will see that calculation and do it instead, but I think a cap of 2 points would be reasonable.
