Hello Park Commission.

I would like to register opposition to closing the section of Vilas Drive as proposed in item 66344. I understand Alder Evers and a neighborhood survey, showing 50% of survey respondents (number of respondents?), support closing the drive. I would appreciate it if you would consider the equity of closing this portion of the drive before making a decision about the proposal.

Please realize there are neighborhood residents such as myself who do not agree with the equity or necessity of closing this section of the park to cars. Where is the city's data regarding any safety issues? Are there records of problems or accidents to support the closing? Is there any data about the number of people from outside the neighborhood who use the park? Who does the park serve? Were general users surveyed about use or the proposal? What about the people from outside the neighborhood who use the park?

Keeping the drive open one way allows park users who arrive by car to enjoy the shoreline for recreation as well as greater access to the park in general. There are often people parked as allowed along the drive to enjoy a sandwich in their car with a view of the lake, to park near a fishing site or picnic spot. I often see families with their gear or people enjoying even just reading in a chair with their car parked close by. Walking to these spots with gear or for mobility-restricted people is very difficult. (A gravel path as proposed will not be passable for a wheelchair for example, or many elderly people.) Parked cars do not impinge in the use of the pedestrian path as currently marked or for traffic.

There is greater diversity of park users by allowing the drive to remain open, in my observation. More Madison residents who do not live the neighborhood, including people of color, have ready access to the

park by being able to use the drive. (Data would be able to be collected from users if such a survey was done.) The safety issues for pedestrians and bicyclists may be dealt with other ways besides entirely closing off use to the many Madison residents who use their cars to enjoy the park and lake. I hope consideration has been given to possible alternatives, for example, perhaps partial closings such as done with Arboretum Dr. or other solutions which will allow access by car to continue.

I previously sent written comments and spoke at meetings during this process. I respectfully submit my comments again for your consideration. I am simply pointing out another view of the current proposal. I appreciate that you are interested in listening.

Thank you for your work on the park plan which has so many commendable aspects. Vilas Park contributes to the vibrancy of life in Madison and to building community through access to recreation. It is an invaluable resource for the citizens of Madison, as is the entire the park system.

To the Board of Park Commissioners,

I am writing in support of the proposed interim solution for Vilas Park Drive. I have served as a member of the Resident Resource Group for the Vilas Park Master Plan process as well as a resident member of the city working group examining interim options for Vilas Park Drive. I live in Vilas and am a frequent user of Vilas Park.

I very much appreciate the work of Parks and Traffic Engineering staff on this issue. There is high interest in making Vilas Park Drive safer for pedestrians and bicyclists that is shared by Parks, Traffic Engineering, and many of the users of Vilas Park. However, I want to point out that this effort goes beyond just how the drive is used. Traffic on Vilas Park Drive affects how Vilas Park itself is used. During the Shared Streets program, the lack of cars on Vilas Park Drive produced park use in previously neglected areas. Park users enjoyed the Lake Wingra shoreline in a whole new way—it was a vibrant part of the park. Once cars returned to Vilas Park Drive, people reduced their use of the park near the drive.

I strongly support option one—two-way traffic from the east to the shelter lot—because this option improves safety issues at both ends of Vilas Park Drive. While it will take the implementation of the master plan recommendation for the drive to fully improve the safety issues on Vilas Park Drive, this option will be a significant improvement over the current situation.

The drive has one end by Edgewood Avenue that includes a historic bridge. This bridge is lovely, but it is very narrow. Accommodating pedestrians, bicyclists and cars in the limited space

on the bridge is difficult. Pedestrians and bicyclists do not feel safe sharing the bridge with cars, which are often travelling at high speeds and using the drive as a cut through route, despite the posted speed limit of 15 mph and "park users only" signs.

The other end of Vilas Park Drive is by the zoo. At this end, there is no clear space for pedestrians and zoo visitors to walk, and frequent flooding limits the space available for pedestrians, bicyclists and cars driving to the zoo or beach. Adding in cars that are using the drive as a cut through contributes to the safety risks at the zoo end of the drive.

Option one improves both ends of Vilas Park Drive. Creating a vehicle free section that includes the historic bridge stops the pedestrian/bicyclist/car conflict at the bridge and ends the use of the drive as a cut through route. The planned ped way and buffer zone create a clear space for pedestrians throughout the drive, most importantly at the zoo end of the drive. The zoo end of Vilas Park Drive will also benefit from the end of cut through traffic as it will reduce, at times substantially, the number of cars using the drive. I also think this option will allow people from Madison and the surrounding areas to enjoy the lake shoreline in Vilas Park.

Thank you for your consideration, and I urge the Commission's support of this proposal.

Dear Board of Parks Commissioners,

I serve on the city's Transportation Commission, am the executive director of the Wisconsin Council of the Blind & Visually Impaired, and live with vision loss. I am in general support of the intermediate traffic plan for Vilas Park, but wish to bring your attention to the need for additional signage and other measures to assure that the park's roadway and adjacent paths are as accessible for people with disabilities as possible during this transition period.

This project was brought before the Transportation Commission on April 28. During that meeting, support for the plan was expressed by the commission. Additionally, I appreciated the cooperation between the residents, alder, and staff to develop a preferred option. However, a couple of fellow commissioners and I raised concerns about accessibility for people with disabilities; primarily those using mobility devices and those with vision loss. One suggestion was to narrow the bike lanes when possible to give increased space for pedestrians. However, the response from parks staff felt insufficient for creating increased safety and accessibility for vulnerable users.

I followed up with Renee Callaway from Traffic Engineering and Anne Freiwald from Parks to explore other low-cost measures to increase usability and accessibility. Renee suggested additional signage to guide cyclist behavior to better accommodate the space for pedestrians. I believe Renee's suggestions, plus narrowing the bike lanes in places like the bridge, will help increase accessibility and make the park drive more welcoming for all users. I ask that you inquire about these increased safety and accessibility measures this evening to be sure they are included in the final plan. I am unable to attend this evening's meeting to speak to these issues directly as the Transportation Commission meets at the same time.

In general, I'd like to ask the Board of Parks to hold a high standard for accessibility of Madison's disability community and visitors. Our parks are beautiful, offer respite from busy lives, and places to gather with friends and loved ones. Our parks need to be welcoming spaces for all, including people with disabilities, if we want to truly be a city that promotes equity and inclusion. I've appreciated the efforts to enhance accessibility of parks in the master planning process and have been involved in some of this work. I'd ask that you apply a filter of equity

even in these intermediate and smaller projects. There are often low cost and simple solutions that can be implemented that create enhanced usability, accessibility, safety and equity for people living with disabilities. I am happy to consult with staff on these issues as are my colleagues from other disability serving organizations in the city.
