Re: Survey for the Construction of Traffic Calming Devices on West Lakeside Street

Dear Resident/Property Owners,

Residents have requested traffic-calming on West Lakeside Street. The City Traffic Engineering Division, in response to that request, has performed a speed study and ranking of this project, which has indicated that this project would be eligible for funding from the Neighborhood Traffic Management Program (NTMP).

The form on the reverse side of this page is to ask your opinion of this project.

Speed humps are our most effective speed control devices and can help maintain the residential nature of a neighborhood. The preliminary design incorporates two speed humps, as shown on the attached map. These speed hump locations have been coordinated with Madison Fire Department. Additional speed humps beyond the two shown have been deemed to have an unacceptable effect on emergency vehicle response.

In addition to the two speed humps, we are proposing a traffic circle at the Whittier Street intersection. Traffic circles work to slow vehicle speeds by requiring the driver to deflect around the circle. The circle is designed to be the maximum size while still allowing a vehicle the size of a Metro Transit bus or fire truck to make all turning movements at the intersection. Left hand turns in front of the circle are allowed and a legal turning movement.


