I am in strong support of Madison approving spaces for permission DIY all-wheelspots. This is a great way to get wheelspots/skateparks for free! The materials will be gathered and the labor will be done grassroots style by passionate folks like myself, community, and friends. Good Afternoon,

I am writing in regard to the proposed all wheel park at Elvehjem Park. I live on Painted Post Drive and have several concerns.

The so-called "defunct Elvehjem tennis courts" is proposed as a location for a new all wheel park. The only reason the tennis courts are run down is because the city doesn't take care of them. The Elvehjem tennis courts are, in fact, used on a daily basis by those of us living in the neighborhood. My husband and I play pickleball, my son and other neighbors play tennis or pickleball there multiple times each week. I would like to continue to be able to walk to my neighborhood park and use the courts, rather than driving to another location!

My children and the children of neighbors have taken tennis lessons at Elvehjem park, and it is a wonderful setting.

Another concern is the lack of available parking for increased use in the park. There is not a parking lot other than the small lot for Elvehjem school. This lot is full during school and used frequently by families with young children utilizing the playgrounds during the evenings and weekends. All summer long there are elementary school aged children who walk or ride their bikes to and through the parking lot to access the playgrounds and the school gardens. It is a place of community gathering for families and children in the neighborhood and has always been a safe location.

I am concerned about increased traffic both in the parking lot and on the small neighborhood streets; Painted Post Drive and Academy Drive. Unlike the Warner Park area, which is also a proposed all wheel park location, there are no major streets to handle the increase in traffic. There are many families with young children in our neighborhood and increased traffic will decrease the safety of our streets.

I'm also concerned about the number of cars parked on the street, and who this is going to draw into our neighborhood. We have a quiet, safe neighborhood and I am concerned about the nature of that changing with people from outside the Elvehjem neighborhood drawn in to use the skate park.

The article describes the current skate park at McPike Park as a destination park that people travel to from all around Wisconsin and the Midwest! How many of those people will be curious to see the newly developed all wheel parks and start venturing into the Elvehjem neighborhood? I am concerned that our safe, quiet streets will have increased traffic, increased parked cars on the street, and potentially no longer be an area children can visit freely to play during the summers and weekends.

Please don't make this change to our wonderful neighborhood!
