We've issued 18 orders.

MARCH 13

Issue first order restricting gatherings to 250 people

MARCH 16

Issue order closing schools and limiting gatherings to 50 people

MAY 13 (Order 1)

Dane County Safer at Home order goes into effect

MAY 18 (Order 2)

Phase 1 order goes into effect which opens most businesses to 25%

MAY 26 (Order 3)

Phase 1 order goes into effect which opens most businesses to 25%

JUNE 5 (Order 4)

Issue order revising mass gathering criteria

JUNE 15 (Order 5)

Phase 2 order goes into effect which opens most businesses to 50%

JUNE 25 (Order 6)

Reduces gathering size; people in bars & rest. must be seated

JULY 2 (Order 7)

Reduces gathering size; closed indoor bar service

JULY 13 (Order 8)

Requires masks in some settings

AUGUST 21 (Order 9)

Required grades 3-12 to start the year virtually

NOV 17 (Order 10)

Eliminated indoor gatherings of all sizes

DEC 15 (Order 11)

Increases indoor and outdoor gathering limits

JAN 12 (Order 12)

Increases outdoor gatherings

FEB 8 (Order 13)

Increases gatherings, allows sports, enhances masking requirements

MAR 10 (Order 14)

Increases gatherings, allows sports, enhances masking requirements

APR 7 (Order 15)

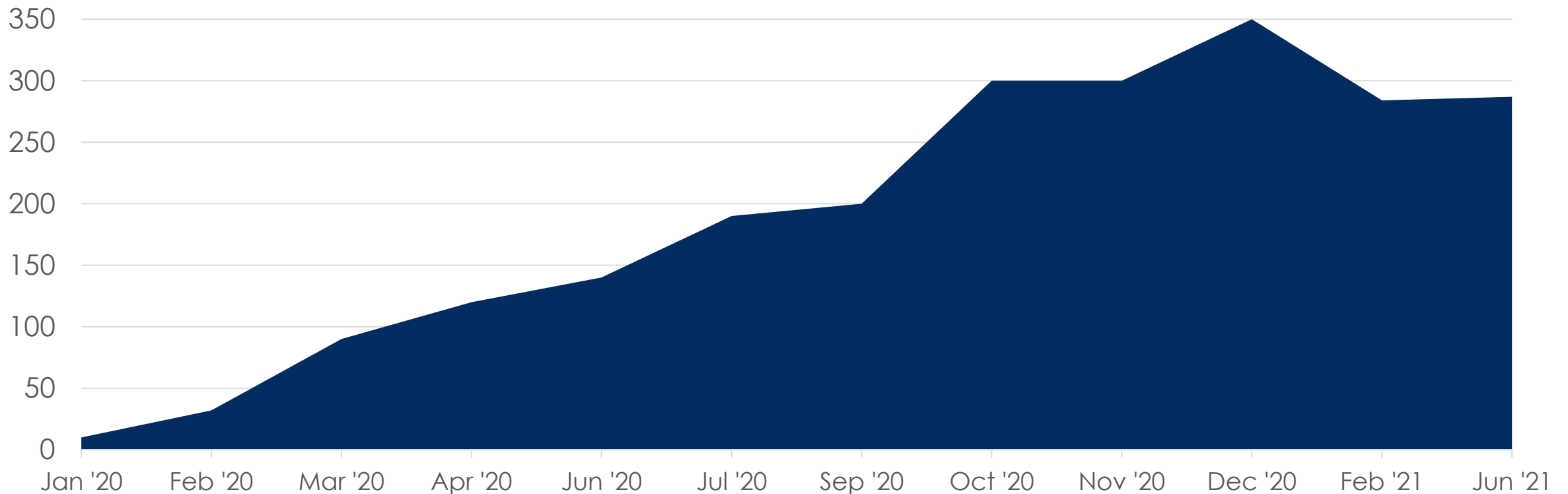
Increased outdoor gatherings, no masking required outdoors

MAY 5 (Order 16)

Capacity limits increased for businesses and restaurants/taverns

Testing Update

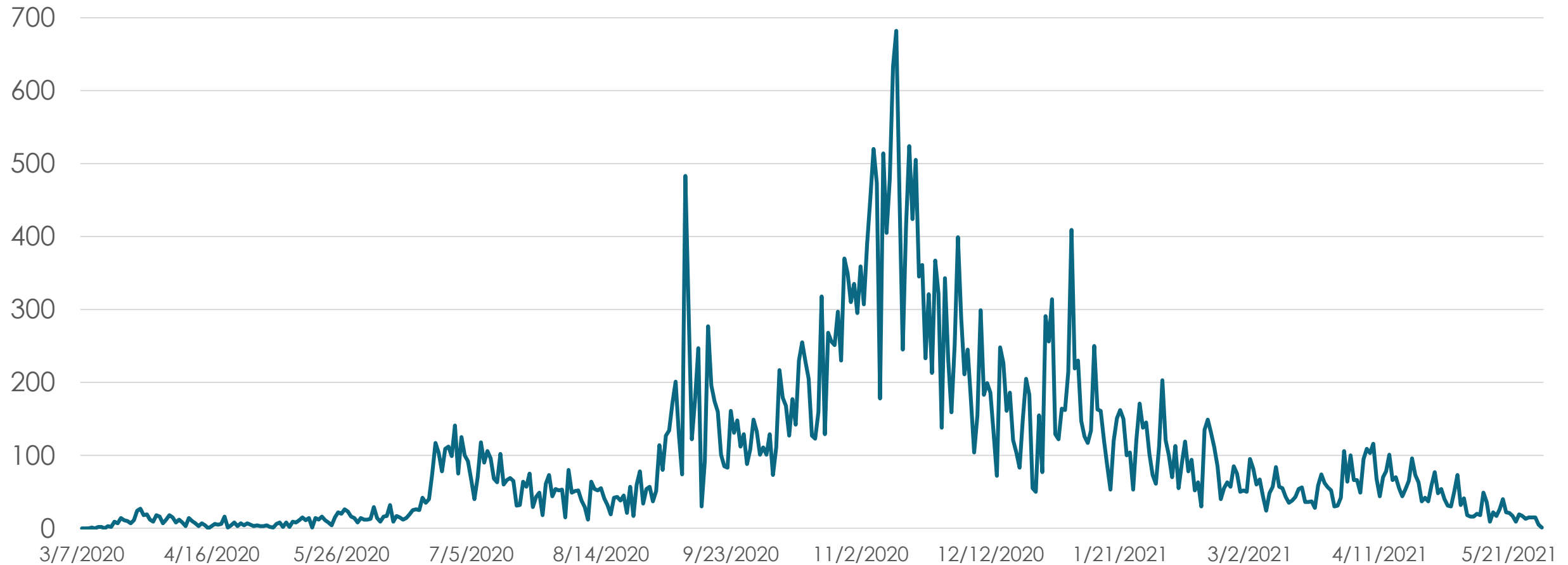
As of June 7:

South Madison test site:
12,793 tests

Alliant test site:
426,445 tests



44,800+ people have tested positive for COVID.



Contact Tracing

Almost 45,000 confirmed and probable cases

+48,425 contact investigations

=Almost **100,000 people** followed-up with during the pandemic so far

We've also conducted nearly 1,800 facility investigations

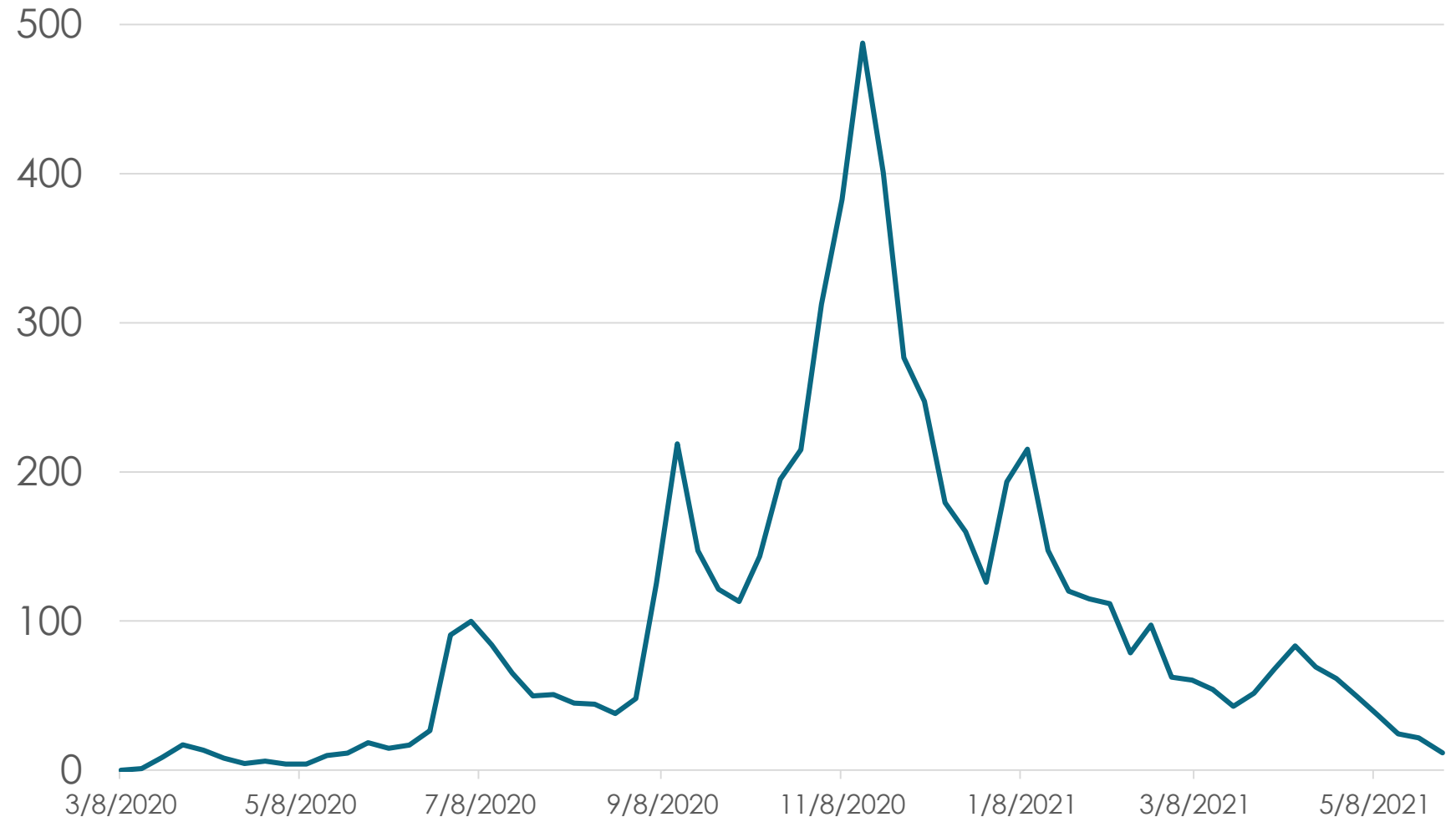

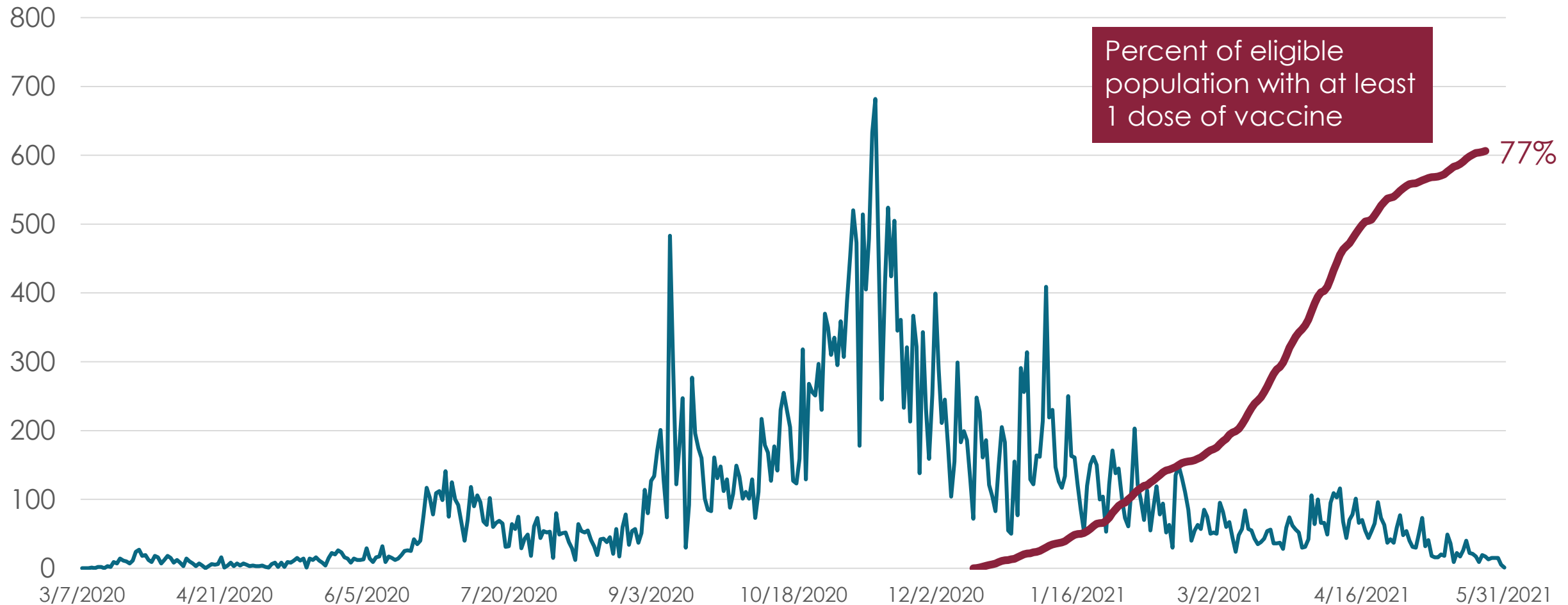

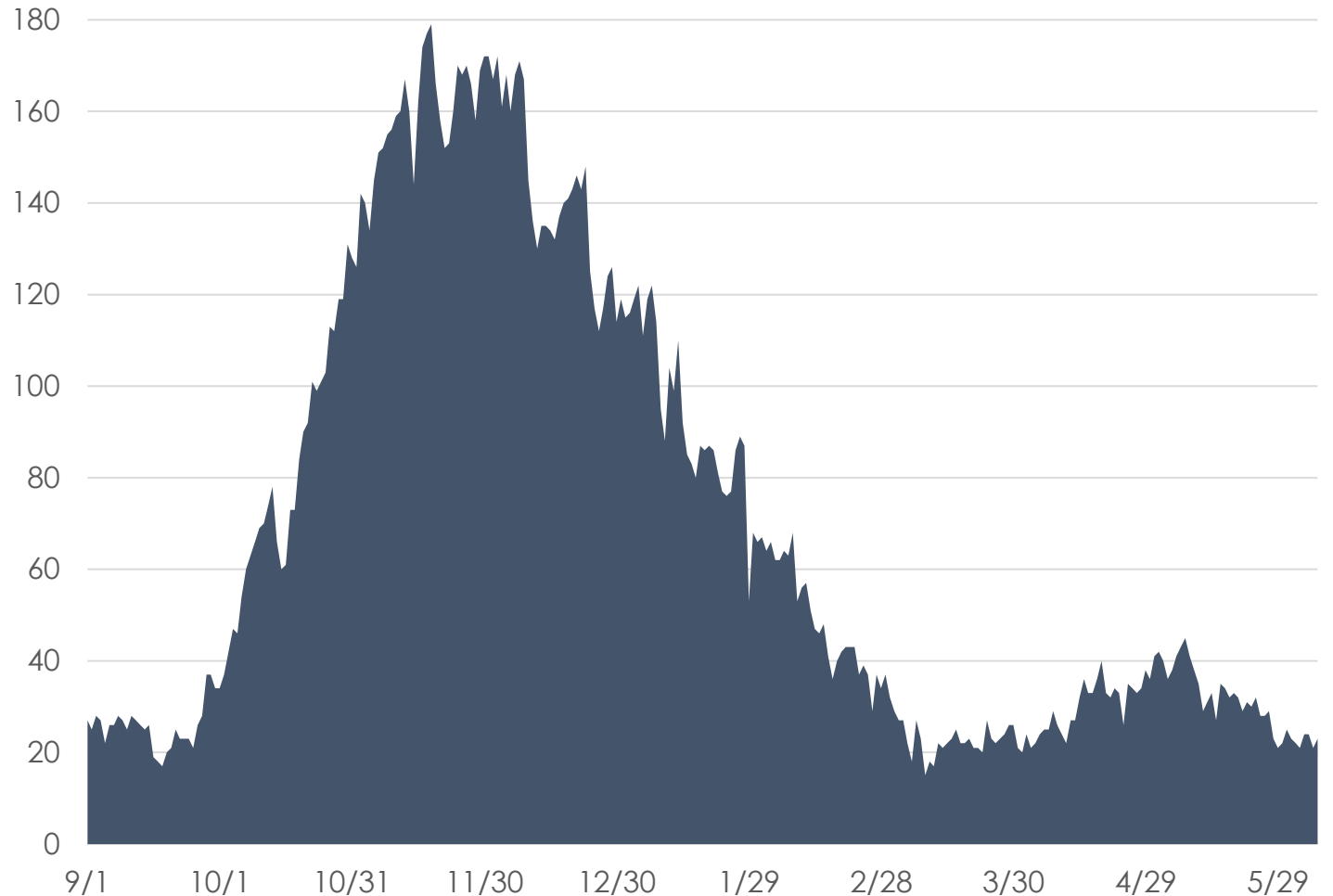
As vaccination has gone up, cases have gone down.



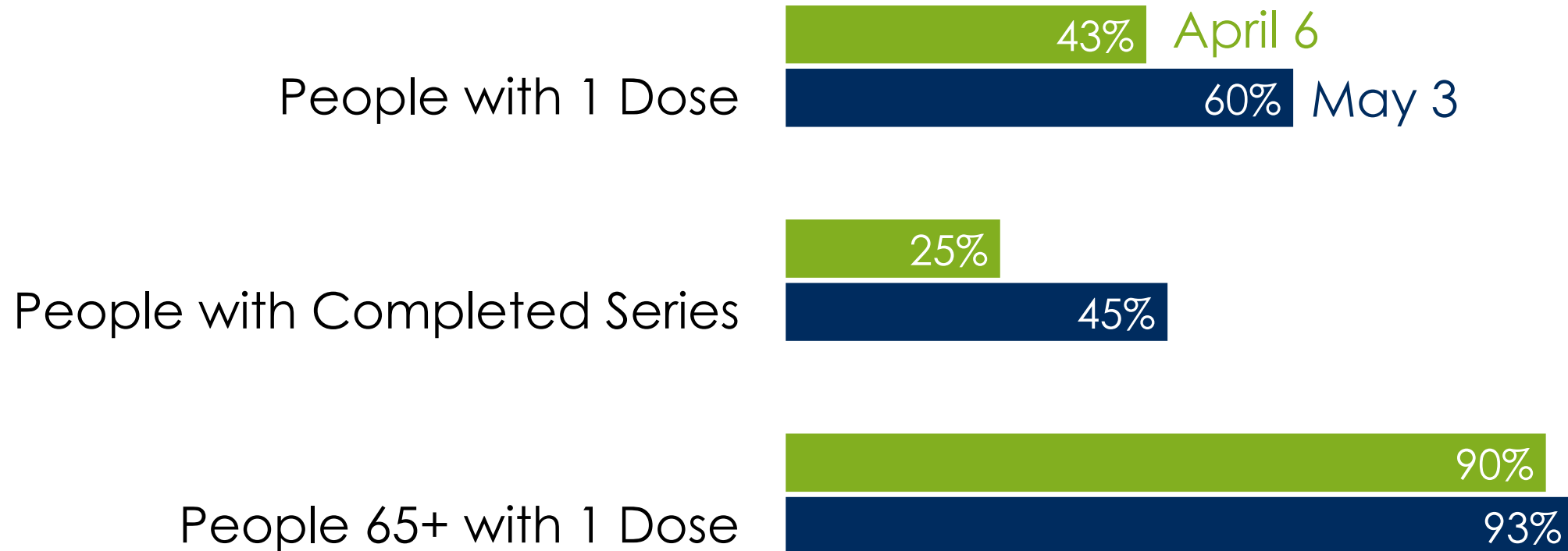
Hospitalizations

were in late fall.

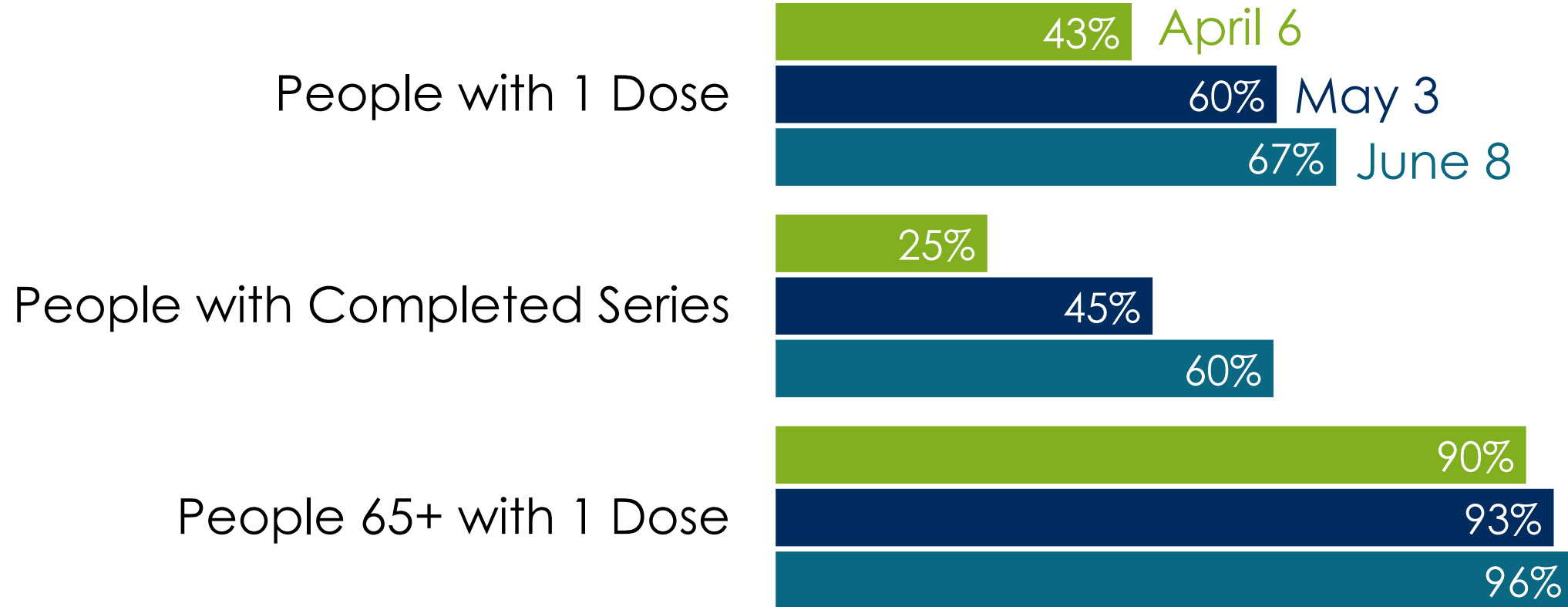
Today there are 23

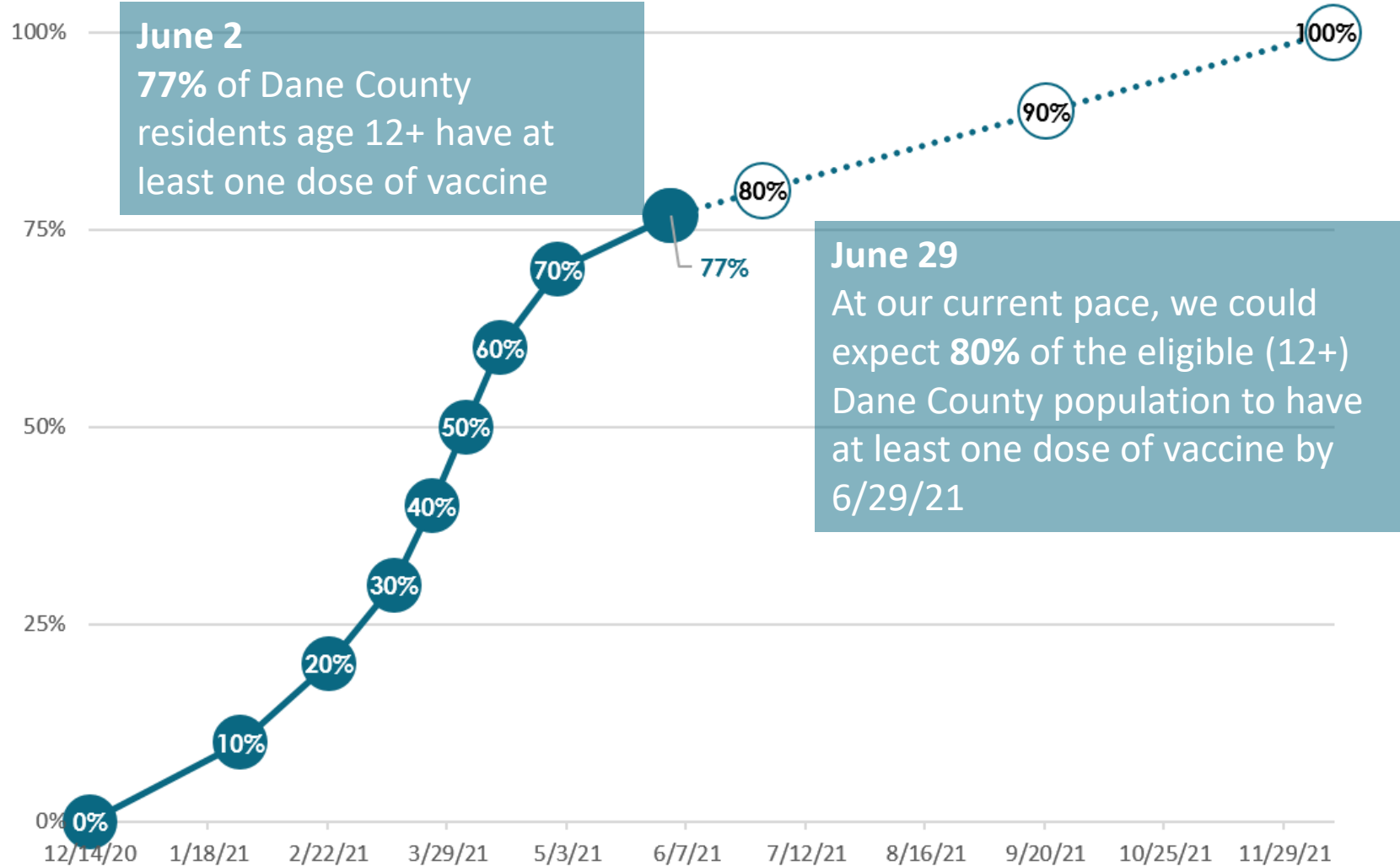

Share of Dane County residents age 12+ with at least one dose of vaccine

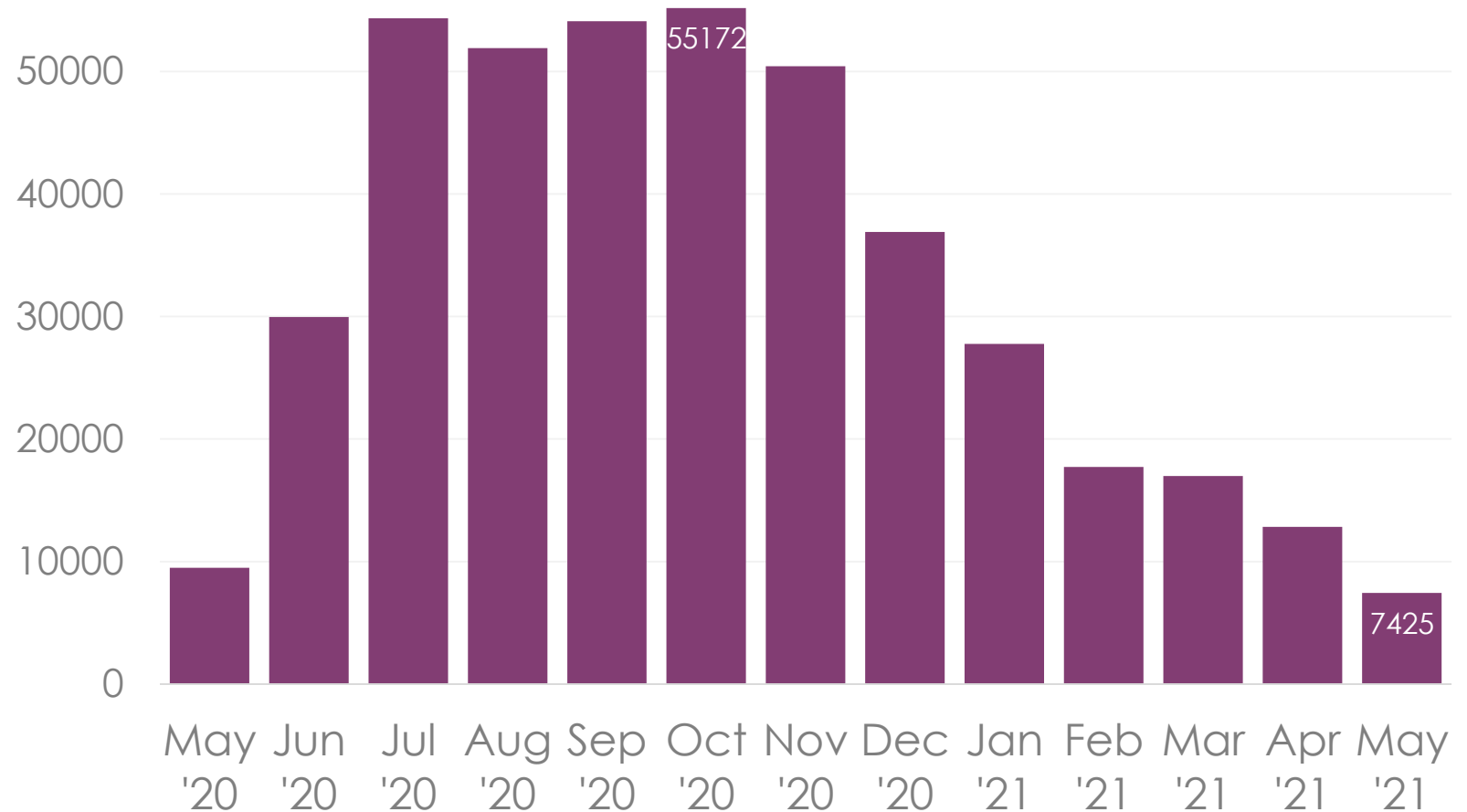
● actual

Transitioning Testing

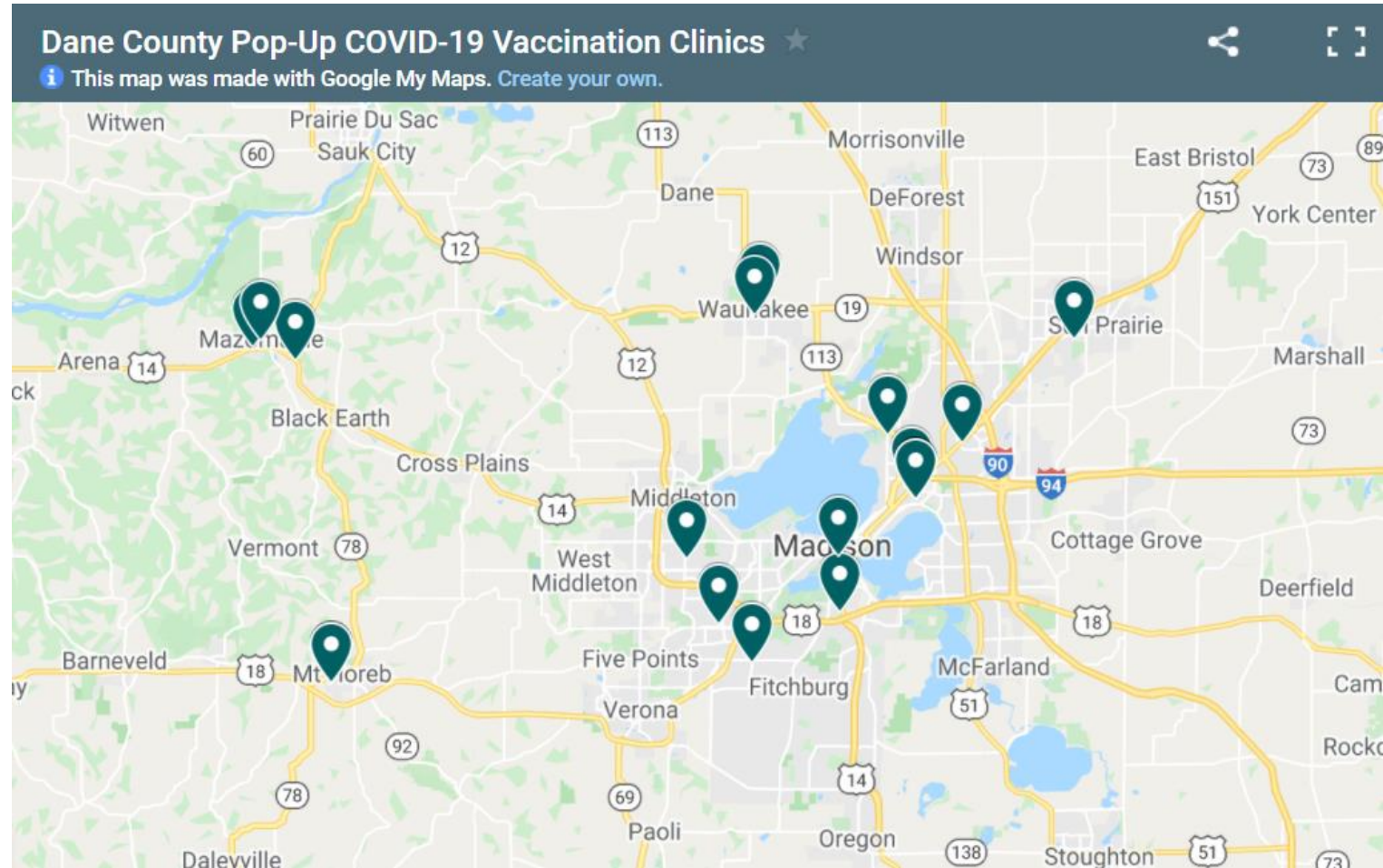
Given the decline of testing at Alliant and the options throughout the community, we'll be moving testing to South Madison on June 29:

- Tuesdays (8-4)
- Thursdays (12-8)
- Saturdays (8-4)



Transitioning Vaccination

We are also transitioning to providing mobile clinics and vaccination at our permanent sites so we can vacate Alliant.
