Adopting the Joint Transportation Commission and Transportation Policy and Planning Board Traffic Calming Subcommittee Final Report and all of the included Priority Recommendations, adopting and implementing the new Safe Streets Madison program, and terminating the existing Neighborhood Traffic Management Program

Body

WHEREAS, the Joint Transportation Commission and Transportation Policy and Planning Board Traffic Calming Subcommittee was created by the Transportation Commission and the Transportation Policy and Planning Board, with the Joint Resolution approved by the Transportation Policy and Planning Board on February 3, 2020 and approved by the Transportation Commission on February 12, 2020; and,

WHEREAS, Subcommittee members included Brigit Brown, Ald. Grant Foster, Harald Kliems, and Tom Wilson; Subcommittee alternate members included Bill Bremer and Ann Kovich; and former Subcommittee members included Badrinath Lankella; and the Subcommittee was staffed by Renee Callaway, City Pedestrian Bicycle Administrator, Patrick McGuigan, Recording Secretary, Thomas Mohr, Traffic Engineer, and Yang Tao, City Traffic Engineer; and,

WHEREAS, the Subcommittee first convened on July 16, 2020 (since Subcommittee meetings were delayed by the pandemic) and met over a series of twenty-nine (29) meetings to review significant background information, outline a work plan, and develop Priority Recommendations regarding opportunities to improve traffic safety and pedestrian and bicycle connectivity and safety; and,

WHEREAS, the Subcommittee was tasked with developing and issuing a Final Report that identifies opportunities to improve outcomes and processes related to: traffic calming, safety enhancements, and pedestrian and bicycle system enhancements in the City of Madison (including, but not limited to, the Neighborhood Traffic Management Program and the Pedestrian Bicycle Enhancements Program), with a goal of equitable distribution of resources that improves safety and encourages increased walking and biking across the city; and,

WHEREAS, the Subcommittee forwards all of the Priority Recommendations shown in Section V of its Final Report for immediate confirmation and adoption by the Common Council in the following focus areas:

- Creation of the New Program - Safe Streets Madison
- Safe Streets Madison Program Priorities
- Balancing Priorities in the Safe Streets Madison Program
- Prioritizing and Evaluating Requests in the Safe Streets Madison Program
- Determining Solutions and Interventions in the Safe Streets Madison Program
- Potential Barriers to Safe Streets Madison
- Implementation of the Safe Streets Madison Program; and

WHEREAS, as noted in the Priority Recommendations shown in Section V of the Final Report, several existing programs and projects are being consolidated into the new Safe Streets Madison program; and budget accounts and/or funding for these existing programs and projects would also be consolidated into available funding for the new Safe Streets Madison program; and,

NOW, THEREFORE, BE IT RESOLVED, that pursuant to M.G.O. Section 2.27(3) the Common Council adopts the Final Report of the Joint Transportation Commission and Transportation Policy and Planning Board Traffic Calming Subcommittee; and,

BE IT FURTHER RESOLVED, that pursuant to M.G.O. Section 2.27(3) the Common Council adopts all of the Priority Recommendations shown in Section V of the Final Report; and,

BE IT FURTHER RESOLVED, that the new Safe Streets Madison Program be adopted and implemented under the direction of the City Traffic Engineer with cooperation from all appropriate City departments and divisions, as noted in the Priority Recommendations shown in Section V of the Final Report; and,

BE IT FURTHER RESOLVED, that in order to create the new Safe Streets Madison program as outlined in the Priority Recommendations shown in Section V of the Final Report, several programs and projects are consolidated into Safe Streets Madison, including the Neighborhood Traffic Management Program which was created by resolution as approved by the Common Council on August 19, 1997; and that the Neighborhood Traffic Management Program be terminated, with its traffic safety functions transferred into the Safe Streets Madison program; and,

BE IT FINALLY RESOLVED, that adopting the Final Report and adopting all of the Priority Recommendations shown in Section V of the Final Report means that the Common Council agrees with all of those Priority Recommendations, adopts them as the policy of the City, and expects the City, Agency, and Staff to follow and implement them.
