Noise. For the past 18+ months, many of us have gotten a respite from noise as the world slowed in response to the Covid pandemic. Indeed, loud noise is more than just a threat to your hearing and your quality of life. New research suggests it can seriously damage our health. According to AARP (American Association of Retired Persons), **noise is the new secondhand smoke**, and we all know where that has gone in the last 20 years.

So why would we deliberately subject people to more noise by building a development on the Raemisch Farm property (between Packers/CV and Sherman) where the noise from the airport is already dreadful and likely to get worse when the F-35 jets come to town in 18 months.

Noise is measured in decibels. Some examples:

Passenger jet (a mile from takeoff): 106 dB F-16 jet (1.5 miles from takeoff): 80 dB Birds chirping: 44 dB Leaves rustling: 20dB

According to a recent study in the journal *Environmental Research*, daily noise exposure may figure significantly in a person's risk of severe stroke. Researchers found that living in a noisy area—like next to an airport or highway—increases one's risk of severe stroke by 30%, while living in a quiet, green area can reduce it by up to 25%.

Here's how this works. An incessantly loud environment stimulates a part of the brain which regulates stress response. The brain reacts by increasing blood pressure and levels of a stress-related hormone (cortisol), both of which are known to cause a host of cardiovascular issues, including stroke. In fact, the American Heart Association warns of an increased risk of heart attack for those regularly exposed to excessive noise, the kind found near airports and highways.

Chronic stress is also a well-established contributor to deaths related to immune system suppression, diabetes, arterial plaque buildup, psychiatric illness, and possibly cancer.

Dane County Airport noise has increased dramatically over the last 25-30 years as more flights to increased destinations increase the number of passenger jets and as the Air National Guard has moved up the ladder from A-10s (warthogs), to F-16s, and soon the F-35s. Noise from the airport is now making near east and northside neighborhoods unbearable; vibrations make houses shudder and shake as jets take off, circle, and land; and conversations (including home schooling) are near to impossible as noise only increases. And then there's the additional noise as the Guard revs engines, cleans jet pipes, and hover helicopters incessantly at the airport.

While noise is the greatest concern to this development, other issues include drainage/runoff; pesticide contamination; transportation and traffic; major disruption to wildlife and the ecosystem; and Lake View School's outdoor classrooms.

Why would the City of Madison deliberately put people's lives at more risk by approving a development on the Raemisch Farm property?
