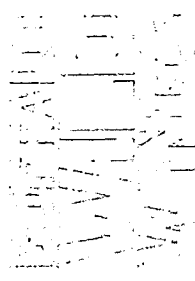

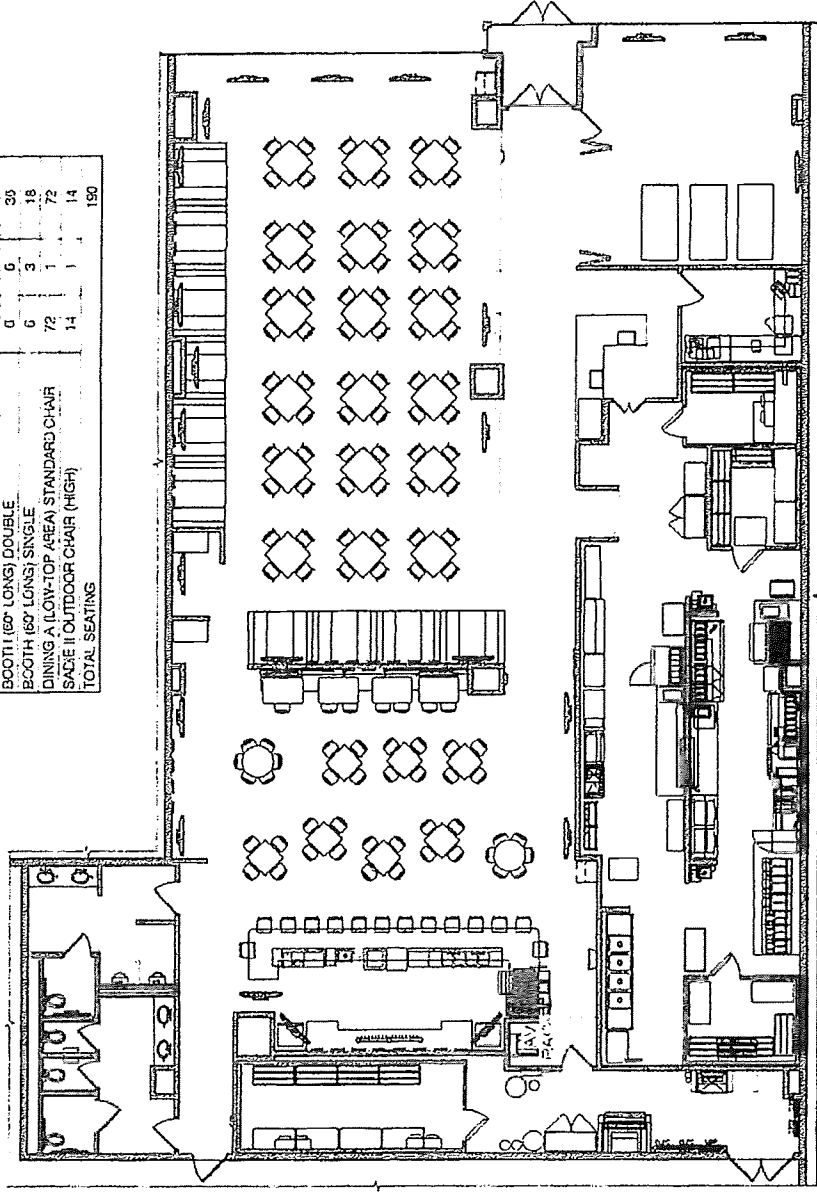

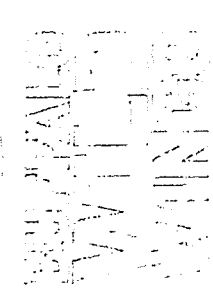
Current floor plan

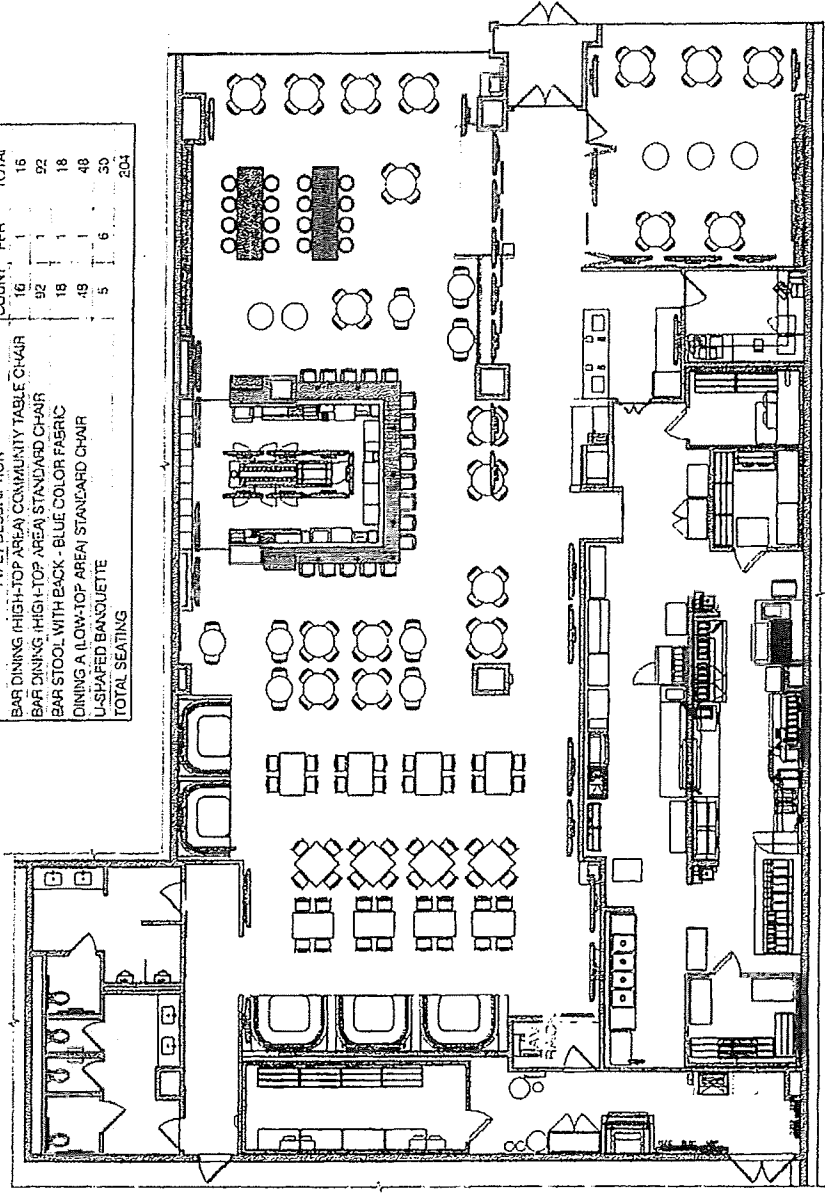
