Title

Amending Section 33.55(4) of the Madison General Ordinances to remove the option for an Alder to serve as an officer of the Transportation Policy and Planning Board.

Body

DRAFTER'S ANALYSIS: This ordinance amendment removes the option for an Alder to serve as an officer of the Transportation Policy and Planning Board, consistent with the rule for all other subunits except the Common Council Executive Committee. The ordinance will first affect officers elected after the next spring election and would not terminate the term of any current officer.

The Common Council of the City of Madison do hereby ordain as follows:

Subsection (4) entitled "Board Procedures" of Section 33.55 entitled "Transportation Policy and Planning Board" of the Madison General Ordinances is amended as follows:

"(4) Board Procedures. The Board shall follow the procedures contained in Sec. 33.01, MGO, ~~except that notwithstanding Sec. 33.01(7)(b), MGO, a Common Council member may serve as chairperson, co-chairperson, or vice-chairperson of the Board.~~"
