I regret that we have been unable to resolve this issue to date. At this point I have limited suggestions on how to move forward which follow.

To the extent that your e-mails can be categorized as either 1) a request for an adjustment to the City Engineer's measurements of total area, impervious area and/or pervious area of your parcels under MGO Sec. 37.05(4)(c), or 2) a request for a fee adjustment or credit under MGO Sec. 37.05(4)(d), the City Engineering Division has reviewed your submissions and has made final adjustments as noted previously. Modifications were not made to the total area, impervious or pervious areas, but wetland credit was granted to one parcel based upon the City's approved Rate Adjustment and Credit Policy. Please consider that determination final as of the date of this e-mail.

Pursuant to MGO Sec. 37.05(4)(e) and 37.05(13), you have fifteen (15) days from the date of this e-mail to appeal this decision to the Board of Public Works. Notice of appeal shall be filed with the City Engineering Division, in writing at 210 Martin Luther King Jr. Blvd., Room 115, Madison, WI 53703. If an appeal is sought, please include the basis for the appeal.

Mr. Gausmann-

Parcel 07102402073 is 3.32 acres in total and has 1.74 acres of wetland according to WDNR surface water data viewer wetland layer.

The credits for the wetland area for this month (May) plus the wetland credits for each billing cycle since January should be applied to your next bill. There is not a line item that shows up on the water bill for the credit.

As a reference, the current credit policy, section 3.6 states:

Customers who own parcels of land that are zoned as wetlands or designated as wetland by a regulatory authority, shall, upon request, be entitled to a reduction of one-half of the area within the defined wetland. This adjustment shall be calculated prior to the adjustment provided by Paragraph 3.2.

The runoff from wetlands varies from site to site. A wetland can be considered a pond, in which all runoff would be expected to flow from the site. In the alternative, a wetland may be found to not discharge any water during a storm event. This adjustment is an average and does not preclude a property owner determining the runoff from a particular wetland with a more rigorous analysis in accordance with Paragraph 3.4 or 3.7.

Paragraph 3.4 and 3.7 are list below as a reference.

3.4 Customers may provide more specific data with regard to the measurement and calculation of impervious or pervious area.

3.7 Customers who own parcels of land used for Conservation purposes or parcels that have special or unique runoff circumstances may provide independent run-off calculations, to determine a percentage reduction in pervious area. The amount of the reduction will based upon the runoff generated, compared to a normal pervious surface with a runoff coefficient of 68. The percentage reduction is subject to the approval of the City Engineer.

Rate adjustments due to independent run-off calculations shall remain in effect until conditions change to alter the runoff characteristics. Customers shall promptly report any changes to the City Engineer. At the time of application, the customer or his/her agent shall provide all necessary information to the City Engineer to document eligibility. This information could include runoff calculations, monitoring results, documentation of a double ring infiltrometer test, or other evidence, stamped by a registered professional engineer.
