#### 4. 80024

Late Night Vending planning: updates, input gathering and timeline for creation of a program for 700/800 State Street Night Vending Area for the 2024-2025 vending season, per MGO 9.136(1)(n)3.c.

Staff presented results from focus group and e-mails and conversations with Council Members and food cart review.

#### Staff discussed comments from vendors:

- Lighting concerns would like additional/better lighting
- Extra security not to be provided above what is normal
- Late night vending is not a special event
- Having more than three vendors with five and twelve being the suggested range from respondents. Vendors think 4+ is best for safety.
- Questions about fees: there are not answers for yet, additional discussion needed
- Disappointment of the group if hours are reduced to 12:30am there would be
- Seniority points: currently this is used and part of food cart review.
- Start time at 4pm could impact current Mall Concourse Carts. Some vend until 6pm
- 4pm time may need to be reviewed/discussed
- How do we safely get the carts out if there are lines at 12:30 a.m. Same issue between the day vendors and light night vending. Committee suggestions:
- Move to the 700 block is very important for safety.

#### **Committee suggestions:**

- Start end times need training for police and coordination.
- Hour suggestion may change to 7pm or 8pm- 12:30am
- Marketing to better prepare customers for new hours
- Possible grants available to help purchase line management systems/equipment
- Inquire with streets about better lighting options
- Number of vendors: 5
- Push back start time
- Share with City Attorney to start drafting the ordinance & move up Council introduction date of ordinance

#### Suggested next steps:

- Start drafting something.
- Move forward with recommendations
- Very tight timeline
- Equity analysis
