Marsh discussed the Early Care Initiatives funding process for \$500,000 in 2023. A provider feedback survey went out in mid-February. An input session is scheduled for February 23. The ECCEC will approve the concept paper on March 9. Funding recommendations will come to ECCEC in summer. Previous funding priorities were Direct Funding for Centers, Consultation Services and Training for Early Care Professionals. Updated priorities are Direct funding for Child Care Providers, Social Emotional Supports and Training, Support Child Care Startups and Expansions. Marsh presented a PowerPoint with further information.
