A motion was made to approve, seconded by Lovelace. The motion was rescinded.

A motion was made by DeChant, seconded by Garcia, to approve Option B

Madison made a friendly amendment, seconded by Carter, to amend the motion on the table to draft an option C which will:

Eliminate the Business Operations Manager position and use the funding for

- Monroe Street Library 2 days per week

- Dream Bus operations (two thirds of annual operations, Foundation commitment

will fund remainder in 2025 & 2026. Will need an additional \$5,000 in 2027 to fully

fund service at current level and an additional \$31,000 in 2028)

AND

- Assuming the cost to continue budget is approved by November, the library intends to create through vacancies 3 new systemwide positions to support the development of the Imagination Center at Reindahl Park

A motion was made by Madison, seconded by Carter, to take up item 6 before item 5. The motion passed by voice vote/other.

A motion was made by Garcia, seconded by Madison, to Take A Recess. The motion passed by voice vote/other.

The board recessed at 6:58 pm and reconvened at 7:11 pm.

6. [84207](#) Approval of the 2025 Operating Budget Reduction Scenario

A motion was made by DeChant, seconded by Carter, move to approve reduction with the understanding there is flexibility on how the reduction in evening hours is implemented across libraries and the preference for seeing reductions in positions through attrition rather than layoff. The motion passed by voice vote/other.

A friendly amendment was made by Roorda, seconded by Garcia to minimize the reductions on staff positions and maximize the reductions on program services and supplies. The amendment was passed by voice vote/other.

A motion was made by Carter, seconded by DeChant, to make a statement that the Madison Public Library Board is in support of a referendum which funds the operating costs to continue and funds the ongoing operational costs of the Imagination Center at Reindahl Park. The motion passed by voice vote/other.
