DISCUSSION ITEMS

Local Use of Plastic Bags

Discussion only

George Dreckman, Streets Department, was present to give information on what can be done regarding the use of plastic bags. Some cities have already looked at this issue and have taken action to minimize the use of plastic bags. Dreckman listed several possible actions:

- 1- Ban plastic bags
- 2- Require stores to take back bags
- 3- Provide location for drop-off

Requiring stores to take back their bags would be similar to the requirement to take back fluourescent bulbs, and so wouldn't be a dramatic shift. The city is not equiped to collect bags through regular recycling because they get caught in equipment. Also, requiring a city-managed drop off site would require more staff. Dreckman would recommend looking at the second option, requiring stores to take them back.

Commission members wanted to know more about the barriers to taxing bags (currently not permitted in Wisconsin), what banning would entail, and the possibility of a deposit for bags. Dreckman agreed to do some more research and return to a future meeting for more discussion.
