UNFINISHED BUSINESS

09674 Accessible Housing Goal

Discuss and decide: (1) having a public forum, (2) finding an intern to gather accessible housing information, and (3) including accessible housing in neighborhood plans

This item was taken up after New Business, Community Living Alliance presentation, and the break for the sign language interpretation.

The Commission discussed the following: gathering accessible information from city agencies, other places and from Commissioners through the use of an intern funded by DVR or the Common Council.

Fike reported regarding her membership on the CDA long-range planning, and Tangney stated that he would gather information from Access to Independence, and CDA regarding level of accessibility in housing.

The Commissioners also discussed having an ordinance that allows breaking a lease if the person becomes disabled, and including a suggestion for development of accessible housing in neighborhood plans.

A motion was made by Skidmore, seconded by Monahan, to Refer this item back to the CPD Executive Committee. The motion passed by voice vote/other.

NEW BUSINESS

A motion was made by Skidmore, seconded by Monahan, to Suspend the Rules and take up this item after the report of the Common Council. The motion passed by voice vote/other.

8. <u>09669</u> Community Living Alliance (CLA) Staff

N. Anderson re: Creative alternatives for in-home assistance for those who do not qualify for medical assistance. No discussion of CLA specific services. (30 minutes)

Anderson, of CLA, discussed: (a) Medical Assistance (Medicaid), and the history of in home care, (b) many not qualifying for public assistance, in the past or currently, and the importance of calling to find out if someone is eligible, (c) family and friends, or "circles of support" providing in home care for 80% of those who need it, as well as respite for caregivers, (d) Home modification is

most difficult for these providers to do.

The presenter discussed that there will be, by 2012, a county run consolidated aging and disability resource center, and that 211 United Way is a resource for all sorts of services, training, volunteers, and is the place to start. She also stated that most of the caregiver training is done by family and friends, for personal care.

The presenter discussed ways to address the need for care giving, and how to prevent falling to minimize the need for it. She encouraged the use of senior center volunteers, independent living and aging specialists. She also discussed how to do background checks on potential caregivers.
