> 2201 Regent Street: The motion required the use of clear vision glass on the windows to be replaced, with the existing air conditioning unit within the middle opening along Regent Street to be flush to provide for the installation of the new awnings as designed. If issues arise with the reinstallation of the existing air conditioning units to accommodate the awning design, the revised awning design must return for further Urban Design Commission consideration.

> 2215 Atwood Avenue: The motion required that the storm door be a wood product and be color matched with the main wood entry door.

Urge the University of Wisconsin to move and preserve the existing house, consider providing a green median strip within the driveway pavement to reduce the amount of impervious surface, along with providing alternative materials to standard concrete for the driveway surface.
