# **PUBLIC COMMENT**

- Rosemary Lee September 16, 2009 COMMENTS TO UDC ON SUBWAY SIGN ON WEST MAIN Dear Commissioners, This evening I come to ask for your help with the garish sign and awning that are now on the exterior front fayade of Subway's new location in the 1 block of West Main Street. I became aware of it recently when walking up State & Carroll Streets to the Capitol Square on a beautiful summer afternoon. I could see it as soon as I got to the top of State Street. I was appalled to think that any City decision makers had authorized it. The workmen were in Subway finishing the builtout. I asked if anyone from Subway Company was there. There was so I asked if Subway had City approval for the gaudy sign. When the answer was yes I expressed my distress that the City had permitted the flashy awning and the huge backlit sign above it. The response was that the signage was expensive. I replied that I didn't care how much it cost because it was an atrocity to install it on a fayade facing our beautiful Capitol Square, the gem of our city. I also informed the gentleman that both the State and City are spending millions of dollars to improve and beautify the entire Square area. I mentioned that the other businesses on the 1 block had very low-key and tasteful signage. The Subway employee could not understand my points and gave me the impression that he didn't care about the aesthetics of the Capitol Square area. Because of what I consider the poor attitude

of Subway I am strongly encouraging everyone I know to boycott them. You who know me will understand how outraged I was. Because I had never seen the Subway signage on any UDC, Plan Commission or other City committee agenda my next stop was, you guessed it, the Plan Department. One ofthe professional staffwas kind enough to talk to me. I asked if had missed the Subway signage on an agenda. I was told no that permission for the awning and sign were granted by an administrative signoff.

Now, I would like to know if there is any action this commission can take to remedy the situation either by a review of the signoff or an order that Subway must reduce the candlepower of the lit sign and that it must be off no later than 9:00pm 365 nights a year. Please help me solve the problem of this ostentatious blight on our square.

Canopy trees should be provided along the southerly parking lot's easterly side as well as a double row of canopy trees along its westerly side adjacent to existing surface parking. Canopy trees shall be shade trees. In addition the use of "no mow" grasses are required to be utilized in favor of formal lawn as much as possible. Future consideration shall provide for a reexamination of the fire access on the northerly portion of the site to reduce pavement in addition to the grouping of windows and precast panels as well as future separate consideration of permanent screening and signage.
